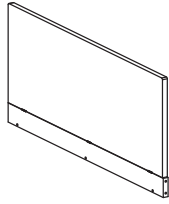


1. Do not use this product unless all screws and bolts are securely tightened.

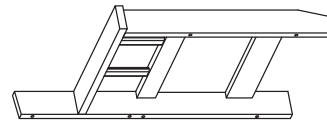

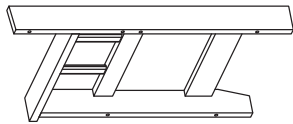

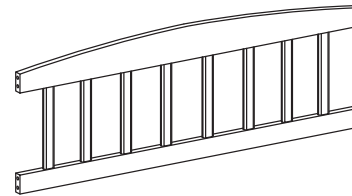
(A) Seat (1 PC)



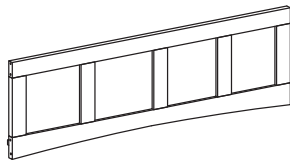
(B) Left Side Frame (1 PC)



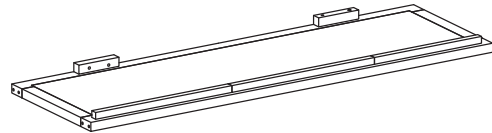
(C) Right Side Frame (1 PC)

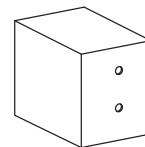
(E) Front Panel (1 PC)

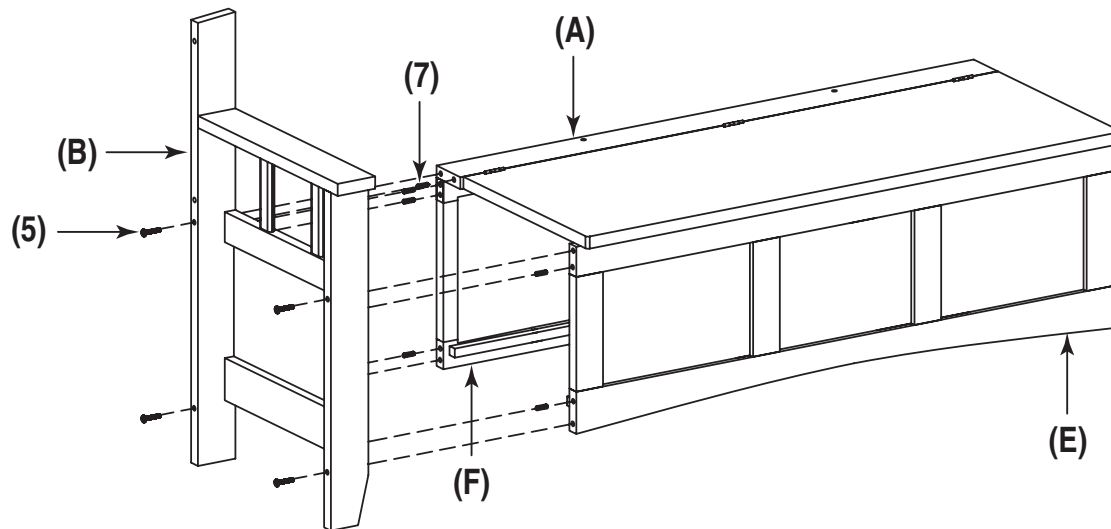
FULLY TIGHTEN ALL BOLTS (3) USING ALLEN WRENCH (10).

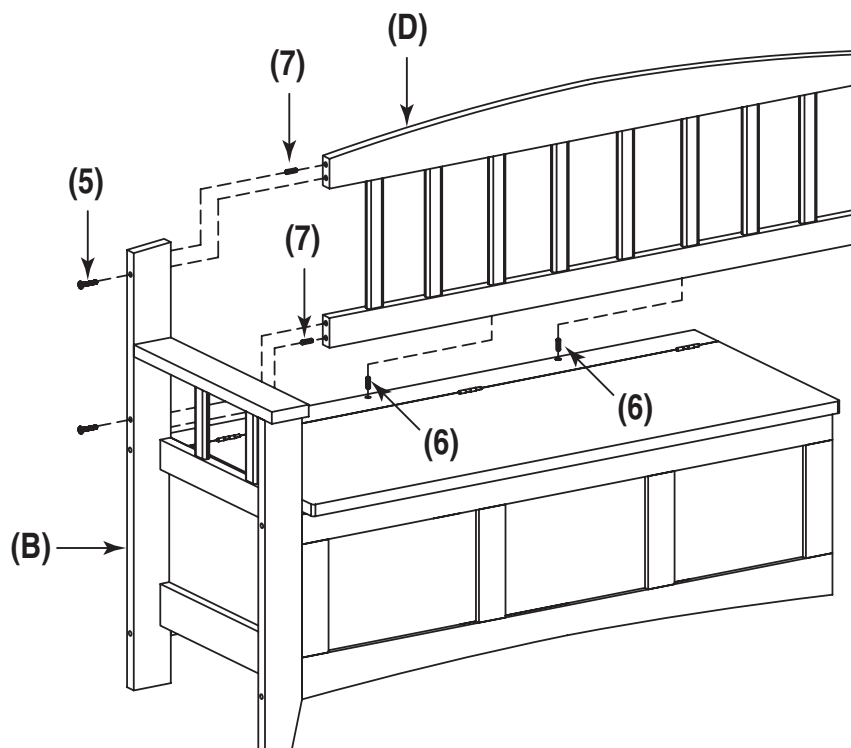
FULLY TIGHTEN BOLT (4) USING ALLEN WRENCH (10).

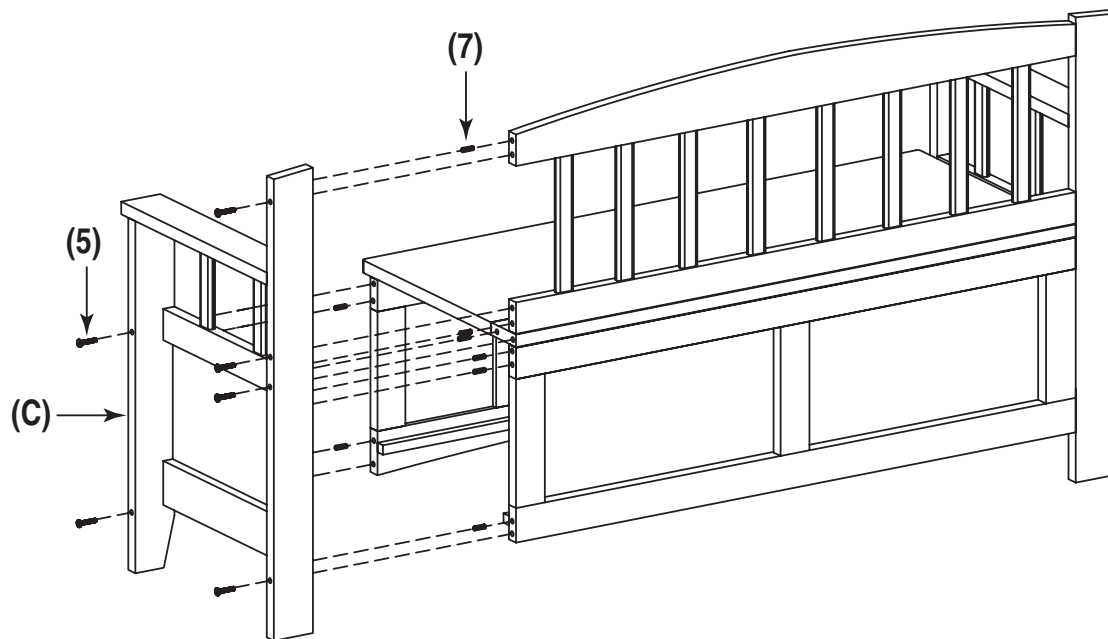
FULLY TIGHTEN ALL BOLTS (5) USING ALLEN WRENCH (10).

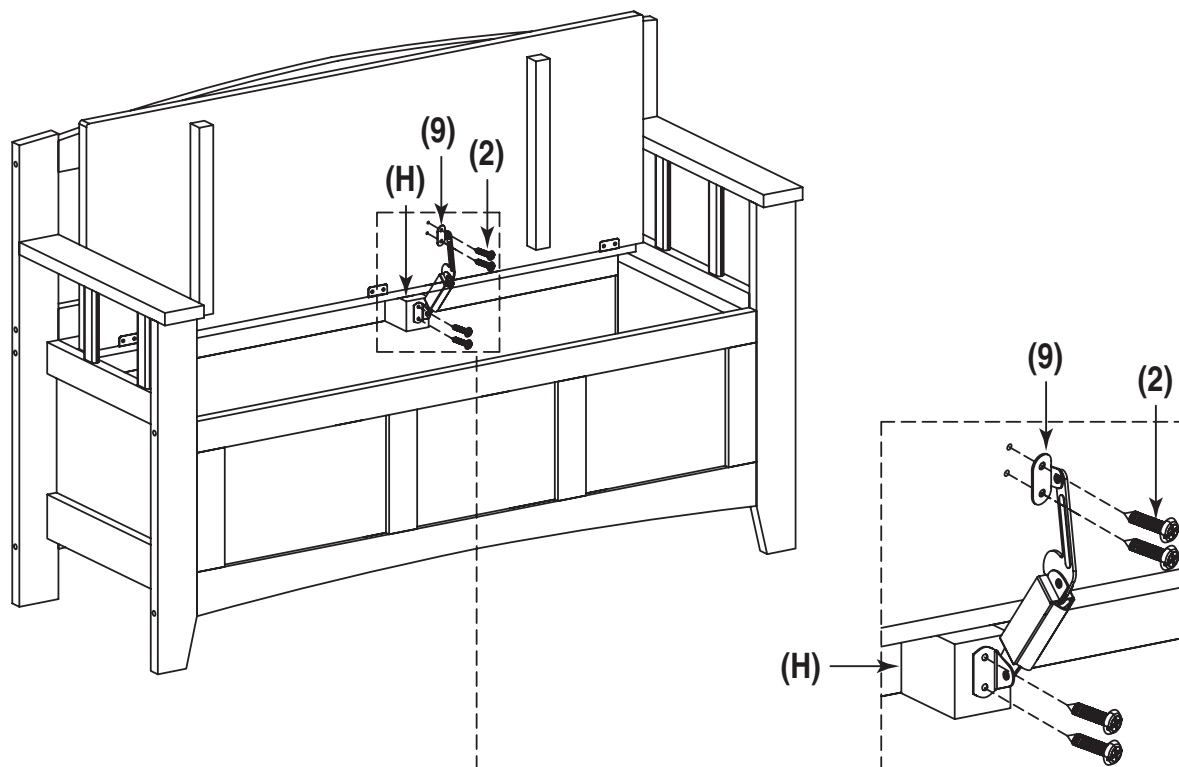
