

# Safety Information

- The product is intended for household use.
- Assembly should be carried out according to the manufacturer's instructions and in the sequence shown therein.
- Assembly and moving the product to its location or installation should be performed by a minimum of 2 people. Some cases may require more people. Information on this subject can be found in the assembly instructions.
- Maintain order during assembly. After unpacking the packages, sort and arrange the components and fittings.
- During assembly, pay special attention to small children. Keep them away from the area where assembly work is being carried out. Do not let them play with fittings, components, or packaging materials – children may swallow small parts.
- Dispose of packaging materials in accordance with applicable waste segregation laws.
- Use only original parts supplied by the manufacturer for product assembly. The only exception to this rule may be fasteners (e.g., wall plugs with screws) used to attach furniture to the wall or hang it on the wall (if required). In some situations, you need to obtain these fasteners on your own.
- The product requires wall mounting to prevent tipping over, thus protecting the user's health and property.

Proper execution of this task requires specialized knowledge and tools. Therefore, mounting the product to the wall should be done by a competent and qualified person who can assess the wall, i.e., its material, strength, and stability, and correctly select appropriate fasteners.

You must:

- ✓ use all mounting points provided by the manufacturer,
- ✓ ensure that at each mounting point, all components used for mounting the product work properly together,
- ✓ ensure before loading the product that it is securely attached to the wall at all designated points.

## **NOTE!!!**

**If wall plugs with screws are included with the product, they are intended only for walls made of solid and homogeneous materials covered with thin-layer plaster.**

- Product use can begin only after it is completely assembled and installed in its final location.
- The product should be used according to its intended purpose.
- Standing on the product and sitting on surfaces not intended for this purpose is prohibited.
- Do not allow children to use the product for play, such as:
  - ✓ climbing on it,
  - ✓ standing on it,
  - ✓ entering inside or under the product,
  - ✓ swinging on doors and drawers,
  - ✓ using drawers as stairs,
  - ✓ etc.
- Exercise special caution with products containing glass or mirrors. Do not allow children to play near such products.
- Make sure the product is placed on a level and stable surface and does not wobble.
- Observe the permissible loading capacity of the product and its individual components. Do not overload the product.
- Distribute the load evenly on surfaces intended for storage. Place heavy items in the furniture as low as possible.

- The furniture is made of materials that may emit small amounts of substances used in production processes into the environment. The emission level is tested and meets applicable standards. After assembling the furniture, it is recommended to increase the intensity and frequency of ventilation in the room where it is located. This should last about four weeks or until the odor is eliminated.
- Do not use the product with serious damage (cracks, breaks, compromised and weakened fastener attachments, etc.).
- Regularly check all connections in the product and mounting points to the building structure (if any). If necessary, tighten or adjust them according to manufacturer's recommendations.
- For maintenance, follow the recommendations of the product manufacturer and the care product manufacturer.
- Caution should be exercised according to the nature and severity of the disability, as well as to age and resulting personal aptitude. Gender does not affect the safe use of the product.
- After the end of its useful life, dispose of the product in accordance with applicable waste segregation laws.

## **If the product is equipped with electrical components**

- Nominal parameters are specified on product labels and the attached operating/assembly instructions. Be sure to read their content and values. Observe the specified values.
- Prior to the assembly, be sure to familiarise yourself with:
  - ✓ The conditions of safe assembly and use and the warnings contained in the instruction manual attached to the lighting set.
  - ✓ Instruction manual for the assembly of the unit.
- Assemble the electrical components in accordance with the instruction manuals provided and in the order shown therein.
- Assembly must always be performed with power disconnected.
- In some countries, only a qualified professional is allowed to perform actions related to the installation of electrical equipment. In the case of any doubts, contact the local authority responsible for this matter.
- In particular, remember that:
  - ✓ The product containing the attached electrical components is intended for use only inside dry rooms.
  - ✓ The power supply unit should be connected in an easily accessible place, away from heat sources and only to an efficient electrical installation.
  - ✓ The power supply unit can only power the lighting fixtures supplied with it. Do not connect other or additional lighting fixtures to it.
  - ✓ The lighting fixtures may only be powered with the supplied power supply unit. Do not connect them to other power supply units.
  - ✓ During maintenance and cleaning of the lighting fixtures, always disconnect the power supply unit from the mains beforehand. Do not use water or chemicals during these activities. Just wipe with a dry cloth.
  - ✓ Protect electrical components from spillage and moisture.
  - ✓ If the lighting is not used for a long period of time, disconnect the power supply unit from the mains.
  - ✓ Regularly check all lighting components for signs of damage.
  - ✓ The light source of the lighting fixture is not replaceable. When the light source is worn out, the entire lighting fixture must be replaced.
  - ✓ If the external flexible wire or cord is damaged, it should only be replaced by the manufacturer or their service agent, or a person with similar qualifications to avoid risk.

- **It is forbidden to:**
  - ✓ Use lighting with any faulty component.
  - ✓ Carry out repairs by yourself. Damaged components should be replaced by their manufacturer.
  - ✓ Make any modifications to any component of the supplied lighting set.
  - ✓ Mechanically strain the power cords in any way (e.g. pulling, stretching, etc.).
  
- **WARNING!!!:**

The electrical cords connecting the individual lighting components are a strangulation hazard for small children. The accessible cords should always be kept out of the reach of small children. Do not allow children to come into contact with or play with any component of the lighting set.
  
- **Disposal of electrical components (lighting set).**

The individual components of the lighting set are marked with the symbol of a crossed-out waste container. This means that at the end of their useful life, they cannot be disposed of with unsorted municipal waste. They should be subject to selective collection of waste. Therefore, the used electrical components should be removed from the unit (in a way which is opposite to the assembly process) and handed over to the appropriate collection and recycling point in accordance with the environmental protection regulations for waste management in force in a given country. Information on the location of such points can be obtained from the local authorities. If your set contains batteries, dispose of them after use according to the local regulations for disposal of used batteries.
