
# Assembly Instructions

**CAUTION**: This Table is NOT a TOY.


Keep your child / children at bay during the assembly process.

Assemble on a clean non-marring surface (packing foam)-




Save all packaging until finished-


# OVERVIEW Table Top (A) Side Turrnbuckle Set (D) Turnbuckle Set (E) Iron Leg (B)

This Table has multiple parts and may require up to some 30 minutes to assemble. To give you an overview of the Table parts, the above picture is to help you put the various parts into perspective. Please read through the instructions below to familiarise yourself with the parts and steps before assembly.


**FRONT FACING** 




Unpack and place all parts on a clean, non-marring surface.



- **2.1)** Connect the Side Turnbuckle Sets(D) together as shown in the arrow above
- **2.2)** Connect the Bottom Turnbuckle Set(E) together as shown in the arrows above




- **3.1)** With the assistance of an adult helper, unfold the Table Top(A) as shown.
- **3.2)** Then lay the Table Top (A) facedown onto a clean, flat surface to avoid any scratches or damage to the product.



Align Support Bar(C) to the housings on Table Top(A) and secure using Screws(4) with Allen Key(6).

### Only loosely tighten the Screws.

Repeat the same process with the other Support Bar(C).




Attach Iron Leg(B) to Table Top(A) using Short Bolt((1)) and Washer((2)) with Allen Key((6)).

Notice: The leg with hole should be face inside against

Only loosely tighten the Bolts.


Repeat the same process with the other Iron Leg(B)



Place Side Turnbuckle Set(D) between housing of Table Top(A) and Iron Leg(B). Attach Side Turnbuckle Set(D) to Iron Leg(B) using Short Bolt( $\widehat{1}$ ) and Washer( $\widehat{2}$ ) with Allen Key( $\widehat{6}$ )


### Only loosely tighten the Bolts.

Repeat the same process with the other Side Turnbuckle Set(D).




Affix Side Turnbuckle Set(D) to Table Top(A) using Long Bolt( $\mathfrak{F}$ ) and Sleeve Nut( $\mathfrak{F}$ ) with Allen Key( $\mathfrak{F}$ ).

Only loosely tighten the Bolts.



Attach the Bottom Turnbuckle Set(E) to Iron Legs(B) using Short Bolt(1) and Washer(2) with Allen Key(6).

Only loosely tighten the Bolts.



Stand the Table right side up.

Inspect it and make sure all parts are adequately connected.

In a sequential manner, tighten all Bolts and Screws until fully locked into position.

**Notice:** By hand, turn the Side Turnbuckle Sets (D) and Bottom Turnbuckle Set(E) to fixed point on Turnbuckle Sets (D), (E) to further secure the Table and maximize stability and show the Turnbuckle Sets as place as the picture. Your Table is ready for use.

This Table can only be used on a flat, level surface.

# Care & Maintenance Do not put hot items directly on furniture surface Do not clean furniture with harsh cleansers or polish. To obtain the longest life span of your outdoor prodcts, minimizing exposure to direct sunlight is recommended. Children should not climb or jump on the furniture. Do not write on furniture without a padded barrier to protect the surface. To obtain the longest lifespan of your outdoor products, avoid extended and lengthy exposure to rain, snow, and direct sunshine. Whenever possible cover the product and /or place under patio or awnings. Not for commercial use. For residential use only. Stains may be removed with mild soap solution and damp cloth.

### Questions & Answers about Proposition 65

What is Proposition 65?

Proposition 65 requires businesses to provide warnings to Californians about significant exposures to chemicals that cause cancer, birth defects or other reproductive harm. These chemicals can be in the products that Californians purchase, in their homes or workplaces, or that are released into the environment. By requiring that this information be provided, Proposition 65 enables Californians to make informed decisions about their exposures to these chemicals.

Proposition 65 also prohibits California businesses from knowingly discharging significant amounts of listed chemicals into sources of drinking water.

Proposition 65 requires California to publish a list of chemicals known to cause cancer, birth defects or other reproductive harm. This list, which must be updated at least once a year, has grown to include approximately 900 chemicals since it was first published in 1987.

What types of chemicals are on the Proposition 65 list?

The list contains a wide range of naturally occurring and synthetic chemicals that include additives or ingredients in pesticides, common household products, food, drugs, dyes, or solvents. Listed chemicals may also be used in manufacturing and construction, or they may be byproducts of chemical processes, such as motor vehicle exhaust.

What does a warning mean?

If a warning is placed on a product label or posted or distributed at a workplace, a business, or in rental housing, the business issuing the warning is aware or believes that it is exposing individuals to one or more listed chemicals.

By law, a warning must be given for listed chemicals unless the exposure is low enough to pose no significant risk of cancer or is significantly below levels observed to cause birth defects or other reproductive harm.
