4. 2 people are recommended to finish.



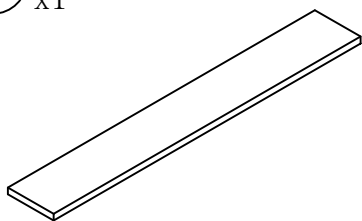

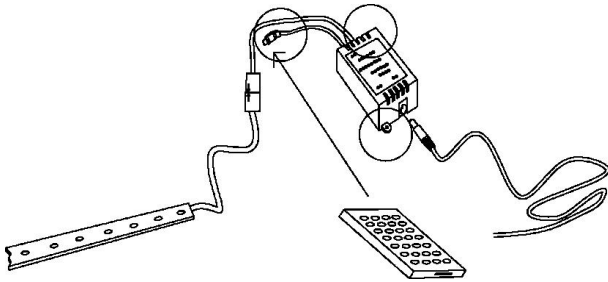
# USER MANUAL

2. Before you using the remote controller, please remove the transparent plastic, which is designed to disconnect the battery



3. Remote controller should be aim at the black receiver unit when you switch colours, you can also fix the control box on the nearby wall with 2 screws, for more convenient using

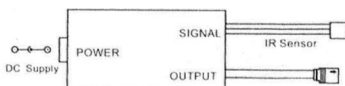
## II .Control Method:

Adopt IR remoter to control the led controller,which has 24 buttons,the function of each button as the table below:

Brightness+(16 in all)	Brightness-(16 in all)	Off	On
Static red	Static green	Static blue	Static white
Static orange	Static pea green	Static dark blue	7 color jumpy/fade change
Static dark yellow	Static cyan	Static brown	All the monochromatic jump
Static yellow	Static light blue	Static pink	All the monochromatic fade
Static straw yellow	Static sky blue	Static purple	3 color jumpy/fade change

Direction:press static color every time,the matching mode flicker two times before stopping,then recover the static color.When switching to four dynamic mode (7 color jump change.All fade out & fade in,7 color fade change,3 base color jumpy),the button of "Brightness+"/"Brightness-" means the speed of light change is up/down,there are 32 step in all.
