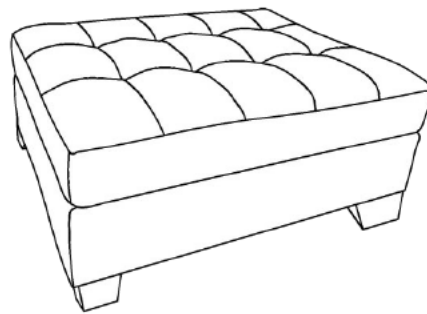

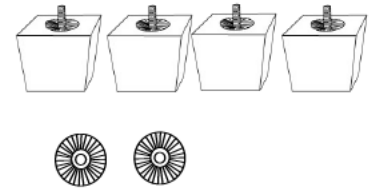
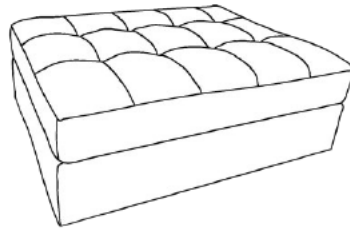

Assembly Preparation

Before

Assembly:



- Read instructions, cover to cover-



- Have 2 adults on hand for assembly-



- Do not assemble on flooring or carpet-

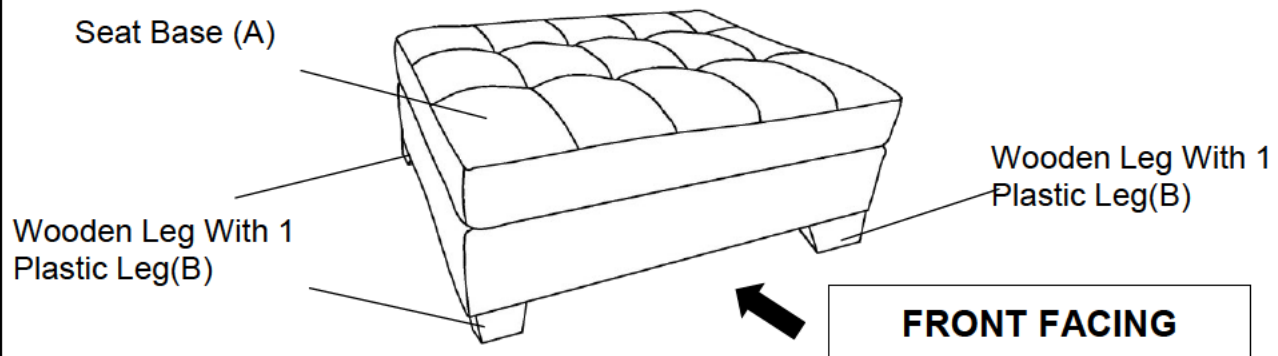


- Assemble on a clean non-marring surface (packing foam)-



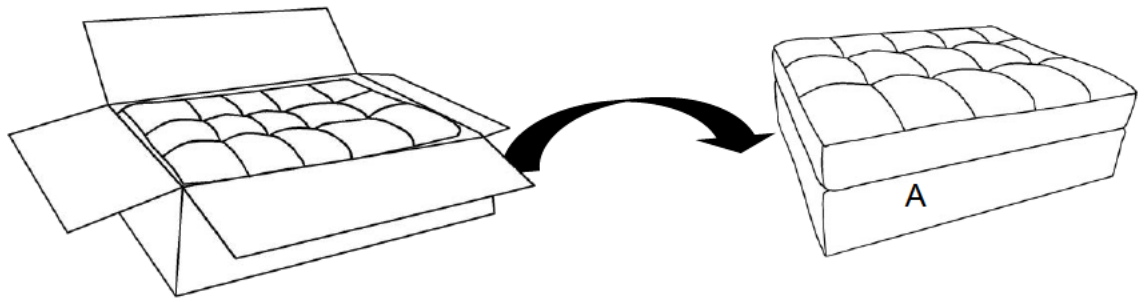
- Save all packaging until finished-

Assembly Steps



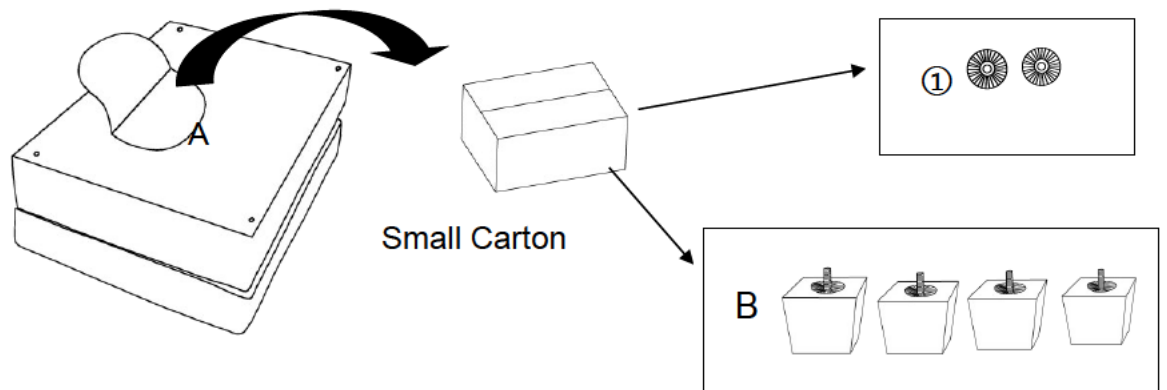
This Ottoman has multiple parts and may require about 30 minutes to assemble. To give you an overview of the Sofa parts, the above picture is to help you put the various parts into perspective. Please read through the instructions below to familiarise yourself with the parts and steps before assembly.

Step 1



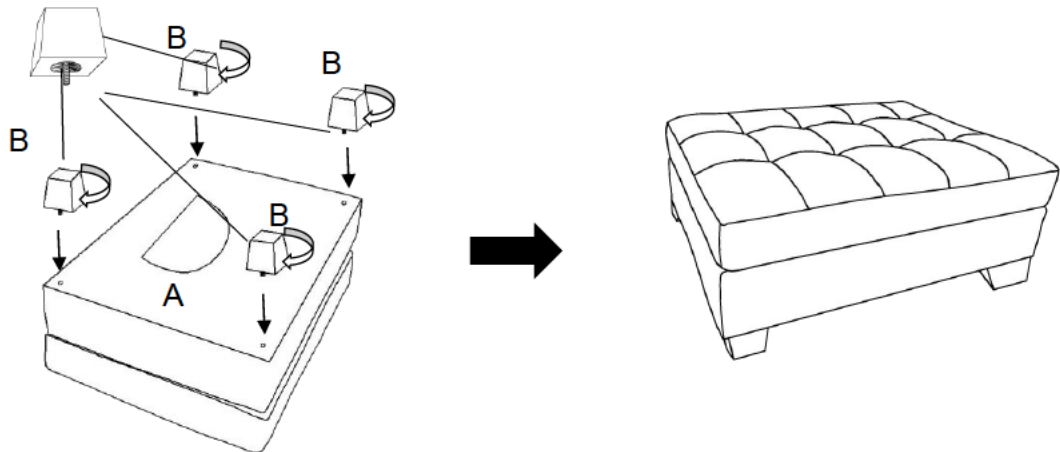
Take out the Seat Base(A) from the carton and place it on a clean, non-marring surface

Step 2



Unzip the non-woven pocket under the Seat Base(A) and take out the small Carton Box out to open it to take out the Plastic Gasket(①),Wodden Leg with 1 Plastic Gasket(B). Then zip the non-woven pocket.

Step 3



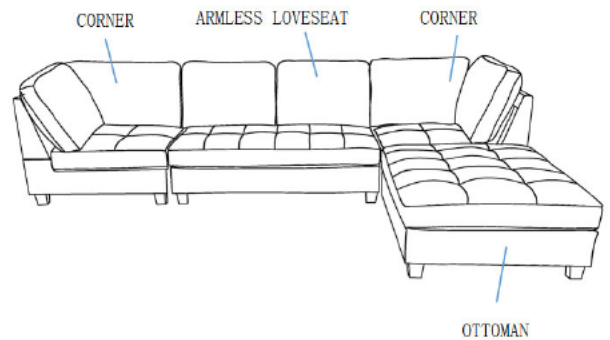
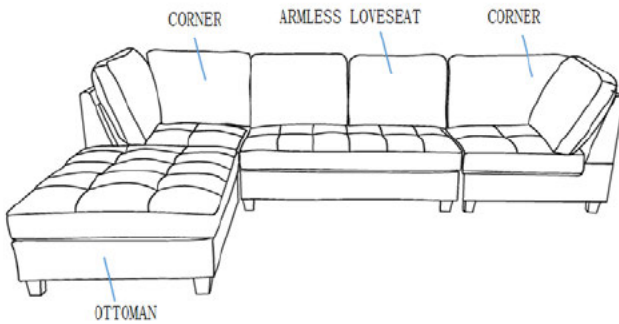
Carefully install the Wooden Legs with 1 Plastic Gasket(B) at the bottom of Seat Base(A) and turn it up after finish the assemble.

Note:The use of Gaskets are **OPTIONAL** and are especially useful to help alleviate slight wobbleness. Some Legs may need more than one gasket while some legs may not need anyny.

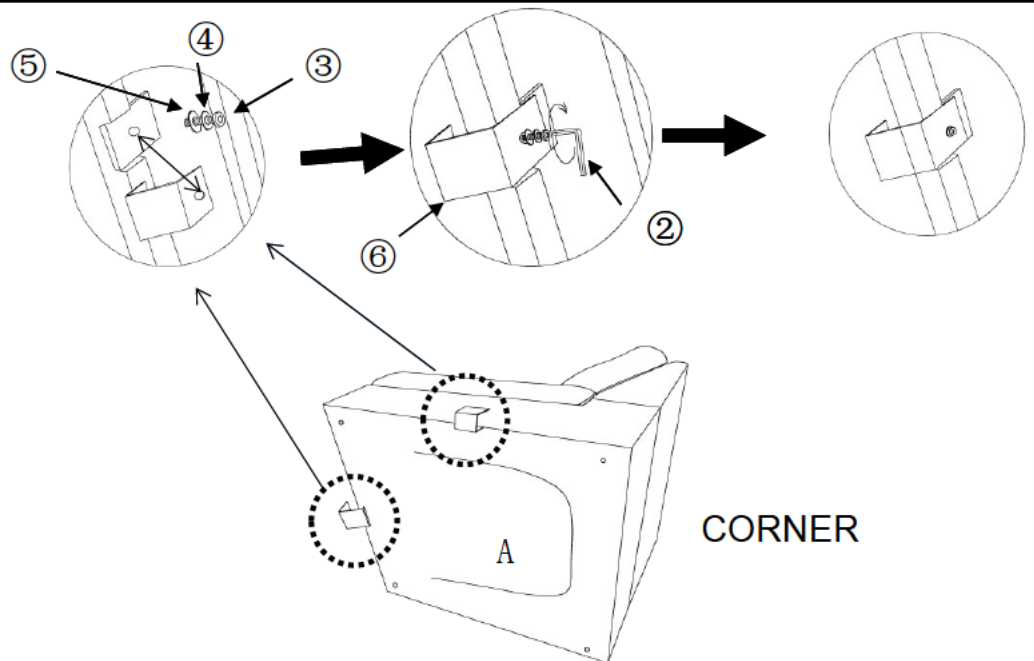
Your Ottoman is ready for use.

Combination Reference

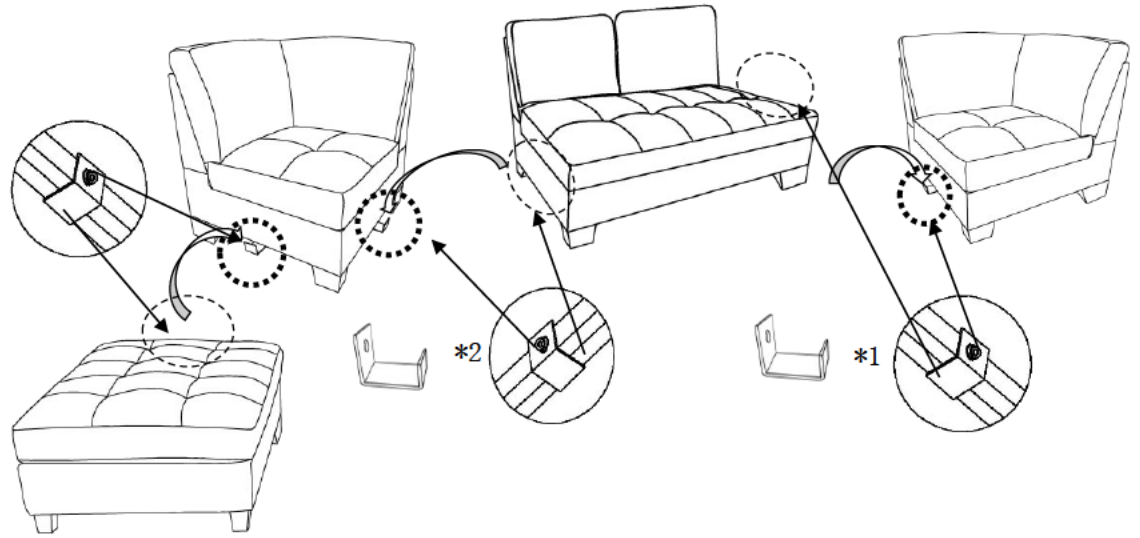


Step 1























Take 2 Bolts(③) by placing a Spring Washer(④) and a Flat Washer(⑤) each by Allen Key(②), then insert the hole of U Shape Metal Connector(⑥) and fix it on the both sides under inside the Seat Base(A) as pictured.

Step 2



Connect the Corner, Armless Loveseat, Corner and Ottoman together with U shape Metal Connector(⑥) one by one, above just one combination for reference, you can do the combination as you want.

Questions & Answers about Proposition 65

• What is Proposition 65?

Proposition 65 requires businesses to provide warnings to Californians about significant exposures to chemicals that cause cancer, birth defects or other reproductive harm. These chemicals can be in the products that Californians purchase, in their homes or workplaces, or that are released into the environment. By requiring that this information be provided, Proposition 65 enables Californians to make informed decisions about their exposures to these chemicals.

Proposition 65 also prohibits California businesses from knowingly discharging significant amounts of listed chemicals into sources of drinking water.

Proposition 65 requires California to publish a list of chemicals known to cause cancer, birth defects or other reproductive harm. This list, which must be updated at least once a year, has grown to include approximately 900 chemicals since it was first published in 1987.

• What types of chemicals are on the Proposition 65 list?

The list contains a wide range of naturally occurring and synthetic chemicals that include additives or ingredients in pesticides, common household products, food, drugs, dyes, or solvents. Listed chemicals may also be used in manufacturing and construction, or they may be byproducts of chemical processes, such as motor vehicle exhaust.

• What does a warning mean?

If a warning is placed on a product label or posted or distributed at a workplace, a business, or in rental housing, the business issuing the warning is aware or believes that it is exposing individuals to one or more listed chemicals.

By law, a warning must be given for listed chemicals unless the exposure is low enough to pose no significant risk of cancer or is significantly below levels observed to cause birth defects or other reproductive harm.
