

## Warranty Policy

Limited Warranty ("Warranty"): We warrant to Buyer ("Buyer" shall mean the individual or entity identified on Buyer's purchase order, or if different, on manufacturer's quote) that all manufacturer manufactured products ("Products") will perform substantially in accordance with manufacturer's published specifications (or other applicable specifications as agreed upon in writing by manufacturer) (the "Specifications") and will be free from defects in material and workmanship for the following warranty period, which shall begin on the date of shipment by manufacturer (the "Warranty Period"):

**ALL Lighting Fixtures Products, 60-days manufacturer warranty for defects only, normal wear and tear is not warranted, visible damages not noted upon delivery will be determined to be customer damage and will not be warranted, returned items must be in new or unused conditions with the original manufacturers packaging, all products are inspected upon arrival and we do not accept worn, dirty or stained merchandise.**

**For LED light or the light which is Integrated LED, the problem of LED driver, such as, the light worked once and then has not worked since, or the light can't light on anymore, our company can supplier LED driver as replacement free during warranty.**

**Please note: the digital images and product dimensions on our website are as accurate as possible, due to differences in computer monitors, some furniture colors may vary slightly, lengths and widths may vary from the published dimensions, we do our best to provide you with an exact measurement, but please be advised that some variation exists.**

Exclusions: This Warranty applies only when the Products have been properly handled, stored, wired, transported, installed, operated and maintained in accordance with the applicable Specifications, including, without limitations, installation in applications in which the ambient temperatures are within the range of specified operating temperatures and operation within the electrical values shown on the Specifications. manufacturer shall have no responsibility under this Warranty for any failure of the Products that results from external causes including without limitation: acts of nature, fire, or vandalism; physical damage; exposure to adverse hazardous chemicals or use of reactive cleaning agents and/or harsh chemicals to clean the Products; environmental conditions unsuited to the Products intended use; power failure, improper power supply, power surges or dips, and/or excessive switching; fatigue failure or similar phenomena resulting from induced vibrations, harmonic oscillation or resonance associated with movement of air currents around the Product; animal or insect activity; use of products, processes or materials supplied by the purchaser of Products, any end user or third parties, or any other occurrences beyond manufacturer's reasonable control. In addition, manufacturer shall have no responsibility under this Warranty for any substantial deterioration in the Product finish that is caused by failure to clean, inspect or maintain the Products. During the Warranty Period some staining, chalking or fading may occur, this is normal aging of the

finish and is not a manufacturing defect, therefore it is not covered by this Warranty. Neither polycarbonate nor acrylic material used in the Products is warranted against yellowing, as yellowing may naturally occur over time due to normal aging. If the Products are used on existing foundations, anchorages or structures, the purchaser of the Products and/or any end user is solely responsible for the structural integrity of such existing foundations, anchorages or structures and all consequences arising from their use. Customer dissatisfaction with any aspect of normal operation of the product is not covered by this Warranty.

Adequate records (as determined by manufacturer in its sole discretion) of operating history, maintenance, and/or testing must be kept by the end user and provided to manufacturer upon request to substantiate that the Products have failed to comply with the terms of this Warranty. The Products are not warranted against costs that may be incurred in connection with changes or modifications to the Products required to accommodate site conditions and/or faulty building construction or design.

In addition, the Products are not warranted against cost resulting from installation of third-party components, failures of third party supplied components, or failures of manufacturer-supplied Products caused by third party supplied components.

This Warranty excludes any and all removal or re-installation costs and expenses including, without limitation, labor and equipment required to remove and/or reinstall original or replacement Product(s) or parts, shipping costs to return nonconforming Products(s) or any damage that may occur during the return of any Product(s) to manufacturer.

manufacturer will have no obligation to make repairs, replacements or corrections which are defective as a result of: (i) normal wear and tear,

(ii) Buyer's misuse, fault or negligence,

(iii) use of the Product(s) in a manner for which they were not designed, or

(iv) improper storage, maintenance, wiring, operation, installation and handling of the Product(s) in accordance with the applicable

specifications, including, without limitation, installation in applications in which ambient temperatures are within the range of specified operating temperatures and operation within the electrical values shown on the specifications. Except as

otherwise set forth herein, manufacturer does not warrant third party components or devices that are not manufactured by manufacturer, which are covered by the applicable third-party manufacturer warranty (if any). Such third-party manufacturer shall be solely responsible for the costs related to any claims associated with any such devices. Warping of wooden or plastic blades is not covered by this Warranty. Metal finishes on Home style brand outdoor Products are not covered by this

DEFECTIVE PRODUCT SHALL BE THE SOLE AND EXCLUSIVE REMEDY OF BUYER IN THE EVENT OF A

DEFECTIVE PRODUCT. EXCEPT AS EXPRESSLY PROVIDED HEREIN, manufacturer DISCLAIMS ALL OTHER

WARRANTIES, WHETHER EXPRESS OR IMPLIED, ORAL OR WRITTEN, WITH

RESPECT TO THE PRODUCTS,  
INCLUDING WITHOUT LIMITATION ALL IMPLIED WARRANTIES OF  
NON-INFRINGEMENT, MERCHANTABILITY OR  
FITNESS FOR ANY PARTICULAR PURPOSE. In no event will manufacturer's aggregate  
liability under warranty exceed the price paid by Buyer for the defective Product. At its  
discretion and to the extent manufacturer is permitted, manufacturer agrees to assign to  
buyer any warranty rights in such Product that manufacturer may have from the third-party  
supplier. The Warranty Period for replacement Products shall be the remainder of the  
original Warranty Period. manufacturer reserves the right to modify or discontinue this  
Warranty without notice provided that any such modification or discontinuance will only be  
effective with respect to any Products purchased after such modification or  
discontinuance.

LIMITATION OF LIABILITY: IN NO EVENT SHALL manufacturer BE LIABLE FOR  
SPECIAL, INCIDENTAL,  
CONSEQUENTIAL, INDIRECT OR COMPENSATORY DAMAGES RESULTING FROM  
LOSS OF USE, LOST REVENUES  
OR PROFITS, BUSINESS OR GOODWILL EVEN IF manufacturer HAS BEEN ADVISED  
OR IS AWARE OF THE POSSIBILITY  
OF SUCH DAMAGES. UNDER NO CIRCUMSTANCES SHALL manufacture  
AGGREGATE LIABILITY ARISING OUT OF  
OR IN CONNECTION WITH THE SALE OF PRODUCTS, IN CONTRACT, TORT OR  
OTHERWISE, EXCEED THE  
PURCHASE PRICE OF THE PRODUCT TO WHICH SUCH LIABILITY RELATES. ANY  
ACTION FOR BREACH OF  
CONTRACT OR TORT MUST BE COMMENCED WITHIN ONE YEAR AFTER THE  
CAUSE OF ACTION HAS ACCRUED.
