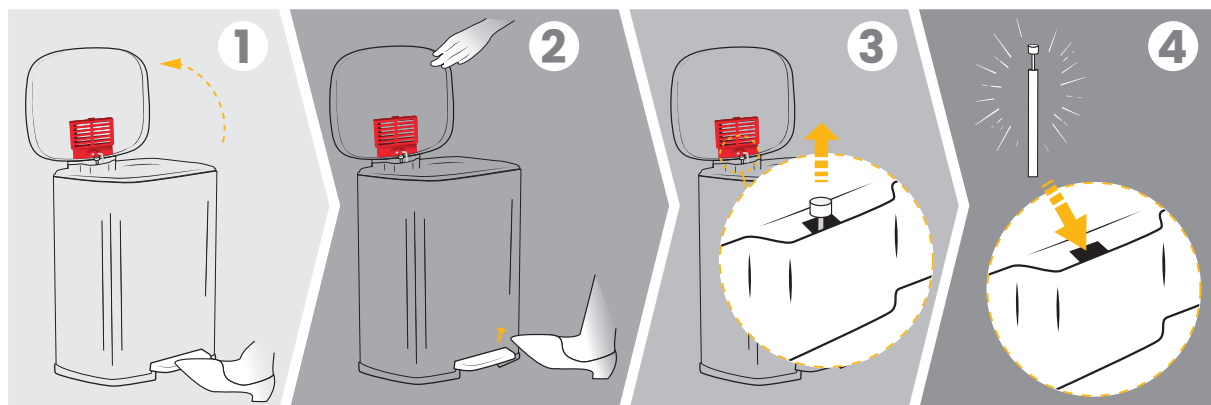
- Replace AbsorbX® Odor Filter every 3 months or when odor becomes too strong.

TROUBLE-SHOOTING



If the lid begins to close quickly, the air damper may need to be replaced.
