# **Lumbar Supreme**<sup>™</sup> SET-UP INSTRUCTIONS

Please read all instructions for Lumbar Supreme™ and Simmons® Attached Pump prior to inflation.

- **1.** Carefully unpack contents of carton.
- 2. Place mattress in unobstructed area free of sharp objects and unfold.

**NOTE:** Read separate **Attached Pump** instructions prior to operation.

**3.** Plug inset pump into a grounded 120 volt AC electrical outlet (a).

**4.** Inflate mattress by turning the Head/Foot knob and the Lumbar knob from the off position to the inflate position. (b). **Ensure that the dial clicks into the "INFLATE" position.** 





- **5.** Inflate **Lumbar Supreme**<sup>™</sup> mattress to full capacity. To avoid stretching or bulging do not overinflate. DO NOT LEAVE PUMP UNATTENDED.
- 6. After mattress is fully inflated, turn the Head/Foot Knob and the Lumbar Knob back to the off position. (c). Ensure that the dial clicks into the "OFF" position and arrow is pointing to "OFF" to prevent loss of air.



7. To achieve desired firmness level, lie on the Lumbar Supreme™ mattress and turn the Head/Foot knob and/or the Lumbar knob slowly towards the deflate position (d). (If too much air escapes, turn knob to inflate position.)



**NOTE:** Do not turn the knobs all the way to the deflate position or mattress will begin deflation process.

- **8.** If the **Lumbar Supreme**<sup>™</sup> requires adjustment, repeat step 7.
- **9.** Your **Lumbar Supreme**<sup>™</sup> is now ready to use. Make up bed as desired with sheets and bedding.

# TO DEFLATE AND STORE

- 1. Plug pump into a grounded 120 volt AC electrical outlet (a).
- 2. Deflate mattress by turning the Head/Foot knob and the Lumbar knob from the off position to the deflate position. (e). Ensure that the dial clicks into the "DEFLATE" position.



3. When mattress is completely deflated turn both knobs to the off position. (f). Ensure that the dial clicks into the "OFF" position and arrow is pointing to "OFF".



- **4.** The **Lumbar Supreme**<sup>™</sup> mattress is now ready for storage.
- **5.** Roll and place **Lumbar Supreme**<sup>™</sup> mattress in the convenient duffel bag.

**WARNING:** Attached Pump will burn out if left in "deflate" position after mattress is deflated. Monitor deflation progress. DO NOT LEAVE PUMP UNATTENDED.

### LIMITED 1 YEAR WARRANTY

If defect occurs in months 4 - 12 from the original purchase date the manufacturer will offer a credit of 50% of the current manufacturer's Suggested Retail Price for any mattress/component that has a manufacturer's defect. This credit is to be applied towards the purchase of a replacement Lumbar Supreme<sup>TM</sup> mattress. Shipping and handling charges to ship the replacement mattress/component are the responsibility of the consumer.

Our obligation under this warranty shall be limited to the repair or exchange of any part which may prove defective under the conditions and during the periods described above. This warranty shall not apply if upon inspection we find:

- 1. Any product or part has been damaged by alteration.
- 2. Any product or part has been subject to accident, misuse, abuse or has been operated contrary to the provided instructions or uses.

# **CARE AND MAINTENANCE**

Mattresses are constructed of heavy duty vinyl designed for optimum comfort when used at normal household temperatures.

#### **WARNING:**

Avoid extreme cold, as vinyl will become brittle. Do not overinflate. Do not use high pressure or compressed air inflation systems.

Avoid sharp objects. Do not use hair dryer to inflate.

#### **WARNING: FLAMMABLE**

VINYL IS FLAMMABLE. Do not locate bed near fire, fireplace or any other heat source, such as a space heater. Avoid placing bed over a heat emitting floor vent.

PVC, the material used to make air mattresses, will naturally stretch and expand during use. After being inflated for several hours and/or having been slept on, the air mattress may lose some of its initial firmness and feel softer because the PVC has naturally expanded. This expansion is normal and not the result of a leak. To regain your desired firmness level, add air to the mattress using the pump that was provided with the mattress.

Clean only with mild soap and water. Harsh cleaners can damage materials. Use repair kit to patch any holes, tears or punctures. Store at room temperature only AFTER cleaned and dried. Do not store outdoors or in a garage.

## USES

Use the **Lumbar Supreme**<sup>™</sup> any time an extra temporary sleep surface is needed. The **Lumbar Supreme**<sup>™</sup> is intended for normal indoor use only. The **Lumbar Supreme**<sup>™</sup> is not intended to be used in place of your present everyday sleep surface.
