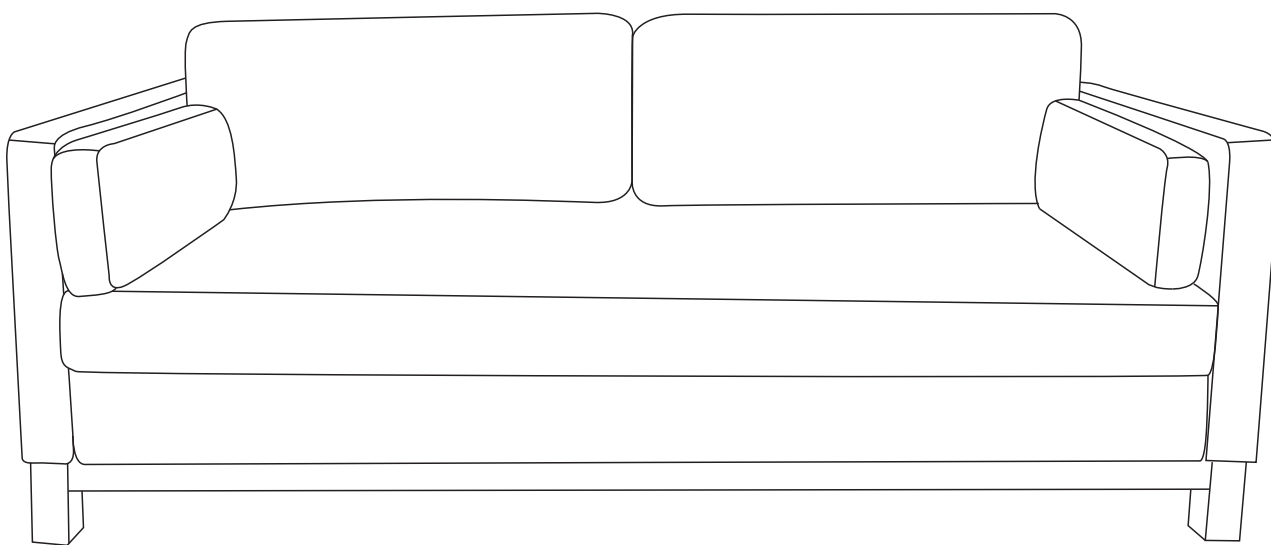

- Note: Cushions are ***compressed*** and cannot be recompressed once opened.

Returns are accepted only for items in their ***original, unopened condition***.

- F. Other aspects that you are not satisfied with.

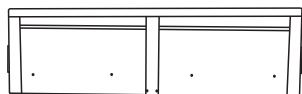

Installation Steps



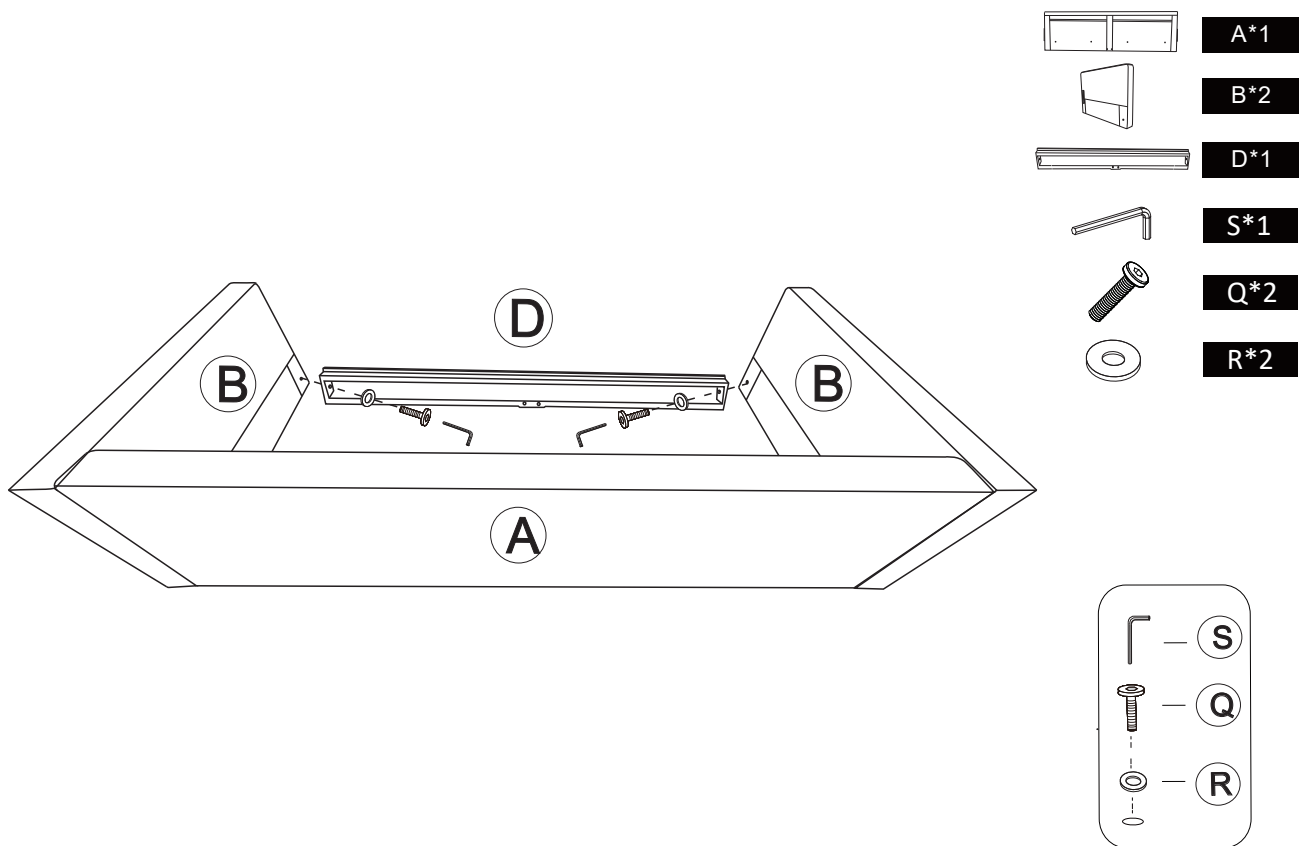
STEP 1

Assemble (A) and (C) with screws at the corresponding blank positions shown in the diagram, ensuring the hook-and-loop fastener side of (C) faces upward.

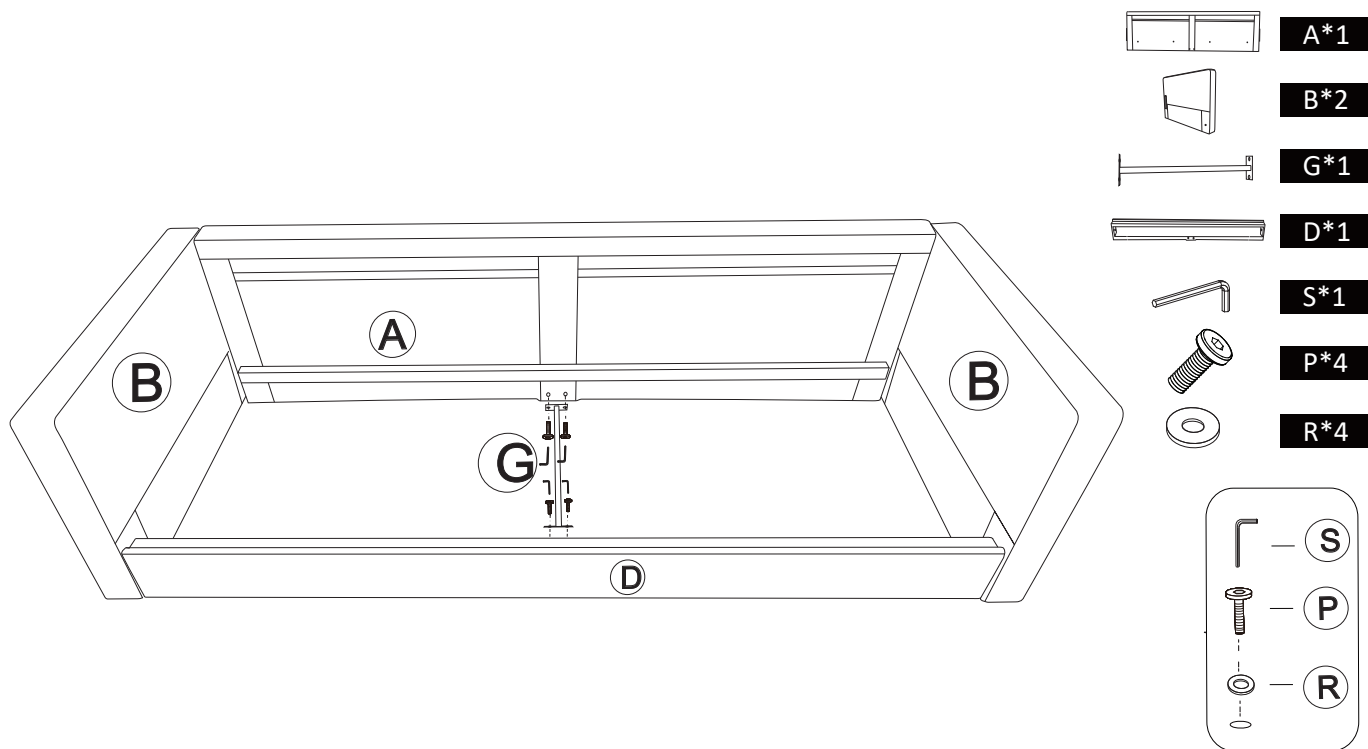


STEP 2

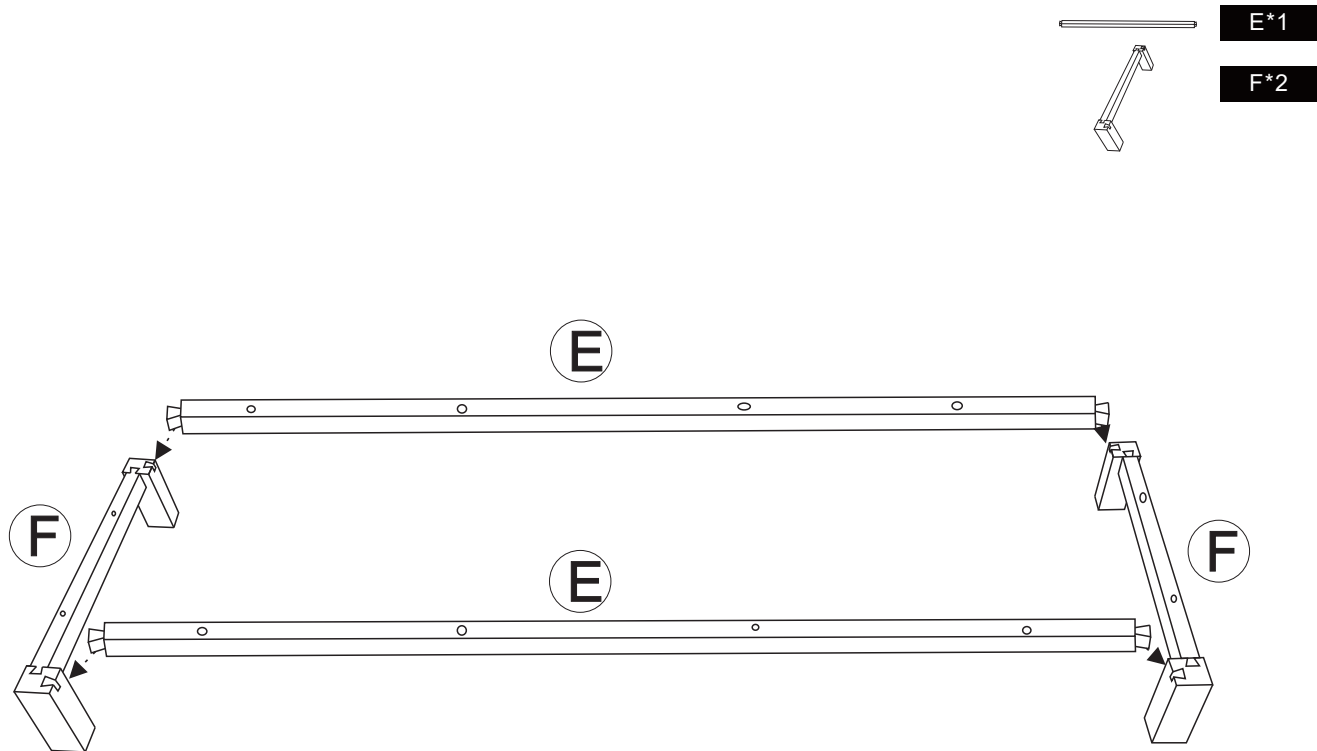
Assemble (A) and (B) together, with (A) connected to the plug-in on (B) from top to bottom, shown in the figure.



STEP 3 Install (D) in the middle of (B) and secure it with screws, ensuring the side with Velcro faces upward shown in the diagram.

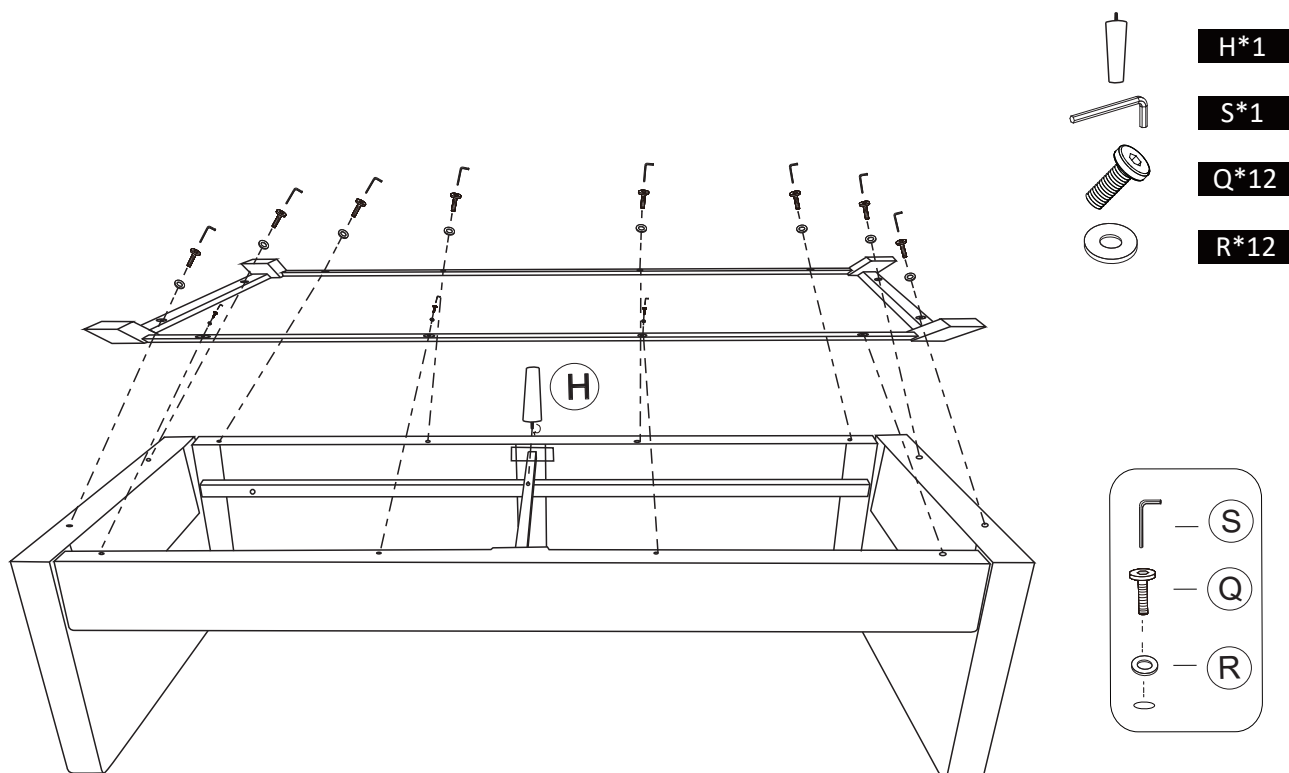


STEP 4 Fix (G) between (A) and (B), shown in the figure.



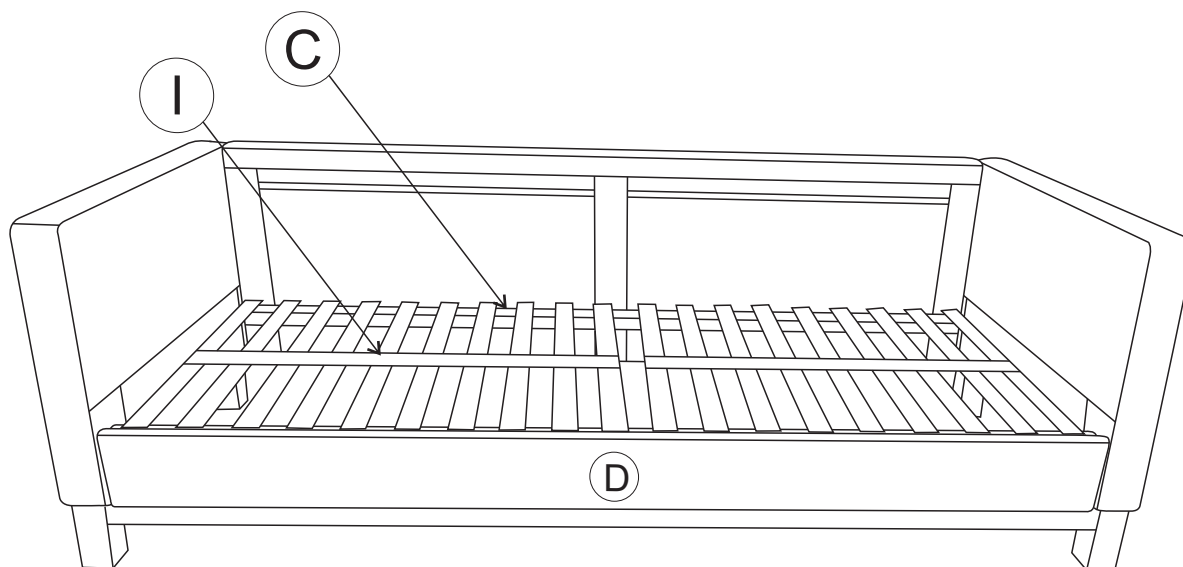
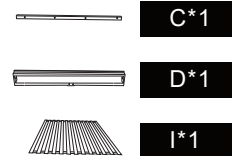
STEP 5

Connect the grooves of (F) and (E), ensuring the small hole of (E) faces upward, shown in the figure.



STEP 6

Flip the sofa main body assembled in step 4 upside down and install the accessories assembled in step 5 onto the sofa main body, Fasten H to G by screwing. Shown in the figure. "Note that the U-shaped hole faces upward."



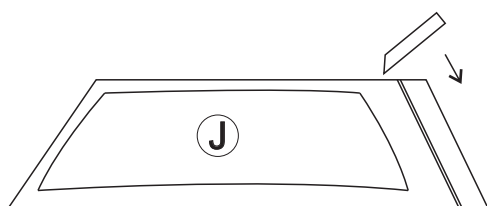
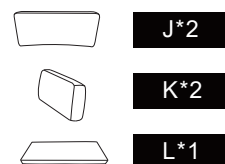
Place the assembled sofa from Step 5 upright, lay the accessory (I) flat on accessories (C) and (D), and secure it firmly with Velcro as shown in the diagram. Note that the side of (I) with Velcro should face upward.

STEP 7

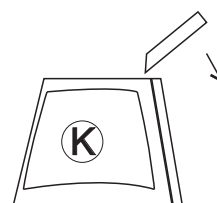
-Cushion Fluffing Instructions

1. Upon receiving the package, take out the compressed cushions.
2. Gently pat and knead the cushions repeatedly.
3. Allow the internal sponge to fully expand for 48-72 hours until it regains a plump, fluffy shape before use.

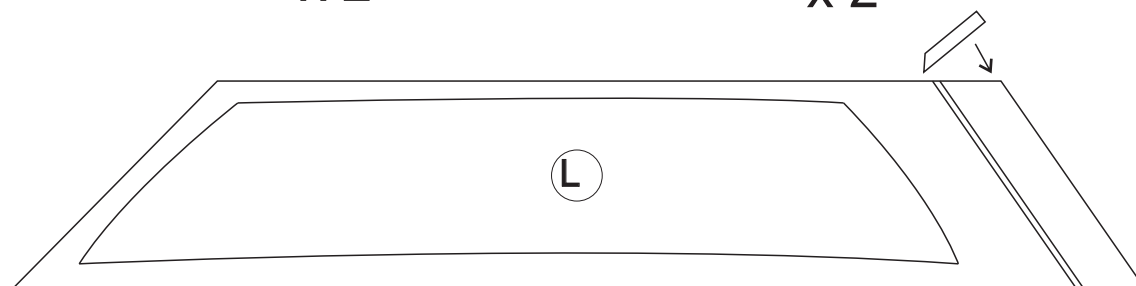
Note: The expansion time may vary slightly depending on temperature and humidity.

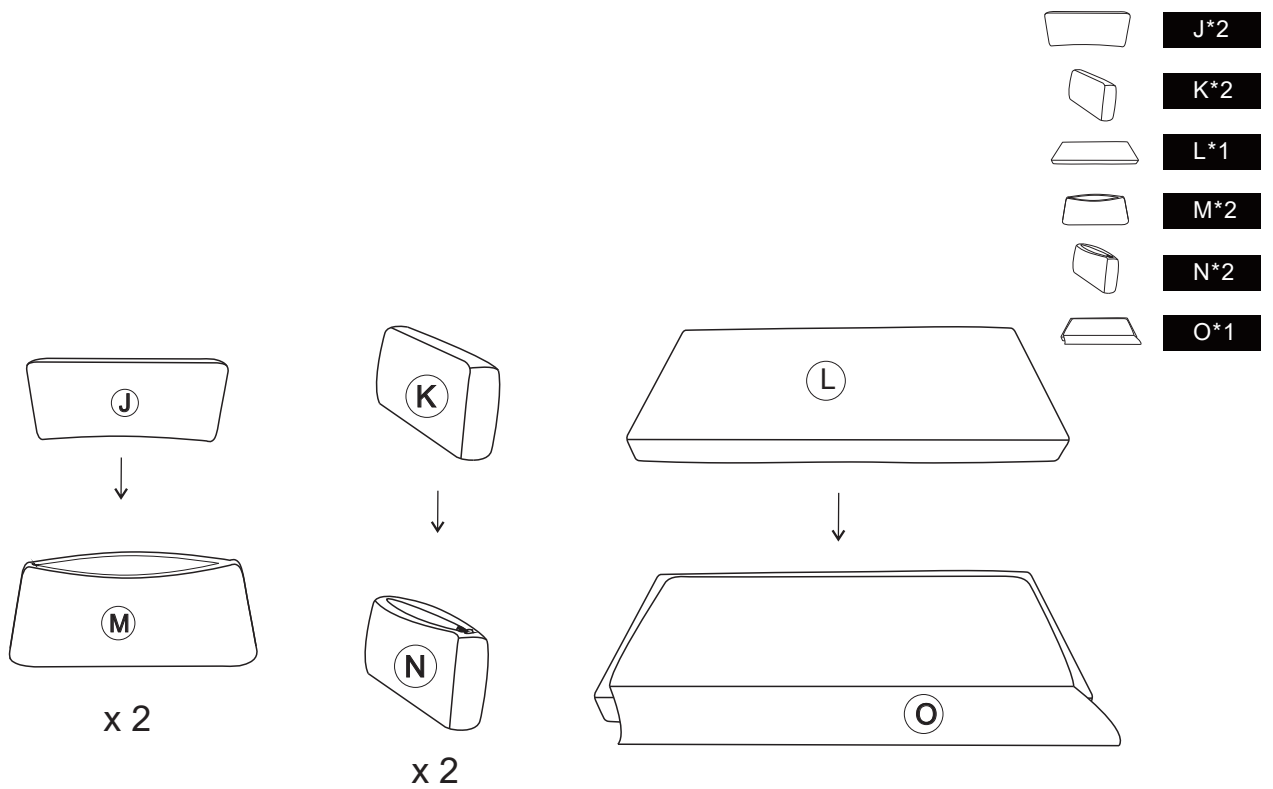

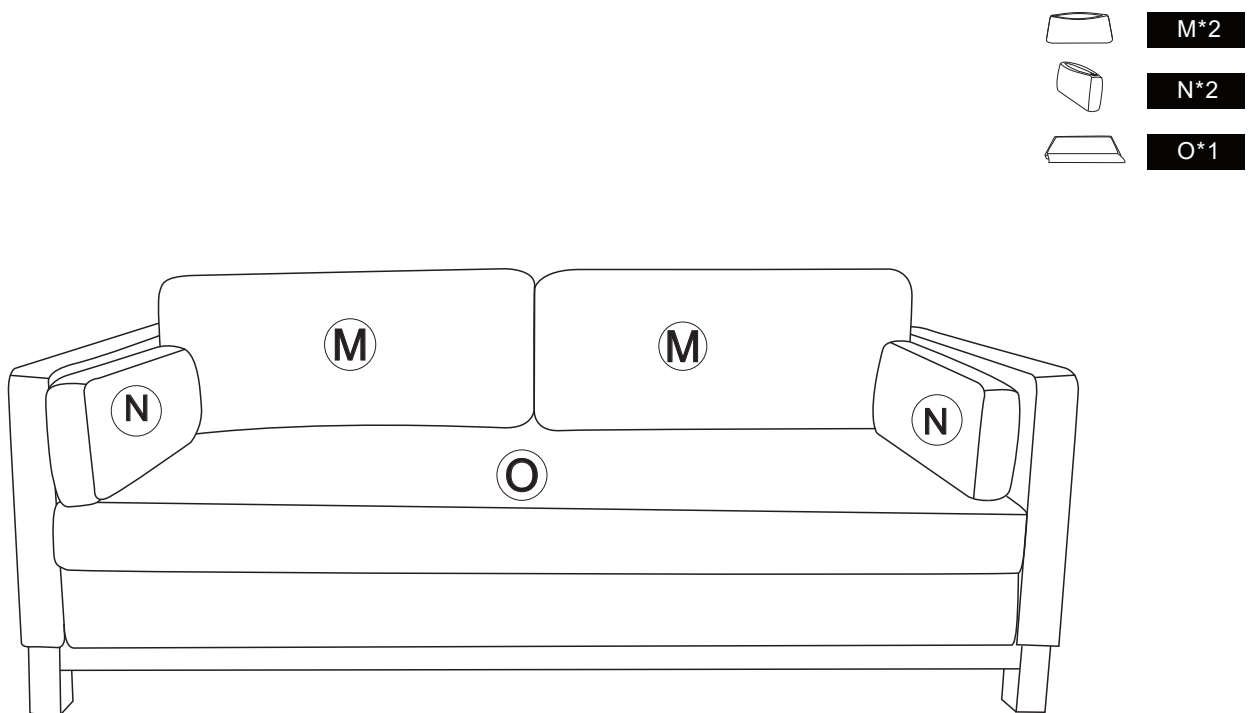
STEP 8

Remove (J) , (K) ,(L) from the compression bag. Shown in the figure.



STEP 9

Remove(M),(N),(O) from the packaging bag, and insert(J) , (K) ,(L) into the corresponding sofa covers shown in the diagram.



STEP 10

Place (M), (N), and (O) in the positions shown in the diagram, and the sofa assembly is complete.
