

- Have 2 adults on hand for assembly-




Do not assemble on flooring or carpet-




· Assemble on a clean non-marring surface (packing foam)-




Assembly Steps




This Chair has multiple parts and may require up to 30 minutes to assemble. To give you an overview of the Chair parts, the above picture is to help you put the various parts into perspective. Please read through the instructions below to familiarise yourself with the parts and steps before assembly.



Unpack and place all parts on a clean, non-marring surface.




- **2.1)** Align Backrest Panel (A) and Seat Panel (D) onto Left Leg Panel (C) as shown above.
- 2.2) Align Right Leg Panel (B) onto Backrest Panel (A) and Seat Panel (D) as pictured.



Attach Right Leg Panel (B) to Seat Panel (D) and Backrest Panel (A) by using 3 Screws ((2)) with Allen Key ((1)).


Do not fully tighten the Screws.



Carefully turn the Chair over.


Attach Left Leg Panel (C) to Seat Panel (D) and Backrest Panel (A) by using 3 Screws (2) with Allen Key (1).

Do not fully tighten the Screws.



Place the Chair onto a level surface, then carefully sit onto the Chair. This pressure will help the Chair reach full alignment at all joints.

In a sequential manner, gradually tighten all Screws until evenly secured. Inspect the Chair and make sure all parts are adequately connected.



Place Seat Cushion (E) onto the Chair.

Lay the Chair down and tie the velcro straps of the Cushion (E) to the Seat Panel (D) as shown above.

Your Chair is ready for use.

This Chair can only be used on a flat, level surface.

Care & Maintenance

- Do not put hot items directly on furniture surface.
- To obtain the longest lifespan of your outdoor prodcts, minimizing

Do not clean furniture with harsh cleansers or polish.

- ✓ Dust and pick-up spills using a clean, non-colored, lint-free cloth .

Questions & Answers about Proposition 65

What is Proposition 65?

Proposition 65 requires businesses to provide warnings to Californians about significant exposures to chemicals that cause cancer, birth defects or other reproductive harm. These chemicals can be in the products that Californians purchase, in their homes or workplaces, or that are released into the environment. By requiring that this information be provided, Proposition 65 enables Californians to make informed decisions about their exposures to these chemicals.

Proposition 65 also prohibits California businesses from knowingly discharging significant amounts of listed chemicals into sources of drinking water.

Proposition 65 requires California to publish a list of chemicals known to cause cancer, birth defects or other reproductive harm. This list, which must be updated at least once a year, has grown to include approximately 900 chemicals since it was first published in 1987.

What types of chemicals are on the Proposition 65 list?

The list contains a wide range of naturally occurring and synthetic chemicals that include additives or ingredients in pesticides, common household products, food, drugs, dyes, or solvents. Listed chemicals may also be used in manufacturing and construction, or they may be byproducts of chemical processes, such as motor vehicle exhaust.

What does a warning mean?

If a warning is placed on a product label or posted or distributed at a workplace, a business, or in rental housing, the business issuing the warning is aware or believes that it is exposing individuals to one or more listed chemicals.

By law, a warning must be given for listed chemicals unless the exposure is low enough to pose no significant risk of cancer or is significantly below levels observed to cause birth defects or other reproductive harm.
