



### Assembly Preparation

Before Beginning Assembly: Unpack all the parts for a clear overview.





Read instructions, cover to cover-



Have 2 adults on hand for assembly-



Do not assemble on flooring or carpet-




Assemble on a clean non-marring surface (packing foam)-




Save all packaging until finished-

## Assembly Steps



This Table has multiple parts and may require up to some 30 minutes to assemble. To give you an overview of the Table parts, the above picture is to help you put the various parts into perspective. Please read through the instructions below to familiarise yourself with the parts and steps before assembly.




Open the carton and place all the parts on a clean, non-marring surface.

Turn table top upside down.Attach Leg Panel(B) to the Table Top(A) using Bolt(②) and Washer(③) with Allen Key(①) as shown in the picture above.

Repeat this process with the other Leg Panel (B)

DO NOT FULLY TIGHTEN THE BOLTS.



Attach Leg Support Panel(C) between Leg Panels(B) using Bolt(2) and Washer(3) with Allen Key(1) as shown in the picture above.

Repeat the same process to affix the another Leg Support Panel(C)

Tighten the Bolts.

# Step 3 Adjust Pre-installed Levellers height for balance

Place the Table on a LEVEL SURFACE to check for wobbles.

If it wobbles, apply steady and even pressure down on the Table with the help of an adult partner.

Adjust the Legs Pre-installed Levellers until the Tables level with the ground. Adjust the levellers to the desired height to avoid wobbles. When the Table is level proceed to tighten all Bolts at all joints.

**CAUTION**: When tightening these bolts, tighten sequentially.


DO NOT tighten any screw fully and then towards the next one.

This would cause the frame to warp.

If there is still wobbles, loosen the bolts and execute this same drop tests.

### **Questions & Answers about Proposition 65**

What is Proposition 65?

Proposition 65 requires businesses to provide warnings to Californians about significant exposures to chemicals that cause cancer, birth defects or other reproductive harm. These chemicals can be in the products that Californians purchase, in their homes or workplaces, or that are released into the environment. By requiring that this information be provided, Proposition 65 enables Californians to make informed decisions about their exposures to these chemicals.

Proposition 65 also prohibits California businesses from knowingly discharging significant amounts of listed chemicals into sources of drinking water.

Proposition 65 requires California to publish a list of chemicals known to cause cancer, birth defects or other reproductive harm. This list, which must be updated at least once a year, has grown to include approximately 900 chemicals since it was first published in 1987.

• What types of chemicals are on the Proposition 65 list?

The list contains a wide range of naturally occurring and synthetic chemicals that include additives or ingredients in pesticides, common household products, food, drugs, dyes, or solvents. Listed chemicals may also be used in manufacturing and construction, or they may be byproducts of chemical processes, such as motor vehicle exhaust.

What does a warning mean?

If a warning is placed on a product label or posted or distributed at a workplace, a business, or in rental housing, the business issuing the warning is aware or believes that it is exposing individuals to one or more listed chemicals.

By law, a warning must be given for listed chemicals unless the exposure is low enough to pose no significant risk of cancer or is significantly below levels observed to cause birth defects or other reproductive harm.
