Assembly Instructions

Marning

Read these instructions carefully **BEFORE** assembly and use.

- Take care NOT to damage ANY electrical wire at ALL times.
- DO NOT leave the lamp connected to power during assembly, disassembly, or bulb replacement.
- DO NOT rinse the lamp or use abrasive or caustic cleaners.
- **DO NOT** use the lamp with bulbs exceeding the recommended wattage.
- DO NOT change any bulb with bare skin while it is still hot.
- Exercise caution if using incandescent bulbs to avoid the risk of burns or fire.
- Provide constant supervision when children or pets are nearby.

Assembling the Main Body

- 1. Connect Pole **H** to the base (I) using the washer (J) and nut (K).
- 2. Tighten the nut with the socket wrench (L).
- 3. Screw Pole G onto Pole H.
- Screw Pole F onto Pole G, centering the power switch (E) to the base.
- 5. Connect Pole **D** to Pole **F**, tightening its set screws **(B)** with the hex wrench **(A)**.
- Connect the extension bars (C) to each other in the same fashion.

Assembling the Shades


- 1. Join the hook-and-loop strips (R) on the shade covers (P).
- 2. Hook the covers to the top rings (O) using their clips (S).
- 3. Hook the covers to the bottom rings (Q) in the same fashion.

Installing the Shades

- 1. Unscrew the socket rings (N) from the lamp holders (M).
- 2. Position the top rings against the lamp holders.
- 3. Replace and tighten the socket rings, securing the shades into place.

Setup

- Install your bulbs into the sockets on the lamp holders.
 This fixture has been rated for three E26 bulbs (not included) up to 60 W each.
- 2. Set the lamp in its upright position on a stable, level, and nonslip surface.
- Plug in the lamp, turn it on using the power switch, and enjoy!
