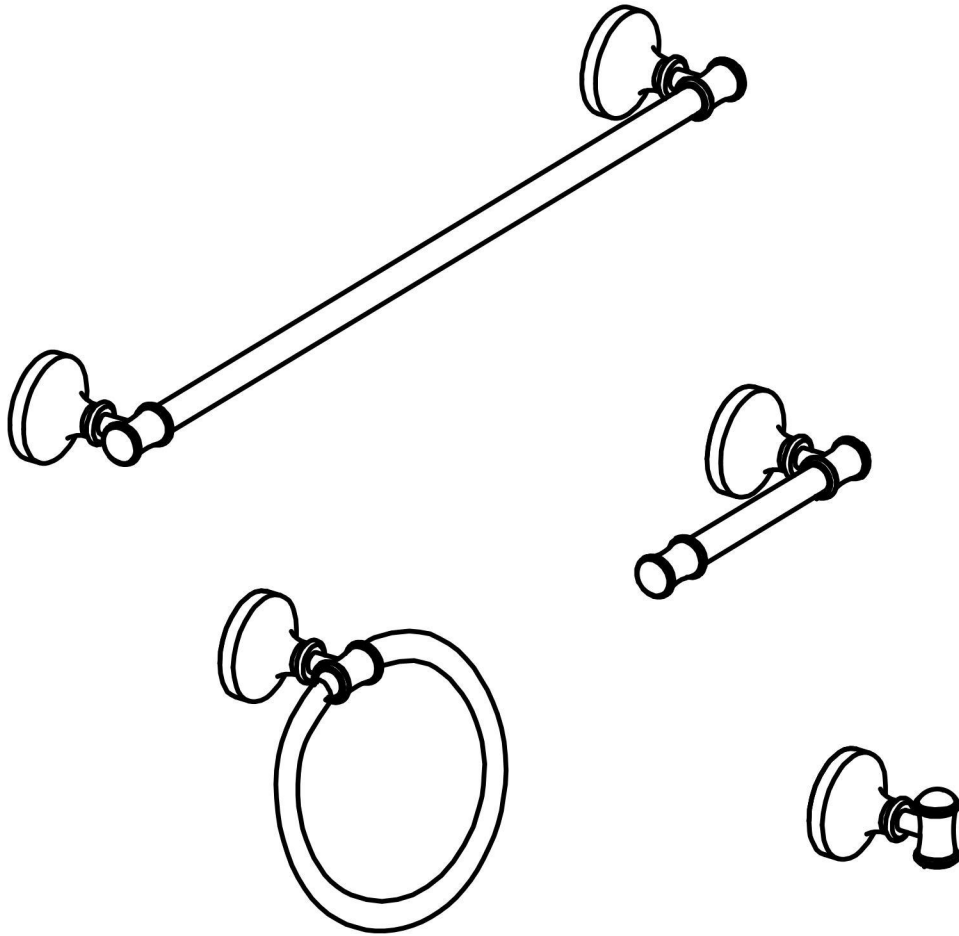

INSTALLATION STEPS

01

1). Install the towel ring mounting seat in a suitable position and fix it with Phillips screws.
2). Press the towel ring onto the mounting seat, and use the hex wrench to lock the towel rack on the mounting seat

02

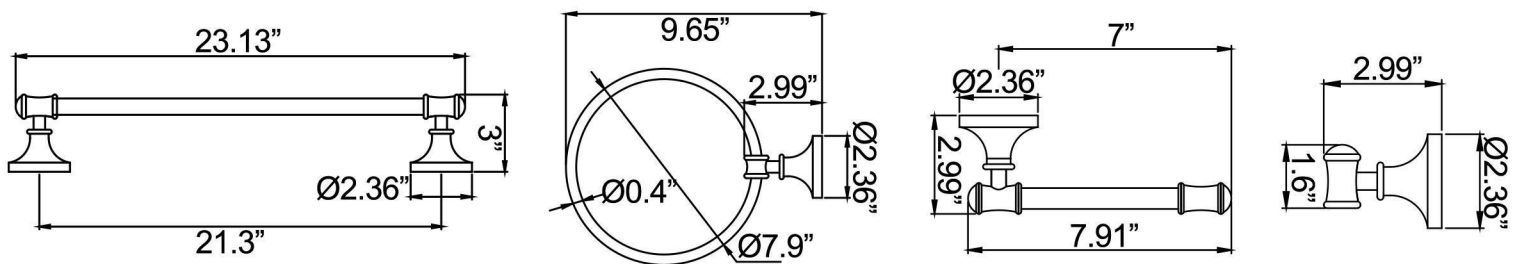
1). Put the towel rack on the wall and mark the position with a pen
2). Install the towel rack mount at the marked position and fix it with Phillips screws
3). Press the towel rack onto the mount and use the hex key to lock the towel rack on the mount.

03

1). Install the clothes hook mounting seat in a suitable position and fix it with Phillips screws.
2). Press the clothes hook onto the mounting seat, and use a hexagonal wrench to lock the towel rack on the mounting seat.

04

1). Install the paper towel holder mount at the appropriate position and fix it with Phillips screws.
2). Press the paper towel rack onto the mounting seat, and use a hexagonal wrench to lock the towel rack on the mounting seat.



CLEANING CARE

In order to keep the product surface bright, please keep offer or regularly to clean the product. Wash holder with clean water, and wipe with soft cotton cloth.

Avold using cleaning power, harsh cleaning chemicals, brushes, and cloth with coarse surface to prevent scrtching and corrosion.

Do not use acidic cleaning agents for washing the product as it may cause corrosion on the surfaceoffaucet in contact with harmful acidic agents.
