

① Take down the protective cover, adjusting cover and rotor in proper order.


2 Clean foreign matters and hairs inside of it.

Important notes

Warning

- Please add water immediately or stop using in the event that the water level of fountain is lower than the water pump.
- Please keep the power adapter away from the place where pets are accessible so as to prevent pets touching or biting the adapter.
- Indoor use only, please unplug the power line when cleaning and please be noted that the adapter is not allowed to clean and must keep it away from water.
- 4. Cellphone adapter can be applicable (All DC5V are applicable)
- Please keep the fountain away from socket and make sure the adapter and socket are higher than fountain to prevent them from water.
- 6. For any questions, please contact distributor or manufacturer.

FAQS

- 1. Why the noise of water pump is higher than before?
- a: It is possible that the water level is too low, please add more water.
- b: It is possible that there are foreign matters such as hair on blades, please disassemble the water pump and have it cleaned.
- 2. How often to have the fountain cleaned?
- It is recommended to clean once or twice a week. Please do not use detergent when cleaning, please use cotton cloth with water to have it cleaned.
- 3.? Is it normal if the adapter is heating when the fountain running 24 hours?
- It is normal for slightly hot, it is within safety range, which will not cause any damage to the fountain.
- 4. Is it safe for water pump operating in the fountain for a long term and is it power consumption?
- The fountain is supplied with safe voltage the same as cellphone charger, which is absolutely safe for people and pets.
- The fountain is extremely power-saving, it will consume no more than 1 kilowatt hour for 24-hour operation every day in one month.
- 5. What is the material of the fountain? What is the material of filter?
- The fountain is made of 304 food-grade stainless steel, which conforms to safety standards of the United States and EU.The material of filter is Premium Active Carbon.
- 6. It is recommended to replace the activated carbon filter element once a week
