## OUTER COVER CARE

**ONLY THE OUTER COVER OF THE GRACO® ULTRA 2-IN-1 DUAL-SIDED PREMIUM CRIB AND TODDLER BED MATTRESS IS SUITABLE FOR MACHINE WASHING.**

For outer cover care, hand wash with mild soap, or machine wash in cold water (on delicate cycle only). Do not use bleach. Hang outer cover to dry (do not place outer cover in machine dryer). Do not remove inner lining of mattress.

**Removable mattress topper on toddler side for quick & easy washing.**

## DUAL-SIDED MATTRESS

- Firmer side is recommended for infants' safer sleep.
- Softer side is recommended for toddlers' comfort.

### STEP 1

Safely unpack the rolled-up mattress from the box and carefully remove the plastic wrapping to prevent any damage to the mattress.

### STEP 2

Allow the mattress to completely unroll and lay flat.

### STEP 3

Please allow for a minimum of forty-eight (48) hours, in a room temperature setting, for the Graco® Ultra 2-in-1 Dual-Sided Premium Crib and Toddler Bed Mattress to fully expand to its maximum level of thickness. Actual expansion times may vary. If, after an expansion period of a minimum of forty-eight (48) hours in a room temperature setting, the mattress has not expanded to a height of at least four (4) inches, and expanded evenly on all sides, then do not under any circumstances, place your child on the mattress. In such an instance immediately discontinue use of the mattress and immediately contact the Storkcraft® Customer Care Department.

## ! WARNING:

### SIDS AND SUFFOCATION HAZARDS

**ALWAYS** place baby on back to sleep to reduce the risks of SIDS and suffocation.

#### Babies have suffocated:

- on pillows, comforters, and extra padding
- in gaps between a wrong-size mattress, or extra padding, and side walls of product.

**NEVER** add soft bedding, padding, or an extra mattress.

**USE ONLY** one mattress at a time.

**DO NOT** cover the faces or heads of babies with a blanket or over-bundle them. Overheating can increase the risk of SIDS.

**ALWAYS** check mattress fit **every time you change the sheets**, by pushing mattress tight to one corner. Look for any gaps between the mattress and the side walls. If a gap is larger than 1 ½ in. (3.8 cm), the mattress does not fit – **do not** use it.

**DO NOT** use this mattress in a crib having interior dimensions that exceed 28-5/8 by 53 in. (73 by 135 cm) as measured from the innermost surfaces of the crib.

**USE ONLY** sheets and mattress pads designed specifically for crib mattresses.

**DO NOT** remove these important safety instructions.

## GRACO® ULTRA 2-IN-1 DUAL-SIDED PREMIUM CRIB & TODDLER MATTRESS WARRANTY

### What does our warranty cover?

Storkcraft® proudly warrants the Graco® Ultra 2-in-1 Dual-Sided Premium Crib and Toddler Bed Mattress that you have purchased to be free of defects in both the quality of the craftsmanship of the mattress, and in the materials used for this product.

### Who does our warranty cover, and for how long?

Storkcraft® provides this warranty to you, the original purchaser, only. The warranty is not transferable and is void upon any subsequent sale or transfer. The warranty is for a period of ten (10) years from the date of purchase of the Graco® Ultra 2-in-1 Dual-Sided Premium Crib and Toddler Bed Mattress, however years two (2) through ten (10) of the warranty are prorated at a rate of eleven (11%) per year off of the original purchase price for each year since the date of purchase by the original purchaser.

### How does the warranty work?

Storkcraft® will replace a defective mattress as the exclusive remedy under this warranty or, at its sole discretion, may offer the prorated cash equivalent (less shipping, handling and/or duties). To request warranty service, contact the Storkcraft® Customer Care Department. Storkcraft®, at its option, may require proof of purchase and proof of the condition of the product in order to process a claim under this warranty.

The model number and date of manufacture can be located on the tag of the mattress.

### Does this warranty have limitations and exclusions?

This warranty does not cover normal "wear and tear", staining, dirt, discolorations, nor damage from unusual uses by the purchaser resulting in dampness, mold, burns, unsanitary conditions and/or other intentional physical damage (i.e. from jumping on the mattress, etc.) to the Graco® Ultra 2-in-1 Dual-Sided Premium Crib and Toddler Bed Mattress. This warranty shall not apply if the Graco® Ultra 2-in-1 Dual-Sided Premium Crib and Toddler Bed Mattress is used for any commercial purposes (such as in a day care facility, at a hotel, or as a floor model), is purchased or obtained in a "used" or "second hand" condition, or if the mattress is otherwise not used solely by the original purchaser. The Graco® Ultra 2-in-1 Dual-Sided Premium Crib and Toddler Bed Mattress is intended solely for use by newborns, infants, and toddler children. The warranty shall be void if this mattress is used for animals or pets. This warranty shall be voided if the removable outer cover of the Graco® Ultra 2-in-1 Dual-Sided Premium Crib and Toddler Bed Mattress is washed in a washing machine (on any washing cycle other than "delicate") or dried in a clothes dryer. This warranty shall also be voided if the Graco® Ultra 2-in-1 Dual-Sided Premium Crib and Toddler Bed Mattress remains compressed in the box/packaging it arrives in to the original purchaser for any period of time extended past two (2) weeks after delivery, or it is otherwise left to expand in a non-room temperature setting. Storkcraft® shall not be responsible for direct, special, incidental, or consequential damages that may result from, or which flow from, any breach of this warranty from any condition present with the mattress. This warranty shall specifically exclude any claims in excess of the original purchase price of the Graco® Ultra 2-in-1 Dual-Sided Premium Crib and Toddler Bed Mattress. This warranty is only applicable for claims made by original purchasers in the United States or Canada.

The foregoing limitations to this warranty shall be modified or removed in any state, country, or province that does not permit such limitations (and only to the minimum extent that any such terms are prohibited by law).

**NOTE: ONLY THE OUTER COVER OF THE GRACO® ULTRA 2-IN-1 DUAL-SIDED PREMIUM CRIB AND TODDLER BED MATTRESS IS SUITABLE FOR MACHINE WASHING. FOR OUTER COVER CARE, HAND WASH WITH MILD SOAP, OR MACHINE WASH IN COLD WATER (ON DELICATE CYCLE ONLY). DO NOT USE BLEACH. HANG OUTER COVER TO DRY (DO NOT PLACE OUTER COVER IN MACHINE DRYER). DO NOT REMOVE INNER LINING OF MATTRESS.**

### Should I stop using the Graco® Crib and Toddler Mattress-in-a-Box if it is sloped or uneven?

Please allow for a minimum of forty-eight (48) hours, in a room temperature setting, for the Graco® crib & toddler mattress-in-a-box to fully expand to its maximum level of thickness. Actual expansion times may vary. If, after an expansion period of a minimum of forty-eight (48) hours in a room temperature setting, the mattress has still not expanded to a height of at least four (4) inches, and has expanded evenly on all sides, then do not, under any circumstances, place your child on the mattress. In such an instance, immediately discontinue use of the mattress and immediately contact the Storkcraft® Customer Care Department.

**NOTE THAT BY USING YOUR GRACO® ULTRA 2-IN-1 DUAL-SIDED PREMIUM CRIB AND TODDLER BED MATTRESS YOU ARE AGREEING TO BE BOUND BY THE TERMS AND CONDITIONS OF THIS WARRANTY. DO NOT USE YOUR MATTRESS UNTIL YOU HAVE REVIEWED THE TERMS OF THE WARRANTY. IF YOU DO NOT AGREE WITH THE TERMS OF THIS WARRANTY, THEN DO NOT USE THIS PRODUCT AND CONTACT YOUR RETAILER OR THE STORKCRAFT® CUSTOMER CARE DEPARTMENT.**
