

Before Beginning Assembly:

Have 2 adults on hand for assembly-




Do not assemble on flooring or carpet-




Assemble on a clean non-marring surface (packing foam)-



Save all packaging until finished-




This Club Chair has multiple parts and may require up to some 30 minutes to assemble. To give you an overview of the Club Chair parts, the above picture is to help you put the various parts into perspective. Please read through the instructions below to familiarise yourself with the parts and steps before assembly.



Position Chair Base(A) on its back as shown.

(DO NOT place on surface that can scratch or damage the upholstery.)

Carefully peel away the non-woven fabric from the bottom of the edge, romove 4 Legs and Hardware bag out of the Chair bottom.




Place the chair onto the side of a table as seen in picture.

Now, you will have the chair bottom facing skywards.

Insert each Front Leg(B) completely and vertically into each Front seat frame corner of Chair Base(A) using Bolts(1), Spring Washers(2) and Washers(3) with Allen Key(4).


Repeat the same process to install the Back Leg (C) completely vertically into each back seat frame corner.

At this point of assembly, DO NOT overtighten the bolts.




Place the chair on a LEVEL SURFACE to see if it wobbles. If it wobbles, press firmly down on both armrests at the same time. This will help to ensure all Bolts and gaps reach full alignment status. If no wobbles found, proceed to tighten all the Bolts. DO NOT fully tighten a BOLT in one go and then move on to the next. Rather, in a sequential manner, gradually tighten each Bolt until all Bolts are evenly secured.

This methodology will ensure maximum eveness once all Bolts are fully tightened.



Seal the Seat Base Cover back on to the underside of the chair seat .




Stand the Club Chair right side up.

Make sure all parts are connected and securely locked into position. Your Club Chair is ready for use.

This Club Chair can only be used on a flat, level surface.

Care & Maintenance







Do not clean furniture with harsh cleansers or polish.
