

Warranty Terms

Click My Cart LTD: Limited Warranty:

This document describes the warranty terms for all Click My Cart products sold Internationally, with exception of North American, South America and China. This document describes the generic period of warranty that may differ based on individual country laws and regulations.

What the warranty covers:

Click My Cart LTD., warrants its products to be free from defects in material and workmanship during the warranty period. If a product proves to be defective in material or workmanship during the warranty period, Click My Cart LTD., or authorized dealers of Click My Cart LTD., will, as its sole option, repair or replace the product with a similar product. Replacement products or parts may include remanufactured or refurbished parts or components.

How long the warranty is effective:

All Click My Cart LTD. products are warranted for 12 months from date of purchase. Some items might offer a longer period of warranty that would be up on each individual product that specified on its product listing of the CLICK MY CART LTD official website.

Who the warranty protects:

This warranty is valid to the original purchaser only, with customer proof of purchase or receipt.

What the warranty protects:

This warranty is only valid for Click My Cart Image, Multimedia and Studio lines of products distributed by authorized dealer(s) Internationally, minus the territories or countries specified previously. Any damage of the product due to shipment, from retailer/e-tailer to end customer.

Removal or installation of the product.

External causes, such as electric power fluctuations or failure.

Use of supplies or parts not meeting the specifications of Click My Cart.

Normal wear and tear.

Failure of owner to perform periodic product maintenance as stated in the user manual such as cleaning methods.

Any other cause that does not relate to product defect.
