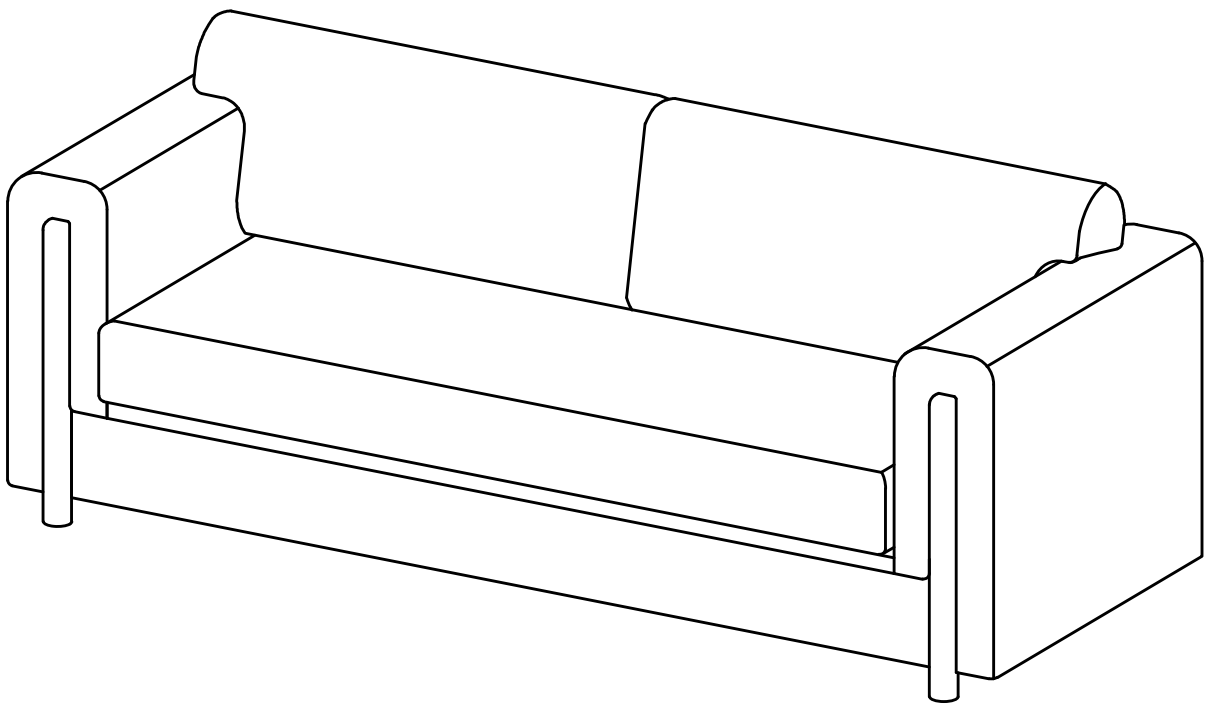
Care & Maintenance

- ⊘  ● Not for commercial use. For residential use only.
- ✓  ● Furniture may scratch floors. We recommend using furniture pads to protect your floors.
- ⊘  ● Do not put hot items directly on furniture surface.
- ⊘  ● Do not clean furniture with harsh cleansers or polish.
- ⊘  ● Do not place furniture under direct sunlight.
- ⊘  ● Do not place furniture near heating or cooling vents.
- ⊘  ● Do not write on furniture without a padded barrier to protect the surface.
- ⊘  ● Do not place furniture outside . For indoor use only.
- ⊘  ● Stains may be removed with mild soap solution and damp cloth.
- ⊘  ● Children should not climb or jump on the furniture.
- ✓  ● Dust and pick-up spills using a clean, non-colored, lint-free cloth.

- Do not assemble on flooring or carpet-



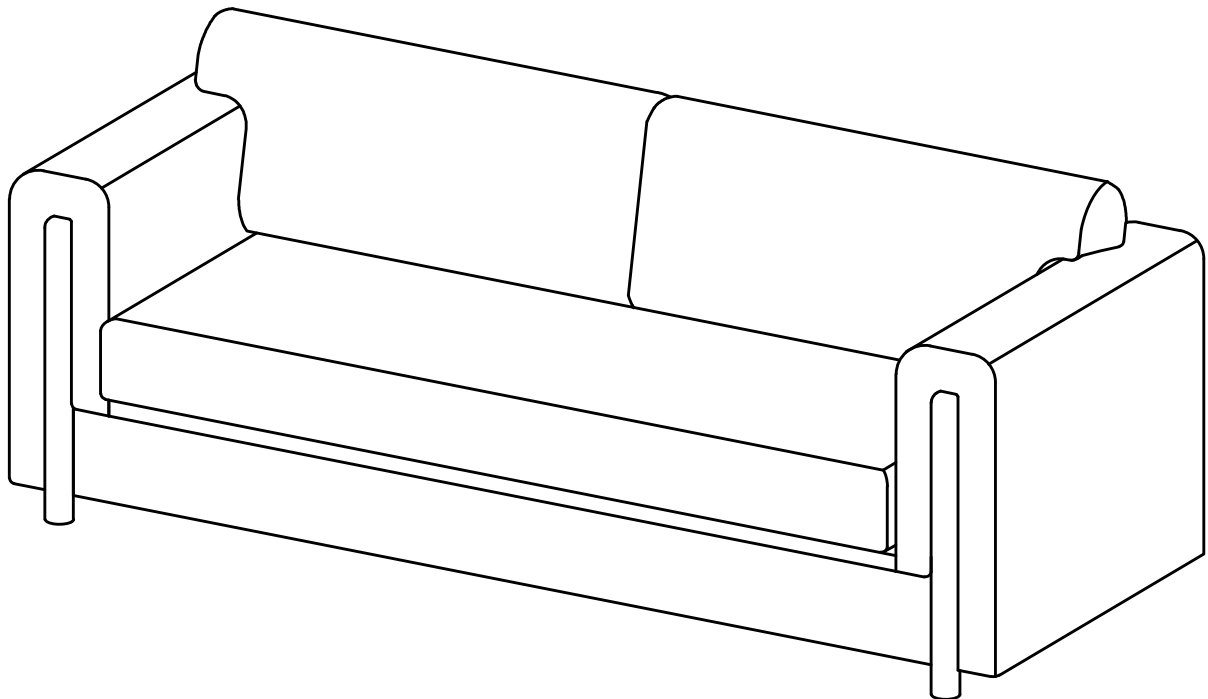
- Assemble on a clean non-marring surface (packing foam)-



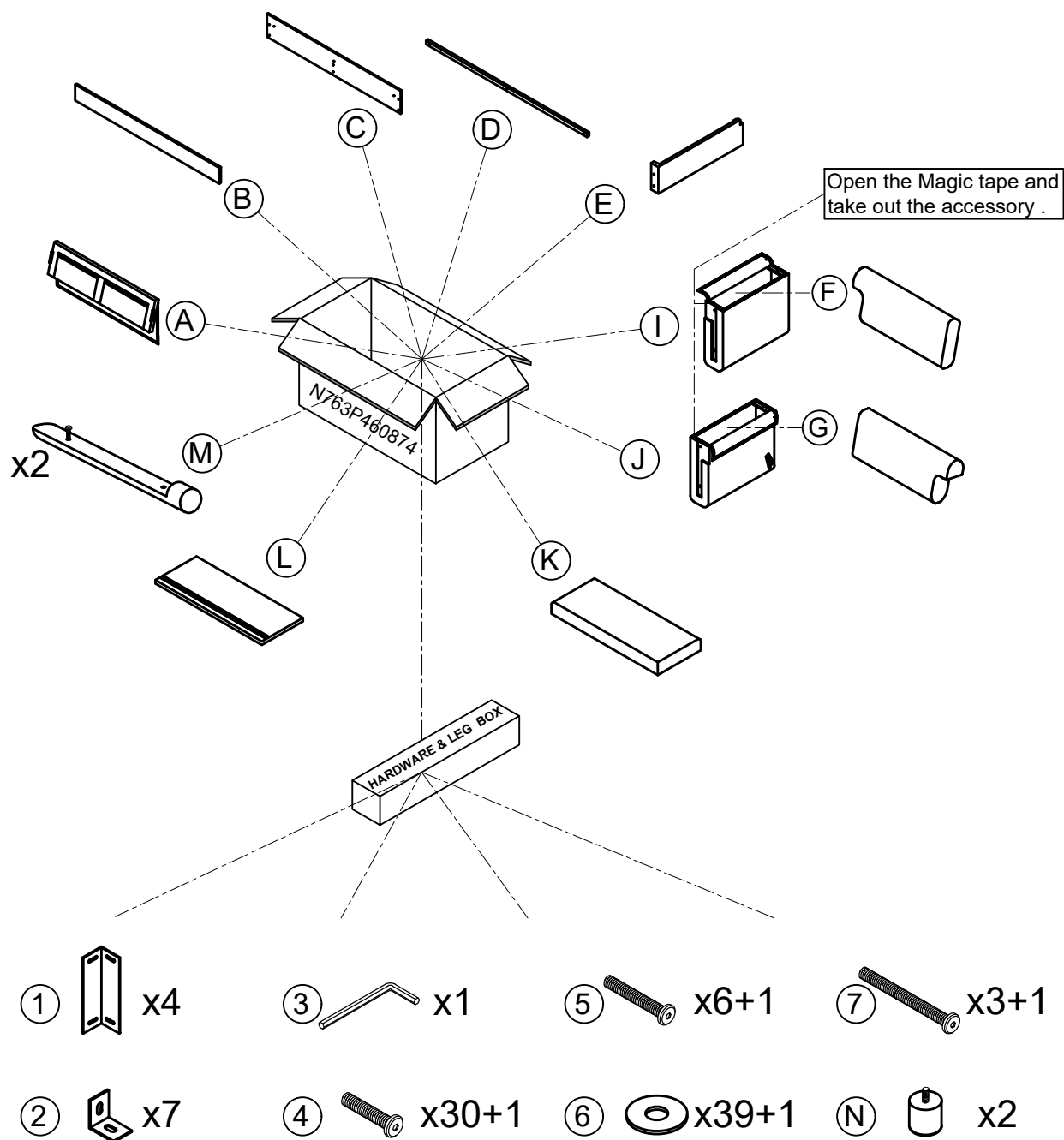

Assembly Steps

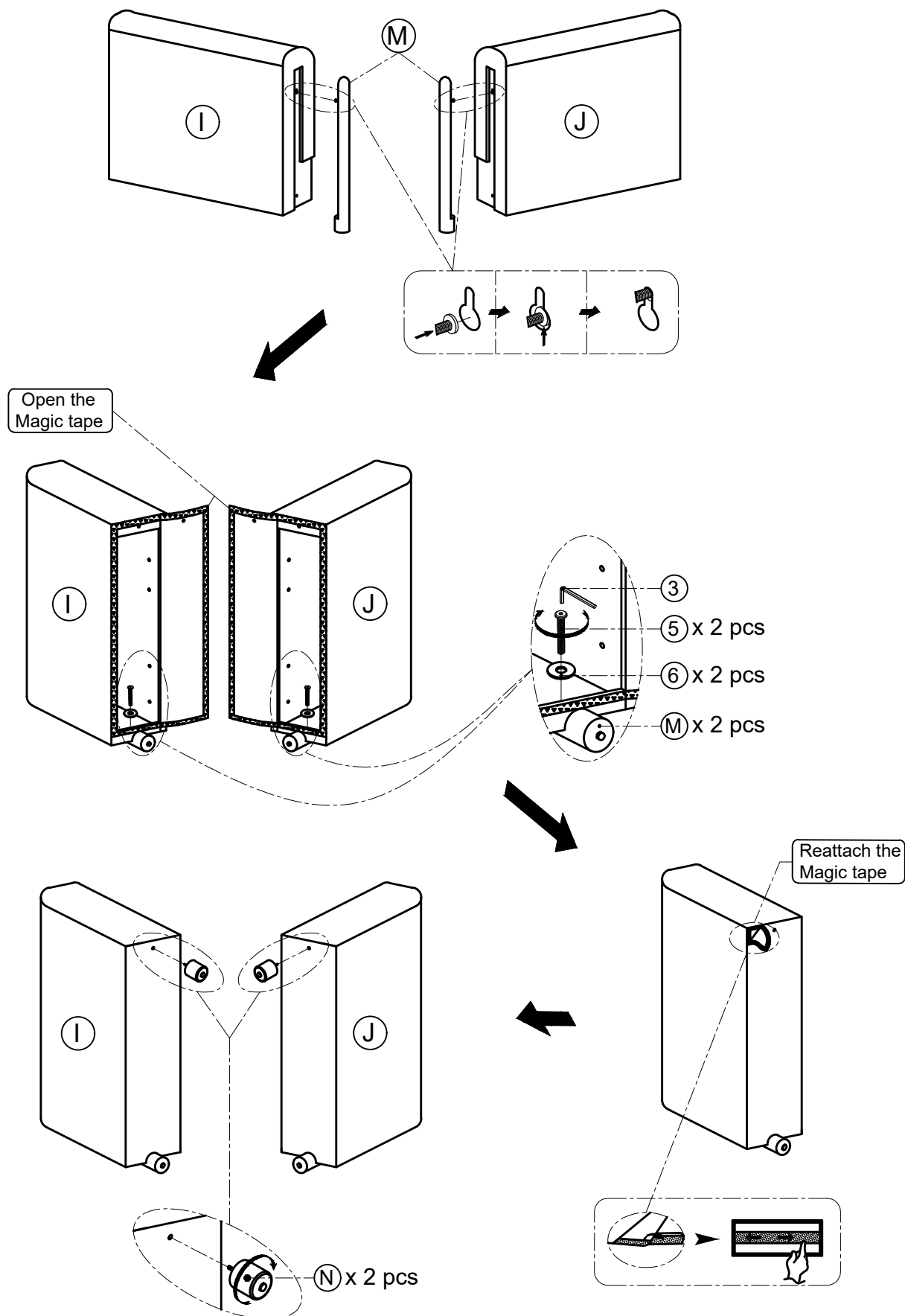
Overview



This Sofa has multiple parts and may require up to some 45 minutes to assemble. To give you an overview of the Sofa parts, the above picture is to help you put the various parts into perspective. Please read through the instructions below to familiarise yourself with the parts and steps before assembly.

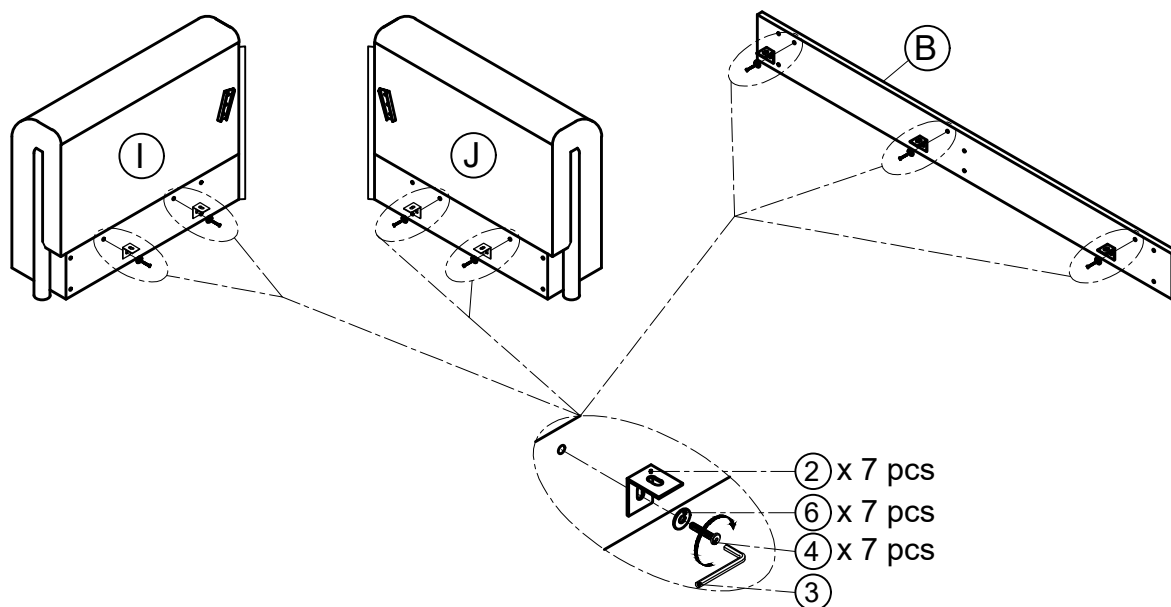


STEP 1: Remove the parts and accessories from the carton .

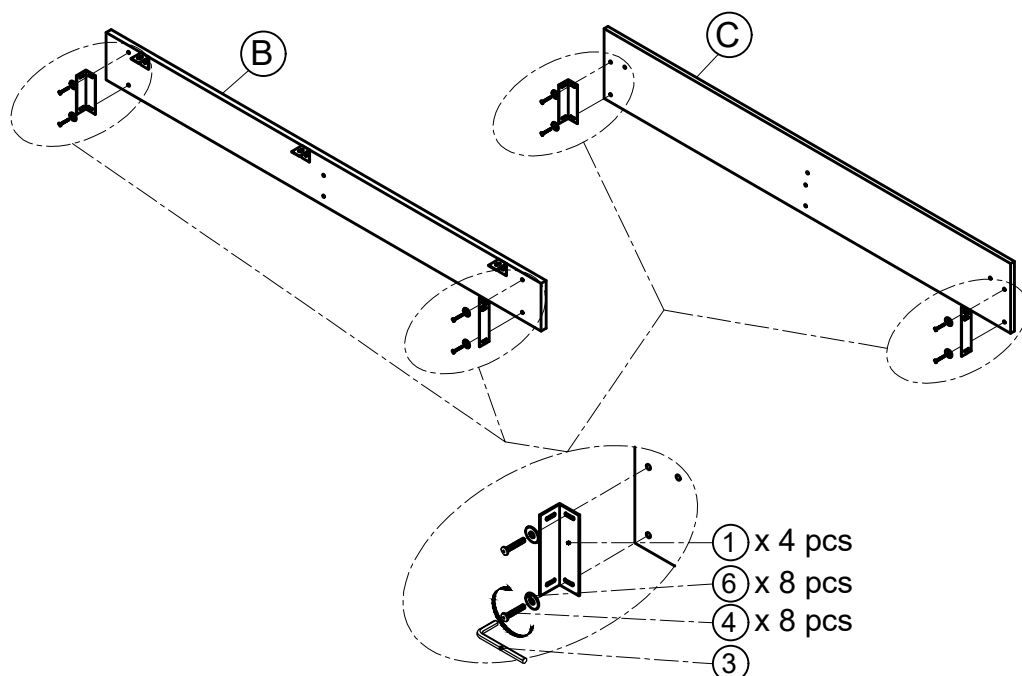


STEP 2: Attach the **Front Legs (M)** to the **Arms (I & J)**. Then remove the magic tape from the Arms and secure them using **Bolts (5)** and **Flat Washers (6)**. Finally, tighten firmly with an **Allen Wrench (3)**.

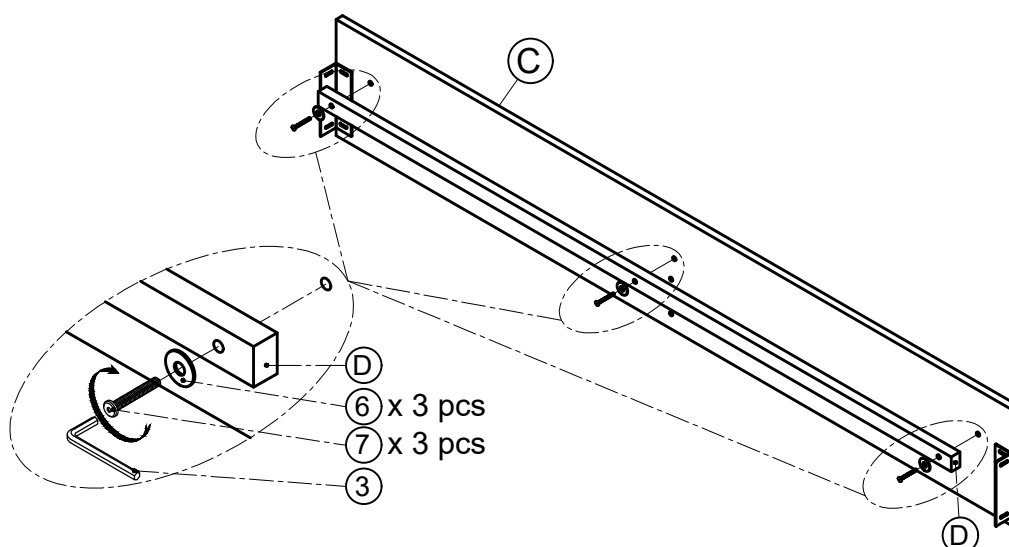
Reattach the magic tape, then install the **Back legs (N)** onto the **Arms (I & J)** by turning them clockwise until securely fixed.



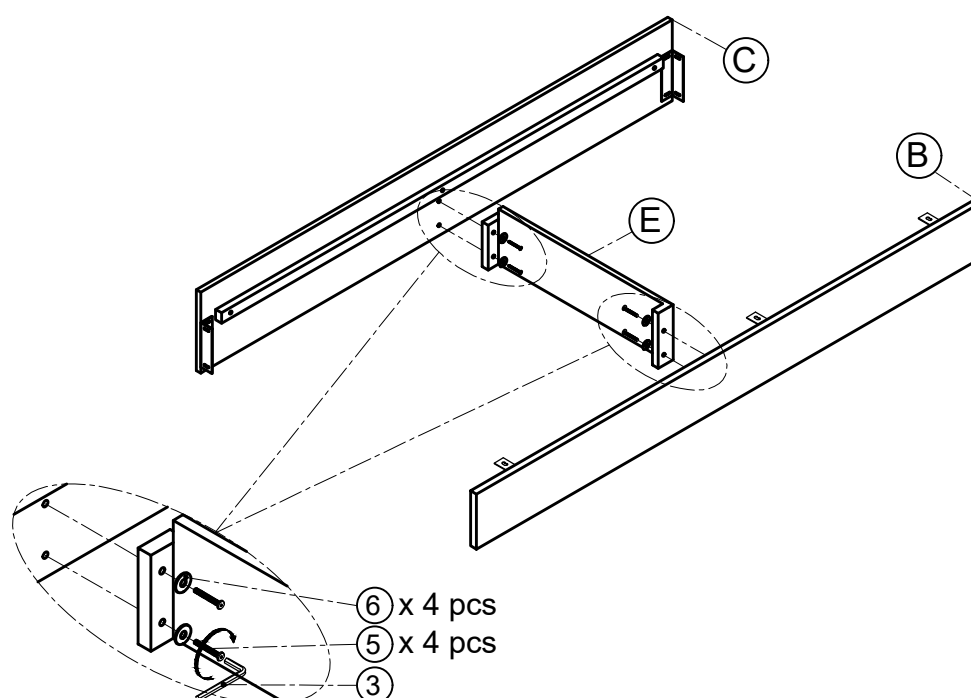
STEP 3: Attach the Lpad (2) to the Arms (I & J) and Front Panel (B) using Bolts (4) and Flat washers (6). Then tighten securely with an Allen Wrench (3).



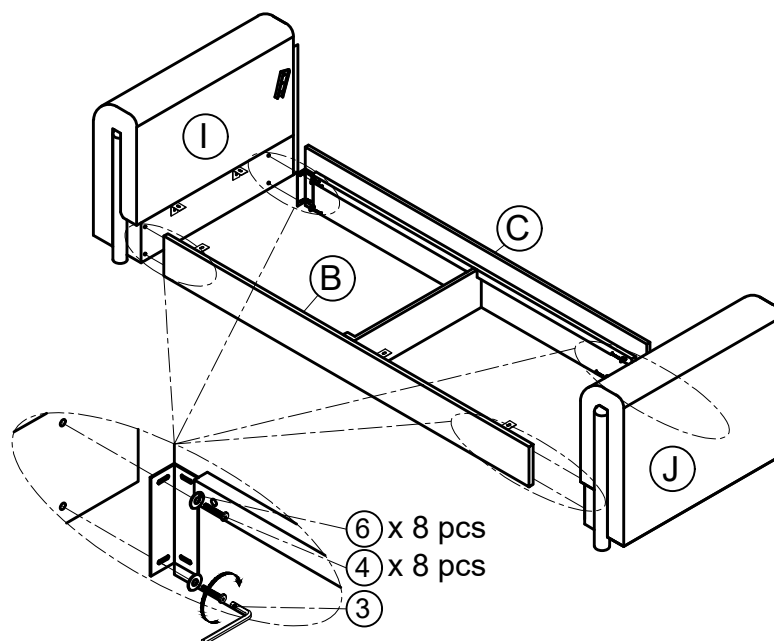
STEP 4: Attach the Vpad (1) to the Front Panel (B) and Back Panel (C) using Bolts (4) and Flat washers (6). Then tighten securely with an Allen Wrench (3).



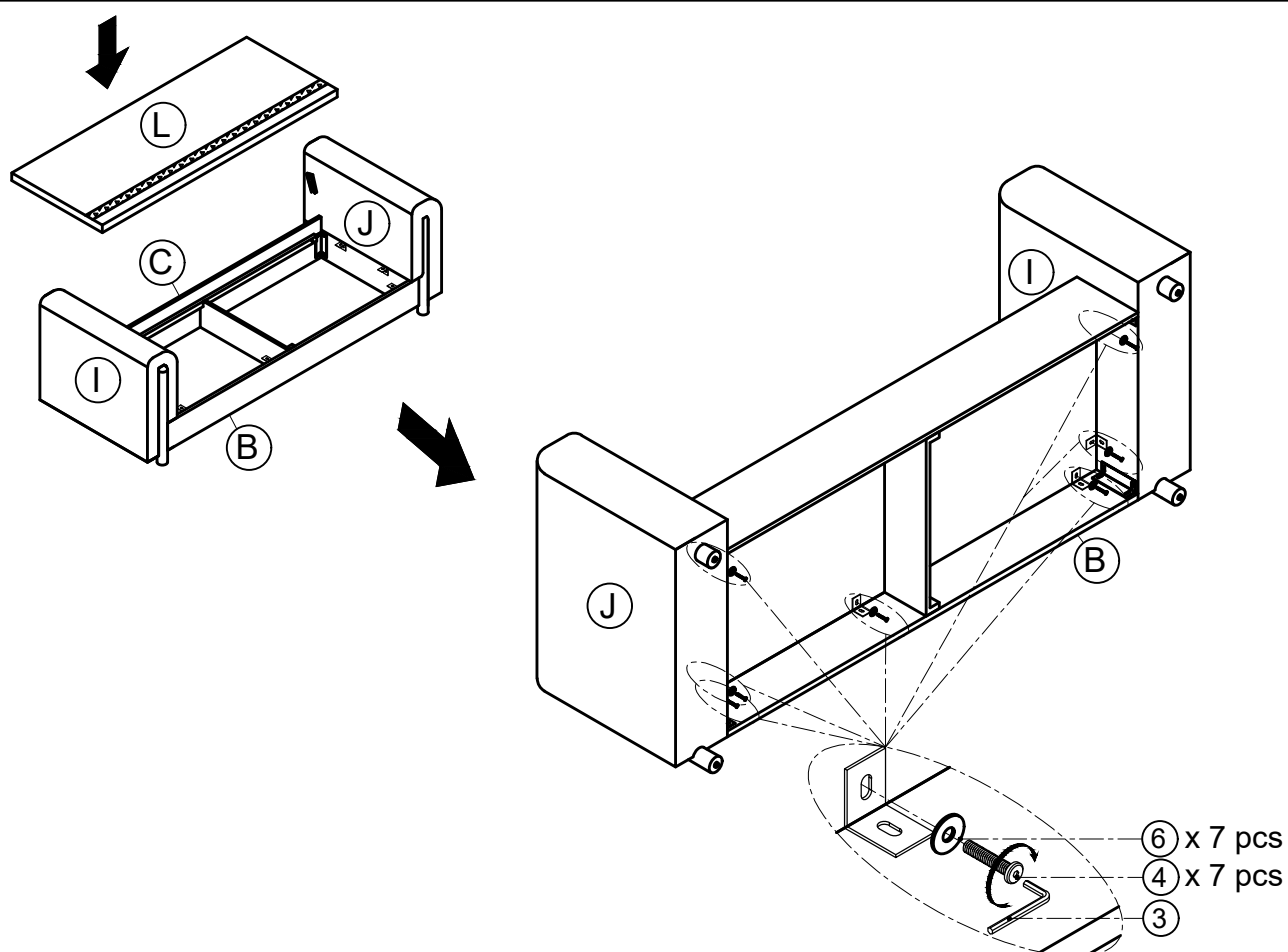
STEP 5: Attach the **Support Rail (D)** to the **Back Panel (C)** using **Bolts (7)** and **Flat washers (6)**. Then tighten securely with an **Allen Wrench (3)**.



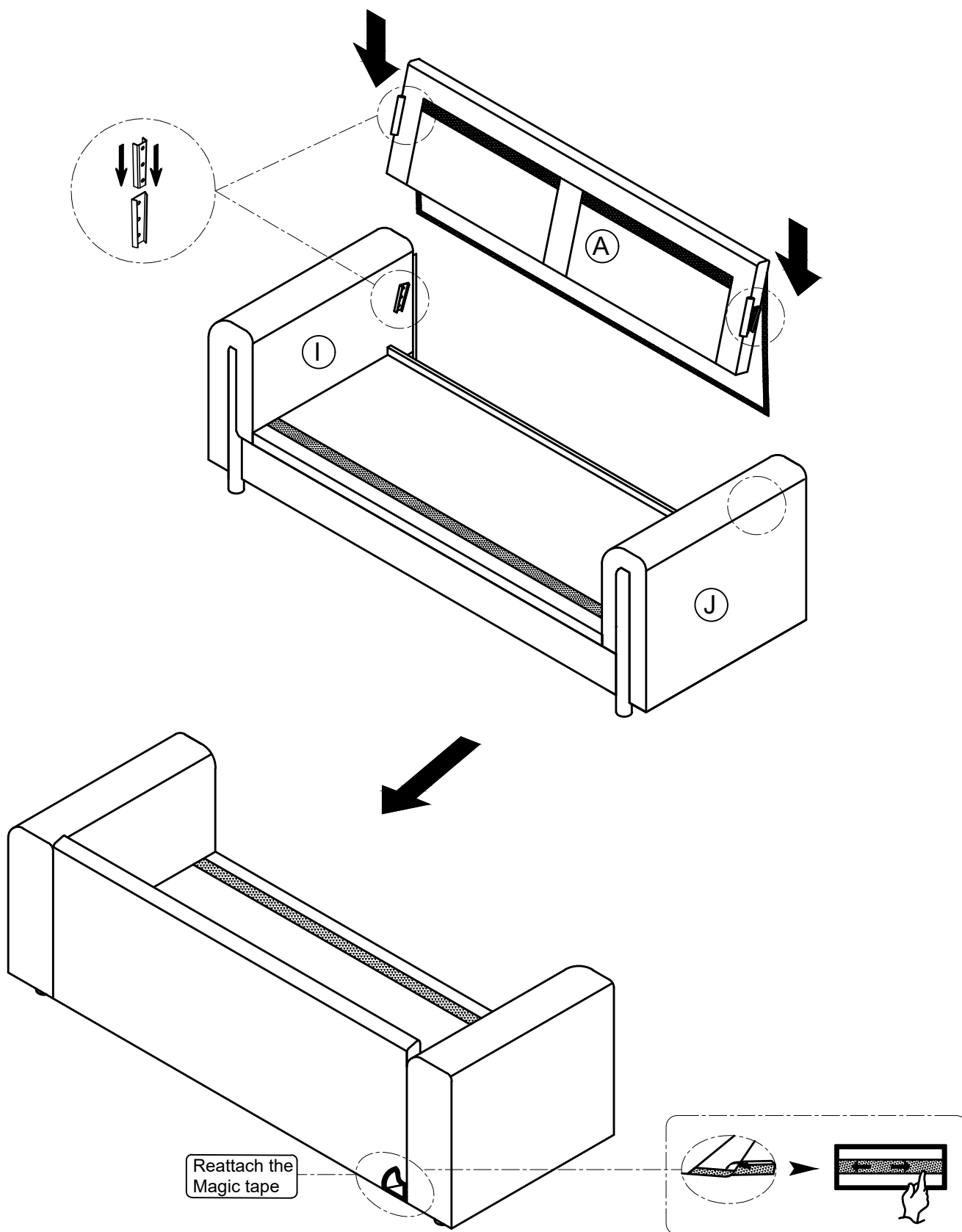
STEP 6: Attach the **Center Support Rail (E)** to the **Front Panel (B)** and **Back Panel (C)** using **Bolts (5)** and **Flat washers (6)**. Then tighten securely with an **Allen Wrench (3)**.



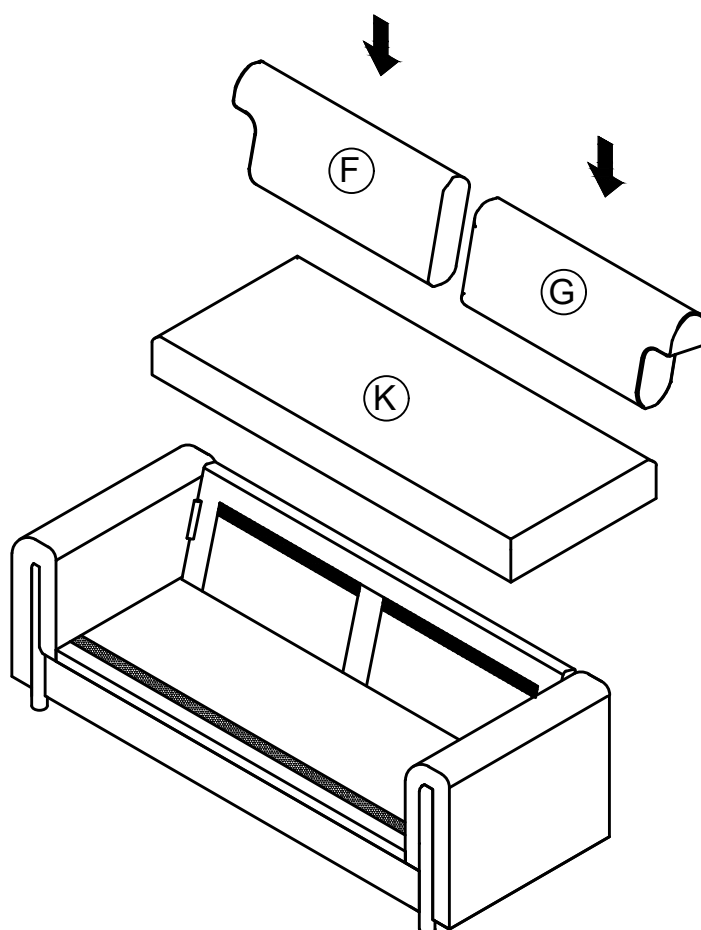
STEP 7: Attach the **Front Panel (B)** and **Back Panel (C)** to the **Arms (I & J)** using **Bolts (4)** and **Flat washers (6)**. Then tighten securely with an **Allen Wrench (3)**.



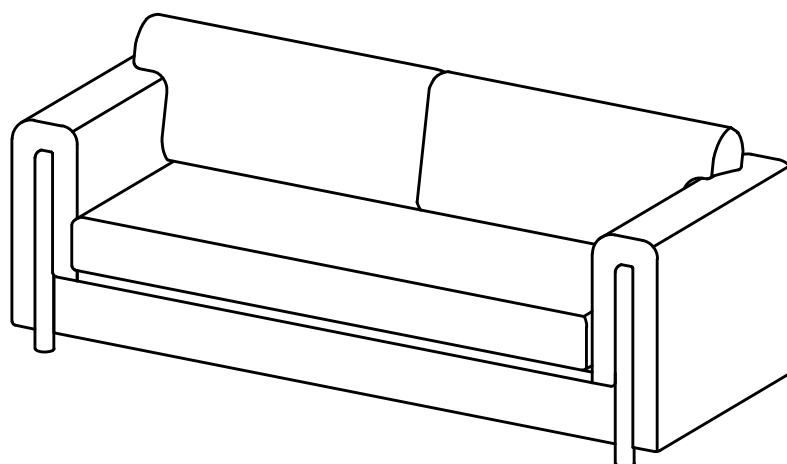
STEP 8: Place the **Spring Frame (L)** into the sofa frame, then attach it to the **Arms (I & J)**, **Front Panel (B)**, using **Bolts (4)** and **Flat Washers (6)**. Tighten securely with an **Allen Wrench (3)**.



STEP 9: Place the **Backrest (A)** into position, ensuring that the **Arms (I & J)** pad and **Backrest (A)** pad fit together properly. Then press the hook-and-loop fabric on the **backrest (A)** and **Arms(I & J)** together.



STEP 10:Position the **Seat Cushion (K)** and **Back Cushions (F & G)**.

Questions & Answers about Proposition 65

- What is Proposition 65?

Proposition 65 requires businesses to provide warnings to Californians about significant exposures to chemicals that cause cancer, birth defects or other reproductive harm. These chemicals can be in the products that Californians purchase, in their homes or workplaces, or that are released into the environment. By requiring that this information be provided, Proposition 65 enables Californians to make informed decisions about their exposures to these chemicals.

Proposition 65 also prohibits California businesses from knowingly discharging significant amounts of listed chemicals into sources of drinking water.

Proposition 65 requires California to publish a list of chemicals known to cause cancer, birth defects or other reproductive harm. This list, which must be updated at least once a year, has grown to include approximately 900 chemicals since it was first published in 1987.

- What types of chemicals are on the Proposition 65 list?

The list contains a wide range of naturally occurring and synthetic chemicals that include additives or ingredients in pesticides, common household products, food, drugs, dyes, or solvents. Listed chemicals may also be used in manufacturing and construction, or they may be byproducts of chemical processes, such as motor vehicle exhaust.

- What does a warning mean?

If a warning is placed on a product label or posted or distributed at a workplace, a business, or in rental housing, the business issuing the warning is aware or believes that it is exposing individuals to one or more listed chemicals.

By law, a warning must be given for listed chemicals unless the exposure is low enough to pose no significant risk of cancer or is significantly below levels observed to cause birth defects or other reproductive harm.
