

GARAGE BASE CABINET W/DRAWERS


PARTS LIST

If you are missing any parts, need assistance with assembly or have questions, please contact us.




FEET LEVELER (4)

LOCATION OF PARTS:

- 1) KEYS (D) are hooked to key leash mounted inside Top Drawer.
- 2) FEET LEVELERS (B) are boxed inside Second Drawer.
- 3) LINERS (C) are packed inside Second Drawer.

ASSEMBLY INSTRUCTIONS


STEP 1

Location of parts: KEYS (D) are hooked to key leash mounted inside Top Drawer. FEET LEVELERS (B) and DRAWER LINERS (C) are packed inside Second Drawer.

Lay CABINET BODY (A) gently on its back. Two people are needed, do NOT attempt this alone.


Screw each FEET LEVELER (B) fully into each pre-installed nut on four corners of cabinet bottom.

Stand cabinet right side up.
Move it to desired location. Adjust each FEET LEVELER (B) as needed to ensure your cabinet is level and stable.



Simply place LINERS (C) in each drawer.



USAGE INSTRUCTIONS

DRAWER REMOVAL


Pull drawer out so that it is almost fully extended. On RIGHT side, push black release lever DOWN. On LEFT side, pull black release lever UP. While holding levers as instructed, pull drawer forward until released from slides attached to Workbench (“Workbench Slides”).

Note: Slides attached to drawer (“Drawer Slides”) are an integral part of drawer and must be removed along with drawer itself.



DRAWER REPLACEMENT


To replace drawer, pull slides out completely. Insert brackets on each side of Drawer Slides into corresponding slots on Workbench Slides, making sure they are properly positioned. Once brackets are inserted into slots, completely close drawer to set all slides in their proper positions.

WARNINGS

Weight capacity per drawer (evenly distributed)	100 lb
Total weight capacity of cabinet (evenly distributed)	400 lb

6. **Lock the drawers before moving the cabinet.**
7. **Do NOT open more than one drawer at a time.** Tipping can occur.
8. **Do NOT step or lean on open drawers.** Tipping can occur.
9. **Load the cabinet starting with the bottom drawers to prevent cabinet from tipping.**
10. **Make sure all drawers are closed tightly before locking or unlocking.**

CARE AND MAINTENANCE

- Avoid harsh, abrasive cleaners, and other corrosive chemicals.
- Do not use scouring pad for cleaning.
- This item is not certified for outdoor use.

1 YEAR LIMITED WARRANTY

Garage Base Cabinet w/Drawers

We warrant to the original consumer purchaser (“Purchaser”) of the Garage Base Cabinet w/Drawers (“Product”) that each Product shall be free from defects in workmanship and materials for a period of 1 year from the date of original purchase. Our obligation under this warranty shall be limited to repair or replacement of, or adequate compensation for the Product which shall not be greater than the amount of the purchase price of the Product, at our option, during the warranty period. All replaced parts and Products become our property and must be returned to us.

This warranty excludes normal wear and tear of the Product and its parts or components, and damage arising from any of the following: negligent use or misuse of the Product, use contrary to this User’s Manual, or alteration by any one other than us. The warranty period of 1 year shall not be extended or renewed by the repair or replacement of, or compensation for, the Product. Any warranty implied by applicable law is limited in duration to one year from the date of purchase and is subject to the same conditions and limitations as is provided for our express warranty.

Except as set forth herein, and to the extent of applicable there are no warranties on this Product either express or implied, and we disclaims all warranties including, but not limited to, any implied warranties of merchantability, infringement or fitness for a particular purpose. No warranty or guarantee given by any person, firm, or corporation with respect to this product shall be binding on us.

If your Product is defective or otherwise requires service or parts, please call us. Please tell us which model you purchased, the date of the purchase, and the problem with your Product. A copy of your original purchase receipt must accompany your service request.
