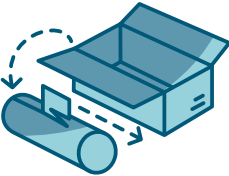

Due to the unique properties of memory foam, dimensions after expansion may vary; this is normal and will not affect the performance of your new topper.

New memory foam may initially have a slight odor; it is completely harmless and will dissipate over a short time with regular use.

Discoloration to memory foam may appear over time due to oxidization. Oxidization is a natural process that occurs when memory foam is exposed to light and will not affect the performance of your topper.

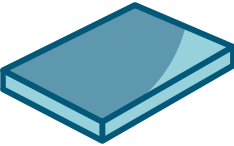
