4. 2 people are recommended to finish.



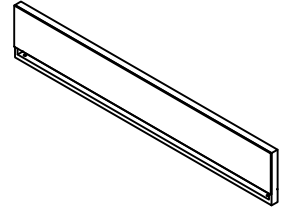

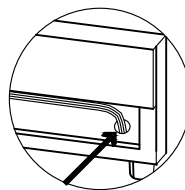




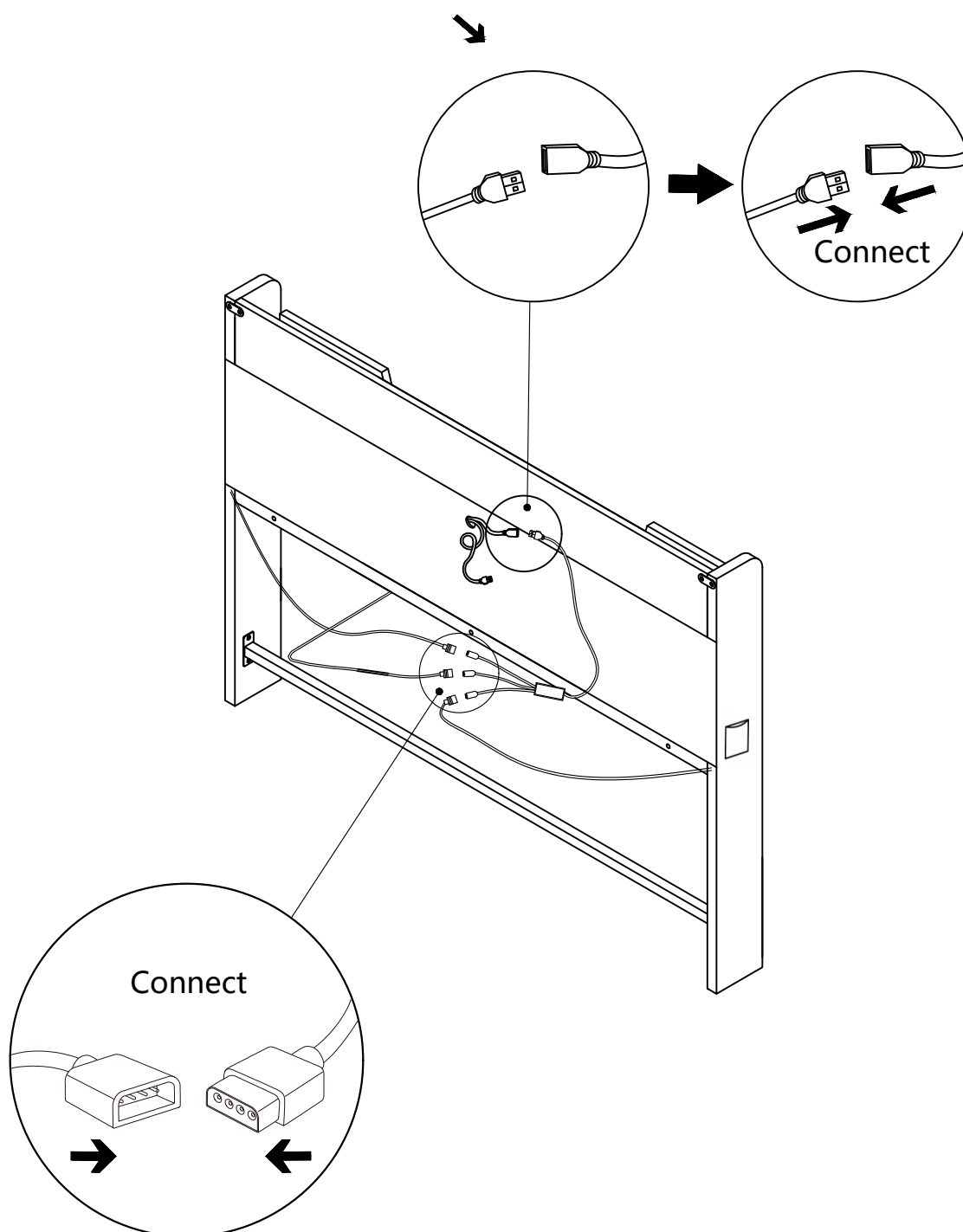
The unfolded light strip has a light strip surface on one side and a magic tape on the other side



The LED strip passes through the threading hole at the bottom of the bed to the headboard.



There is a USB bus under the socket, connect the USB plug of the power cord to it.

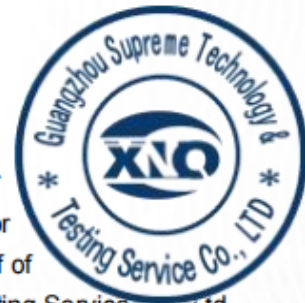
