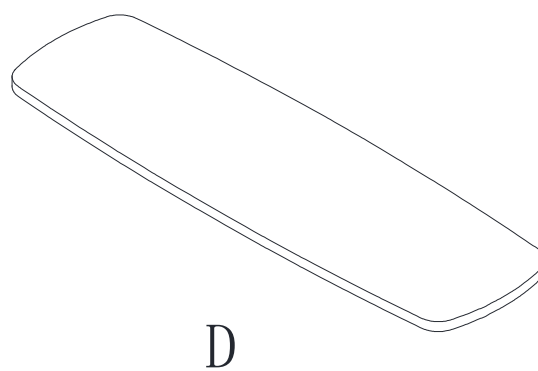
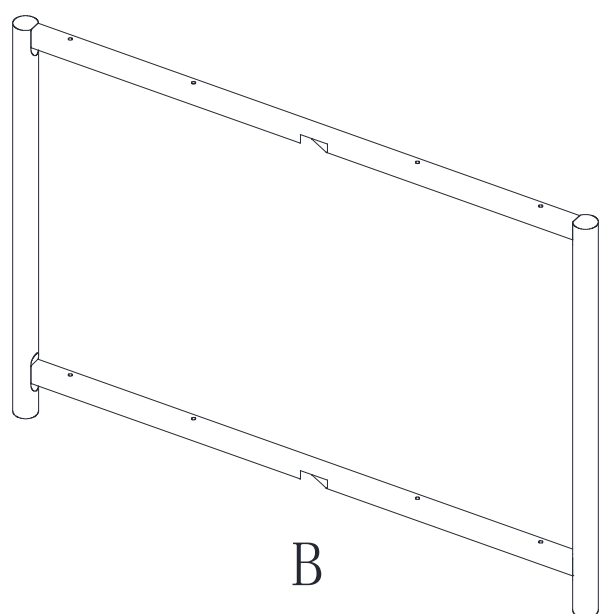
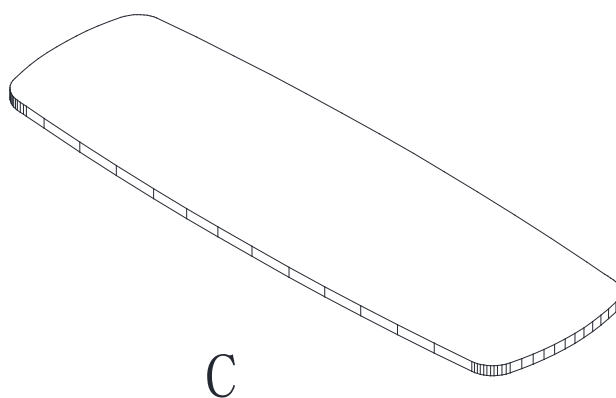
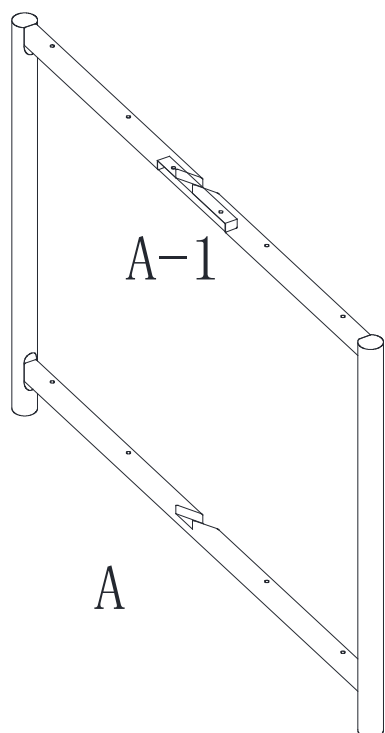
- Read these Warnings fully before use.

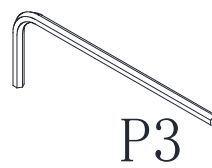

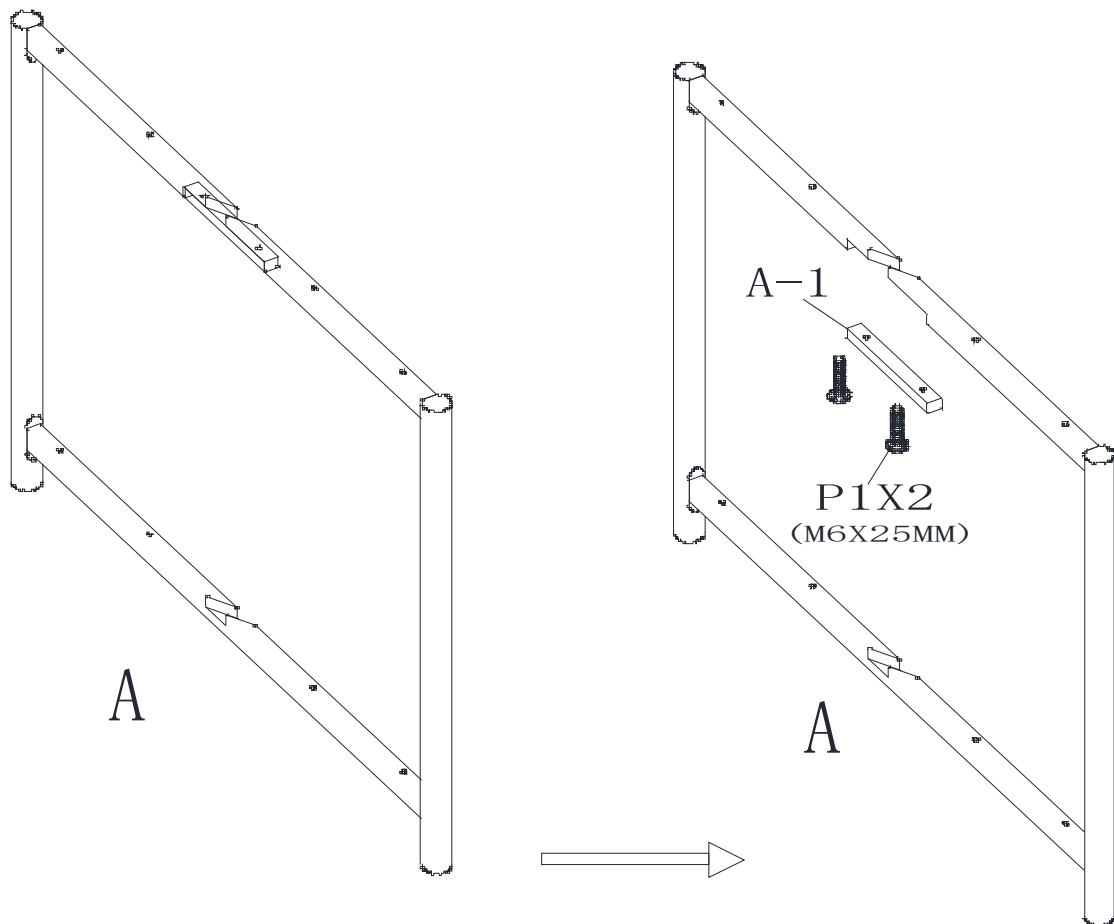

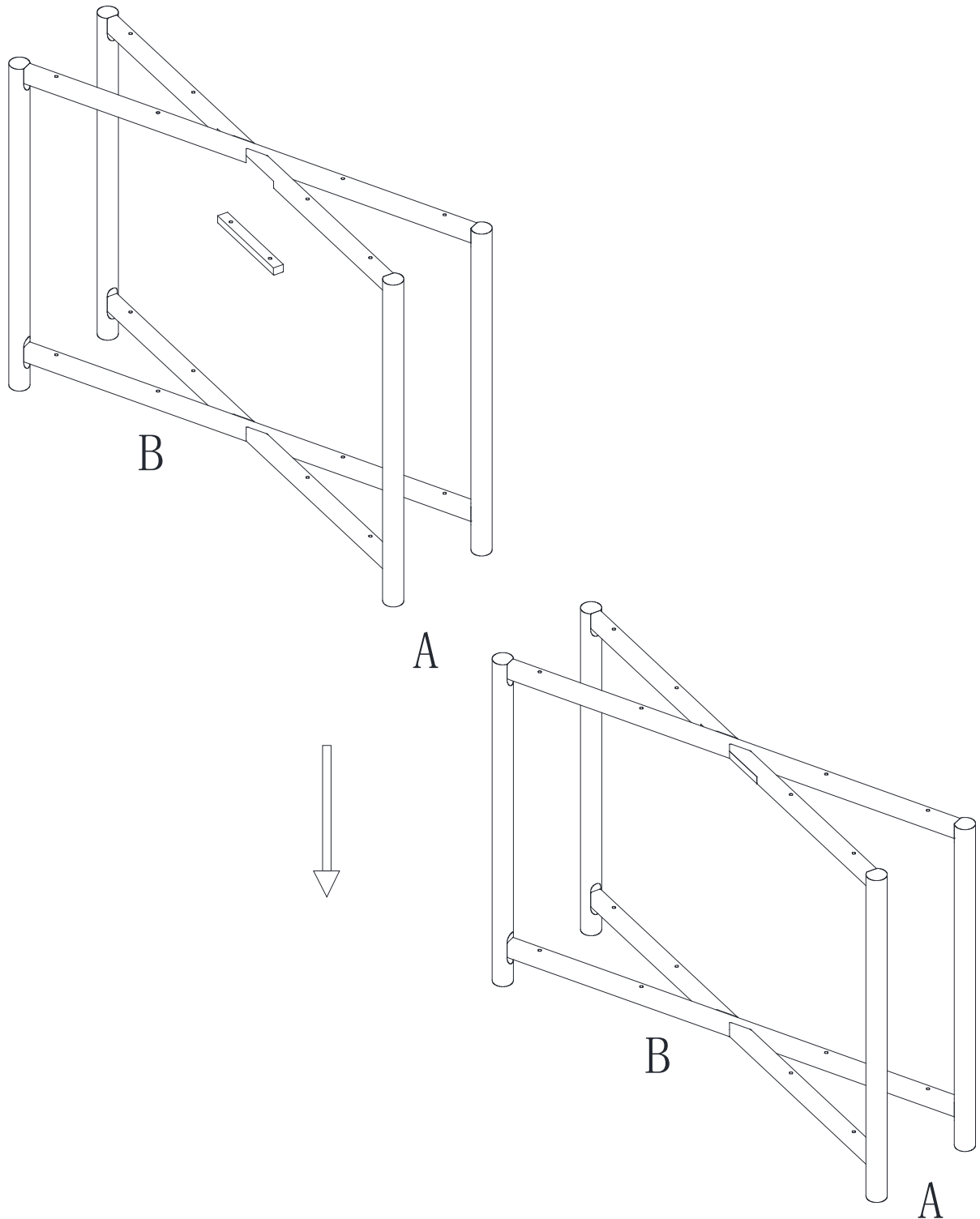


STEP 1



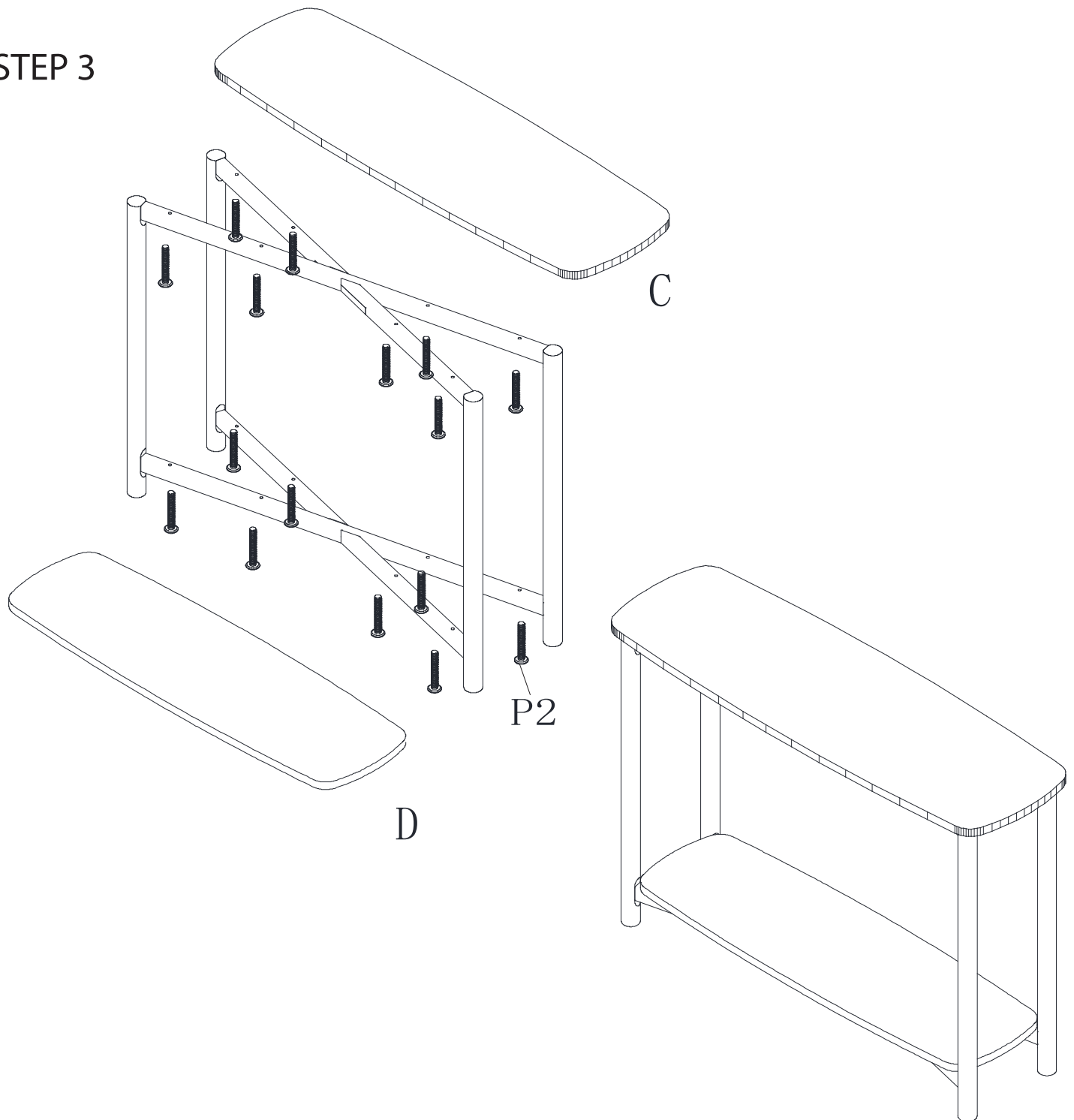
- Unscrew part (A-1) from (A) as shown.
- Destornille la parte (A-1) de (A) como se muestra
- Dévisser la partie (A-1) de (A) comme indiqué.

STEP 2



- Place part (B) on top of part (A). Fit part (B) between the opening on part (A). Then assemble A-1 using P1.
- Coloque la parte (B) en la parte superior de la parte (A). Coloque la parte (B) entre la abertura de la parte (A). Luego ensamble A-1 usando P1.
- Disposez la partie (B) sur le dessus de la partie (A). Ajustez la partie (B) entre l'ouverture sur la partie (A). Puis assemblez A-1 en utilisant P1.

STEP 3



- Screw shelf (C) to the top of the table. Screw shelf (D) to the bottom of the table using (P2) screws.
- Atornille el estante (C) a la parte superior de la mesa. Atornille el estante (D) a la parte inferior de la mesa con los tornillos (P2) .
- Vissez l'étagère (C) au dessus de la table. Vissez l'étagère (D) au fond de la table à l'aide des vis (P2).
