Symmons warrants to the original consumer purchaser that any TEMPTROL®, SYMMETRIX®, or ALLURA® product will be free of defects in material and workmanship during normal domestic use for the life of your home. All other purchasers including industrial, commercial or business use are warranted for a period of 5 years from the date of purchase.

At our option, we will either have you send the defective part or product prepaid to us for inspection, or we may elect to send you the replacement part or product without investigation. A replacement for any defective part will be supplied FREE OF CHARGE for installation by the purchaser. Defect or damage caused by the use of replacement parts other than Symmons Genuine Replacement Parts will void this warranty.

Symmons further warrants that any TEMPTROL, SYMMETRIX, or ALLURA product will be leak free and drip free during normal domestic use for the life of your home. If the product should develop a leak or drip, Symmons will provide FREE OF CHARGE the parts necessary to return it to good working condition.

Proof of purchase (original sales receipt) and a copy of the warranty registration card from the original consumer purchaser must accompany all warranty claims. This warranty is applicable only to Symmons TEMPTROL, SYMMETRIX, or ALLURA products purchased after July 1, 1998 and shall be effective from the date of purchase as shown on the purchaser's receipt.
