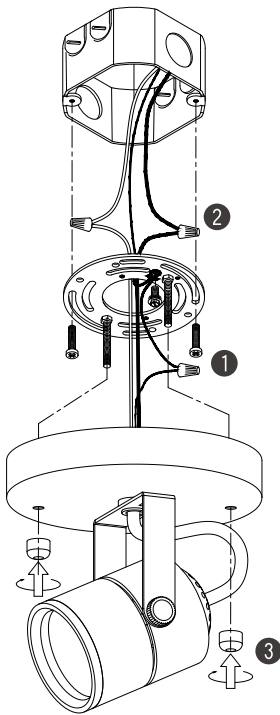
## CAUTION

1. BE SURE THE ELECTRICITY TO THE WIRES YOU ARE WORKING ON IS SHUT OFF; EITHER THE FUSE IS REMOVED OR THE CIRCUIT BREAKER IS TURNED OFF. TURNING THE POWER OFF USING THE LIGHT SWITCH IS NOT SUFFICIENT TO PREVENT ELECTRICAL SHOCK.
2. DO NOT INSTALL OR USE THE LIGHT FIXTURE IF ANY PART IS MISSING OR DAMAGED. CONTACT YOUR DEALER FOR REPLACEMENT OR MISSING PARTS.
3. SOME METAL PARTS IN THE LIGHT FIXTURE MAY HAVE SHARP EDGES, TO PREVENT CUTS OR SCRAPES, WEAR GLOVES BEFORE INSTALLATION.
4. TO PROTECT THE FINISH, WEAR GLOVES BEFORE INSTALLATION, DO NOT USE CLEANSERS OR ABRASIVES DURING MAINTENANCE.
5. TO AVOID POSSIBLE FIRE OR ELECTRICAL SHOCK, MAKE SURE NO BARE WIRE STRANDS ARE EXPOSED OUTSIDE WIRE CONNECTORS.



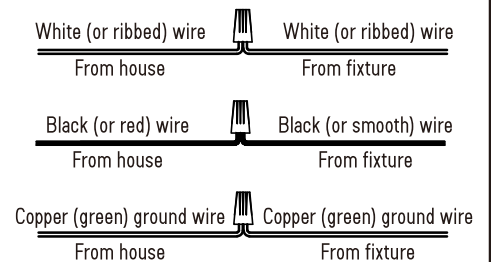
6. IF IN DOUBT ABOUT ELECTRICAL INSTALLATION, CONSULT A LICENSED ELECTRICIAN.

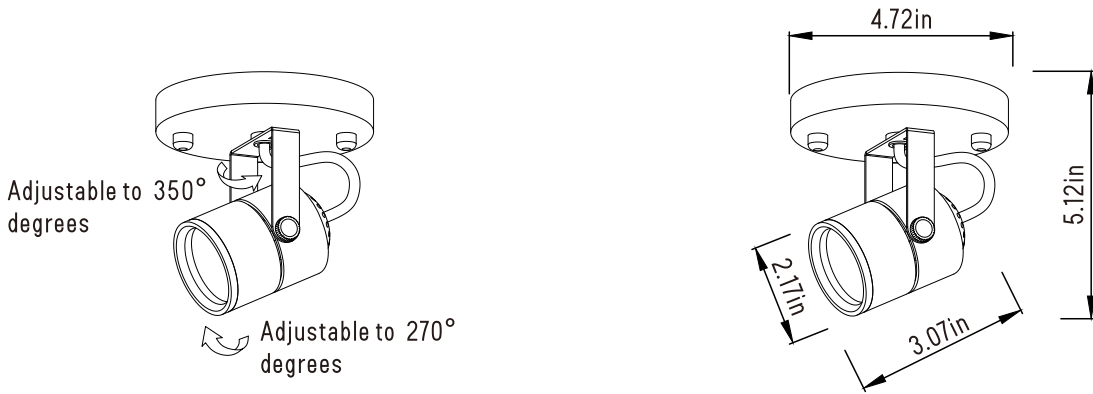


Fixture mounting screw

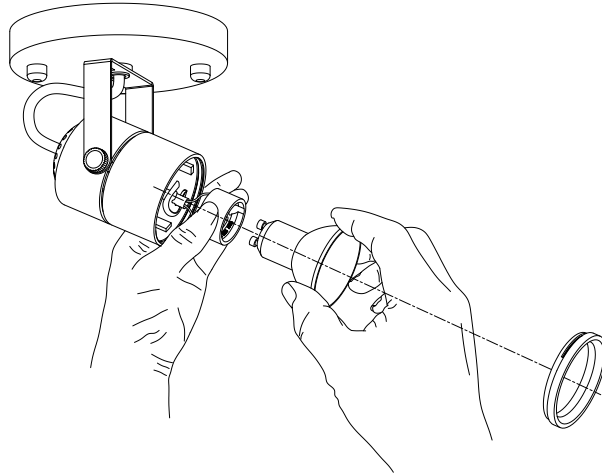
