



LIMITED WARRANTY

Abruzzo warrants to the original consumer purchaser, or commercial purchaser/user, as applicable, that the product will be free from defects in material and workmanship for the applicable period specified below. This warranty is not transferable and applies only to products that are installed in the United States of America.

WHAT WE WILL DO

Abruzzo will, at its sole discretion, repair or replace, free of charge, during the applicable warranty period (as described above), any product covered by this warranty that proves defective in material and/or workmanship under normal installation, use and service. If repair or replacement is not practical, Abruzzo may elect to refund the purchase price. These are your exclusive remedies.

WHAT IS NOT COVERED

Any labor charges incurred by you to repair, replace, install or remove the product are not covered by this warranty. This warranty does not cover damage to the product resulting from reasonable wear and tear, accidents, acts of God, outdoor use, misuse (including use of the product for an unintended application), abuse, neglect, or improper or incorrectly performed assembly or installation, maintenance, or repair, including failure to follow the applicable care and cleaning instructions or performing alterations or using replacement parts not authorized by Abruzzo.

TO OBTAIN WARRANTY SERVICE OR REPLACEMENT PARTS
