

Assembly Instructions for Exercise Pens

Warning –

1) **Before allowing your pet to enter the crate, remove all collars, tags and leashes. This will ensure the pet will not become entangled.**

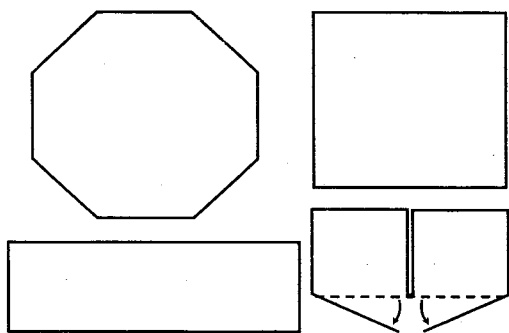
2) **DO NOT leave small or young animals unsupervised for extended periods of time.**

Parts Included:

- A) 8 – Panels
- B) 4 – Snap Hooks
- C) 8 – Ground Anchors
- D) Instruction Manual

Set - Up Instructions

- 1) Unfold exercise pen and decided which configuration best suits your needs.



- 2) Connect two ends with snap hooks at top and bottom of pen. Connect the remaining two in the middle.
- 3) When applicable install the ground anchors for added security. Install one anchor in the bottom corner of each panel.

Limited Manufacturers Warranty

1) For one (1) year from the date of original purchase, Titan Cages will repair or replace at its option, any part of the crate upon examination by Titan Cages to be defective in workmanship or materials. The warranty on any repaired or replaced part will be limited to the unexpired term of the original warranty.

2) **THIS WARRANTY DOES NOT COVER** any damage caused by any animal using the crate, any damage caused from misuse or abuse of the crate, any modifications, attempted repairs or alterations caused by the purchaser or third parties, any defects arising or discovered more than one (1) year from the date of original purchase.

3) Claims procedures:

A: Call customer service at (714) 692-2199 and report the defect or missing parts.

B: Customer service will determine if claim is covered by this warranty. If covered by this warranty they will instruct how to return crate for inspection by Titan Cages or obtain replacement parts.
