WHAT WE WILL DO

WHAT IS NOT COVERED

Any labor charges incurred by you to repair, replace, install, or remove the product are not covered by this warranty. This warranty does not cover damage to the product resulting from reasonable wear and tear, accidents, acts of God, outdoor use, misuse (including use of the product for an unintended application), abuse, neglect, or improper or incorrectly performed assembly or installation, maintenance, or repair, including failure to follow the applicable care and cleaning instructions or performing alterations or using replacement parts not authorized by Fieeay.

TO OBTAIN WARRANTY SERVICE OR REPLACEMENT PARTS
