



Do not assemble on flooring or carpet-




Assemble on a clean non-marring surface (packing foam)-




Save all packaging until finished-


Overview




This Armchair has multiple parts and may require up to 30 minutes to assemble. To give you an overview of the Armchair parts, the above picture is to help you put the various parts into perspective. Please read through the instructions below to familiarise yourself with the parts and steps before assembly.



Place the Frame(A) and Seat(B) on a clean, non-marring surface. Place the Frame(A) with the Legs facing skywards.






Place the Seat(B) on the side of a table, with the backrest facing down and perpendicular to the Desk Top.

- **2.1)** Place the Frame(A) onto the Seat(B) with the Seat(B) stuck in the middle of the Frame(A) and align the mounting positions.
- **2.2)** Attach Frame(A) to Seat(B) using Screws(①) with Screwdriver(②). **Do not fully tighten the Screws.**

Note: If there are gaps between the Frame(A) and Seat(B) which hinder installation, pull the Seat(B) upwards into the Frame(A).



Finally, stand the Armchair up, and place it on a LEVEL SURFACE.

Inspect it and make sure all parts are adequately connected.

Gently and carefully, sit into to the Armchair.


This would help to align all the parts at all joints.

Then get off the Armchair, and place it facedown.

Proceed to tighten all Screws in a sequential manner.

If there are still wobbles, loosen the Screws and execute this same process.





Your Armchair is ready for use.

This Armchair can only be used on a flat, level surface.

Care & Maintenance Do not put hot items directly on furniture surface

Do not clean furniture with harsh cleansers or polish.

Do not place furniture under direct sunlight.

Do not place furniture near heating or cooling vents.

Do not write on furniture without a padded barrier to protect the surface.

Do not place furniture outside. For indoor use only.

Not for commercial use. For residential use only .

Stains may be removed with mild soap solution and damp cloth.

Children should not climb or jump on the furniture.

Dust and pick-up spills using a clean, non-colored, lint-free cloth .

Questions & Answers about Proposition 65

What is Proposition 65?

Proposition 65 requires businesses to provide warnings to Californians about significant exposures to chemicals that cause cancer, birth defects or other reproductive harm. These chemicals can be in the products that Californians purchase, in their homes or workplaces, or that are released into the environment. By requiring that this information be provided, Proposition 65 enables Californians to make informed decisions about their exposures to these chemicals. Proposition 65 also prohibits California businesses from knowingly discharging significant amounts of listed chemicals into sources of drinking water.

Proposition 65 requires California to publish a list of chemicals known to cause cancer, birth defects or other reproductive harm. This list, which must be updated at least once a year, has grown to include approximately 900 chemicals since it was first published in 1987.

What types of chemicals are on the Proposition 65 list?

The list contains a wide range of naturally occurring and synthetic chemicals that include additives or ingredients in pesticides, common household products, food, drugs, dyes, or solvents. Listed chemicals may also be used in manufacturing and construction, or they may be byproducts of chemical processes, such as motor vehicle exhaust.

What does a warning mean?

If a warning is placed on a product label or posted or distributed at a workplace, a business, or in rental housing, the business issuing the warning is aware or believes that it is exposing individuals to one or more listed chemicals.

By law, a warning must be given for listed chemicals unless the exposure is low enough to pose no significant risk of cancer or is significantly below levels observed to cause birth defects or other reproductive harm.
