Please read through the instructions below to familiarise yourself with the parts and steps before assembly.

Step 1



Open the carton and place all the parts onto a clean, non-marring surface.

Place the Right Armrest(B) facedown.

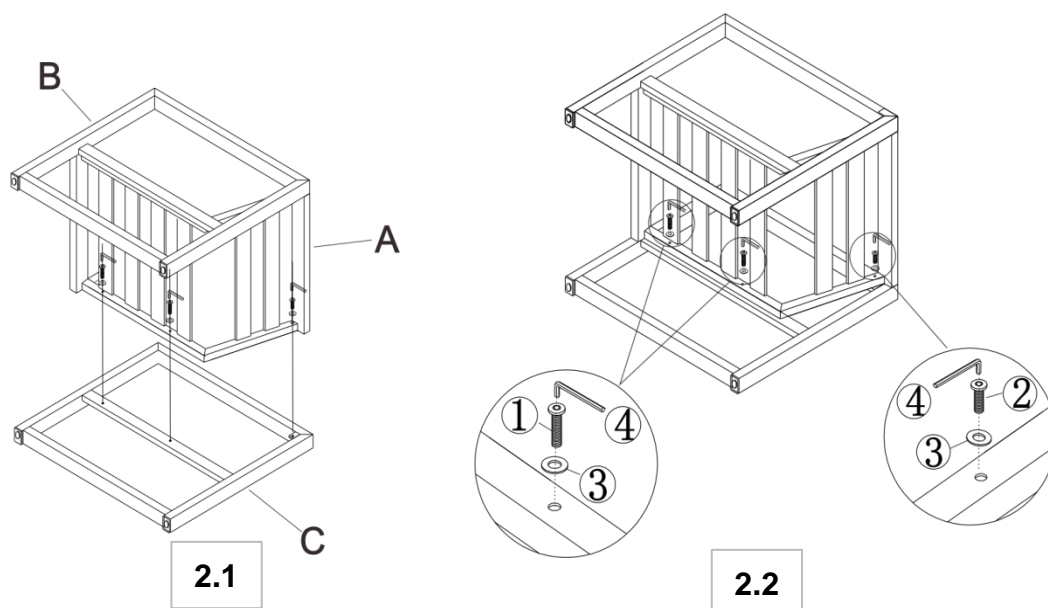
1.1) With the assistance of your adult partner, turn the Seat(A) over and align it to the Right Armrest(B).

1.2) Attach Seat(A) to Right Armrest(B) using Bolts(①) and Washers(③) with Allen Key(④) as shown above.

Attach Seat(A) to Right Armrest(B) using Bolt(②) and Washer(③) with Allen Key(④) as shown above.

Do not fully tighten the Bolts.

Step 2



Place the Left Armrest(C) facedown.

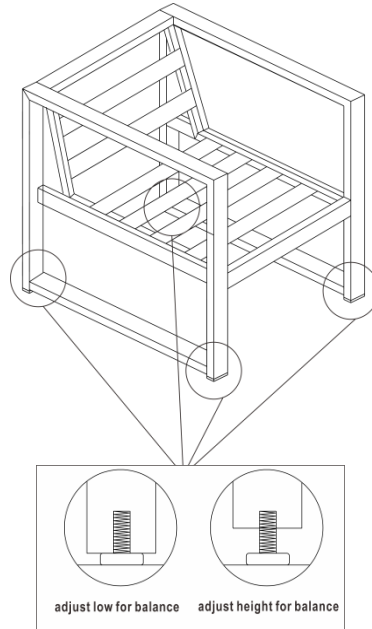
2.1) With the assistance of your adult partner, turn the Seat(A) with Right Armrest(B) over and align it to the Left Armrest(C).

2.2) Attach the Seat(A) to the Left Armrest(C) using Bolts(①) and Washers(③) with Allen Key(④) as shown above.

Attach the Seat(A) to the Left Armrest(C) using Bolt(②) and Washer(③) with Allen Key(④) as shown above.

Do not fully tighten the Bolts.

Step 3



In a sequential manner, proceed to tighten all Bolts.

DO NOT tighten any Bolt fully and then move on to the next one, this may cause the frame to warp.

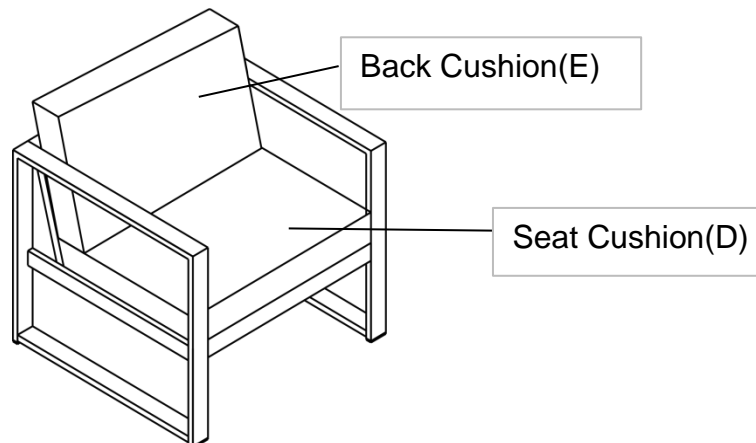
Then, with the assistance from an adult partner, stand the Chair upright.

Adjust the Pre-installed Levellers until the Chair is level with the ground.

To adjust the Levellers: with the assistance from an adult partner, tilt the Chair to rest on two feet.

Adjust the levellers to the desired height to avoid wobbles.

Step 4





















Place the Seat Cushion(D) and Back Cushion(E) on the Chair.

Your Chair is ready for use.

This Chair can only be used on a flat and level surface.

Step 1



Open the carton and place all the parts onto a clean, non-marring surface.
Place the Right Armrest(G) facedown.

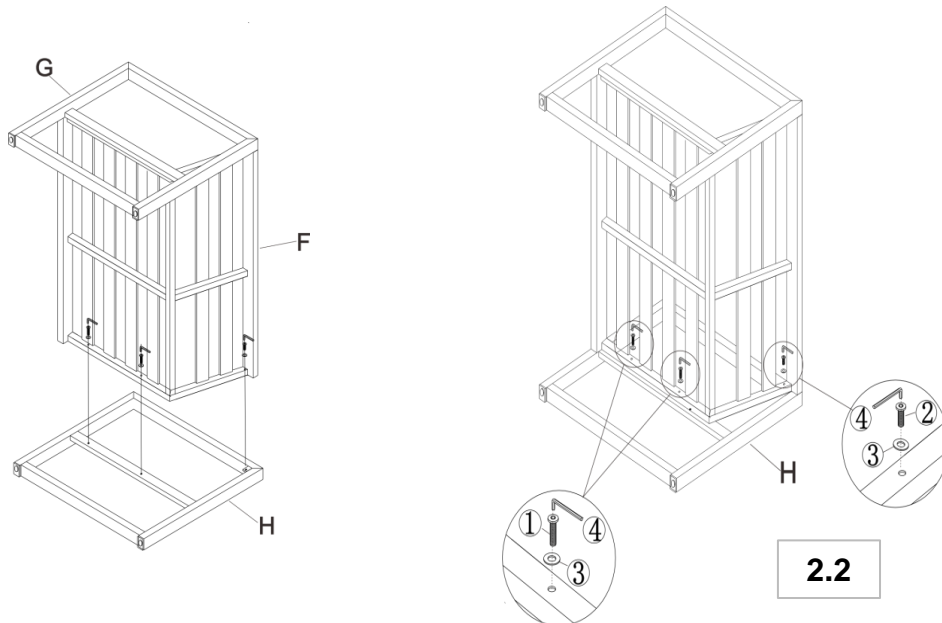
1.1) With the assistance of your adult partner, turn the Seat(F) over and align it to the Right Armrest(G).

1.2) Attach Seat(F) to Right Armrest(G) using Bolts(①) and Washers(③) with Allen Key(④) as shown above.

Attach Seat(F) to Right Armrest(G) using Bolt(②) and Washer(③) with Allen Key(④) as shown above.

Do not fully tighten the Bolts.

Step 2



Place the Left Armrest(H) facedown.

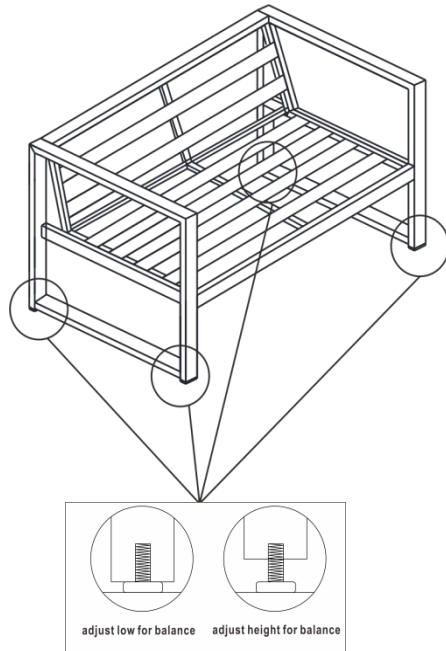
2.1) With the assistance of your adult partner, turn the Seat(F) with Right Armrest(G) over and align it to the Left Armrest(H).

2.2) Attach the Seat(F) to the Left Armrest(H) using Bolts(①) and Washers(③) with Allen Key(④) as shown above.

Attach the Seat(F) to the Left Armrest(H) using Bolt(②) and Washer(③) with Allen Key(④) as shown above.

Do not fully tighten the Bolts.

Step 3



In a sequential manner, proceed to tighten all Bolts.

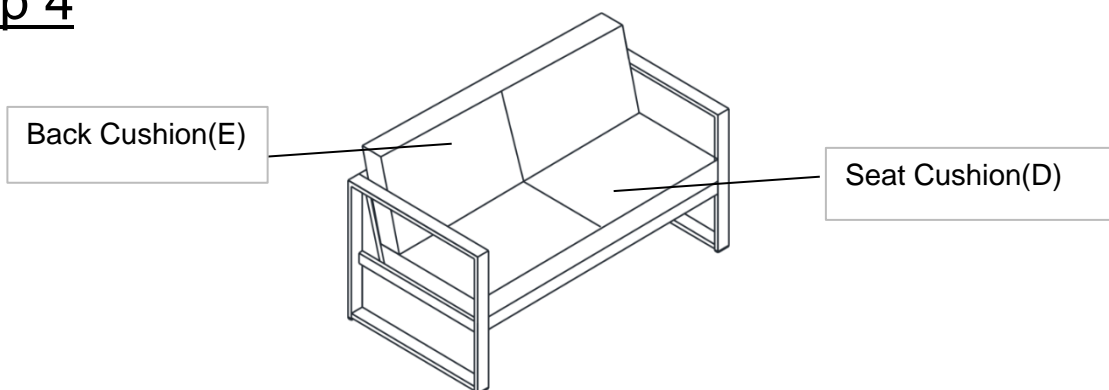
DO NOT tighten any Bolt fully and then move on to the next one, this may cause the frame to warp.

Then, with the assistance from an adult partner, stand the Loveseat upright. Adjust the Pre-installed Levellers until the Loveseat is level with the ground.

To adjust the Levellers: with the assistance from an adult partner, tilt the Loveseat to rest on two feet.

Adjust the levellers to the desired height to avoid wobbles.



















Step 4



Place the Back Cushions(E) and Seat Cushions(D) on the Loveseat. Your Loveseat is ready for use.

This Loveseat can only be used on a flat and level surface.

Step 1

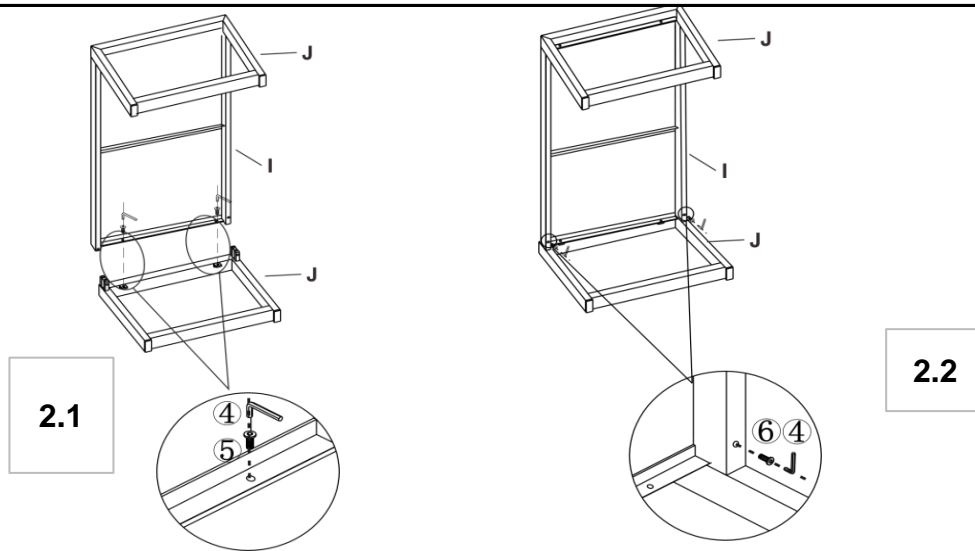


Open the carton and place all the parts onto a clean, non-marring surface.

1.1) Attach Table Top Frame(I) to Leg(J) using Bolts(⑤) with Allen Key(④) as shown above.

1.2) Attach Table Top Frame(I) to Leg(J) using Bolts(⑥) with Allen Key(④) as pictured.
Do not fully tighten the Bolts.

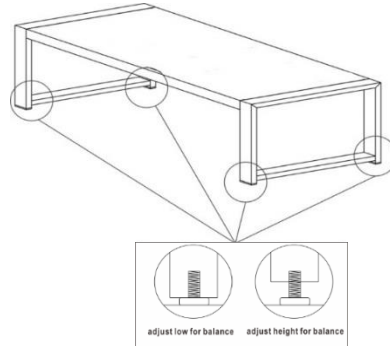
Step 2



2.1) Attach Table Top Frame(I) to Leg(J) using Bolts(5) with Allen Key(4) as shown above.

2.2) Attach Table Top Frame(I) to Leg(J) using Bolts(6) with Allen Key(4) as pictured.
Do not fully tighten the Bolts.

Step 3



In a sequential manner, proceed to tighten all Bolts.

DO NOT tighten any Bolt fully and then move on to the next one, this may cause the frame to warp.

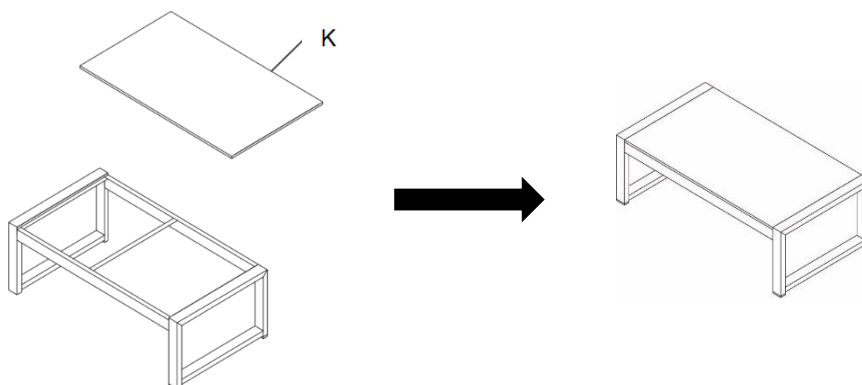
Then, with the assistance from an adult partner, stand the Table upright.

Adjust the Pre-installed Levellers until the Table is level with the ground.

To adjust the Levellers: with the assistance from an adult partner, tilt the Table to rest on two feet.

Adjust the levellers to the desired height to avoid wobbles.

Step 4





















Place the Glass Top(K) on the assembled Table Frame.

Caution: The Glass is Heavy. Two adults are required for lifting and moving it.
