



Do not assemble on flooring or carpet-





Assemble on a clean non-marring surface (packing foam)-


Assembly Steps






Take out the silders in the four ends of the Seatboard (D) using Allen Key(3).


Step 2




Open the carton and place all the parts on a clean, non-marring surface. Insert the Seat(D) into the Left Side Panel(A), shown as the picture.




3.1) Attach Seat(D) and Left Side Panel(A) using Bolt(2) with Allen Key(3) as shown in the picture. 3.2) Attach Seat(D) and Left Side Panel(A) using Bolt(1) with Allen Key(3) as shown in the picture. **Do not fully tighten the Bolt.**




Attach Back Support Bar(C) to Left Side Panel(A) using Bolt(②) with Allen Key(③). **Do not fully tighten the Bolt.**



5.1) Attach Seat(D) and Right Side Panel(B) using Bolt(②) with Allen Key(③) as shown in the picture. 5.2) Attach Seat(D) and Right Side Panel(B) using Bolt(①) with Allen Key(③) as shown in the picture. **Do not fully tighten the Bolt.**




Attach Back Support Bar(C) to Right Side Panel(B) using Bolt(2) with Allen Key(3). **Do not fully tighten the Bolt.**



Stand up the loveseat frame, check stability and then tighten the bolts.

Note DO NOT fully tighten a BOLT in one go and then move on to the next. Rather, In a sequential manner, gradually tighten each Bolt until all bolts are evenly secured. This methodology will ensure maximum evenness once all Bolts are fully tightened.



Put the Seat Cushions(E) and Back Cushions(F) on the Loveseat. Your Loveseat is ready for use.

Care & Maintenance Do not put hot items directly on furniture surface Do not clean furniture with harsh cleansers or polish. To obtain the longest lifespan of your outdoor prodcts, minimizing exposure to direct sunlight is recommended. Children should not climb or jump on the furniture. Do not write on furniture without a padded barrier to protect the surface. To obtain the longest lifespan of your outdoor products, avoid extended and lengthy exposure to rain, snow, and direct sunshine. Whenever possible cover the product and /or place under patio or awnings. Not for commercial use. For residential use only. Stains may be removed with mild soap solution and damp cloth.

Questions & Answers about Proposition 65

What is Proposition 65?

Proposition 65 requires businesses to provide warnings to Californians about significant exposures to chemicals that cause cancer, birth defects or other reproductive harm. These chemicals can be in the products that Californians purchase, in their homes or workplaces, or that are released into the environment. By requiring that this information be provided, Proposition 65 enables Californians to make informed decisions about their exposures to these chemicals.

Proposition 65 also prohibits California businesses from knowingly discharging significant amounts of listed chemicals into sources of drinking water.

Proposition 65 requires California to publish a list of chemicals known to cause cancer, birth defects or other reproductive harm. This list, which must be updated at least once a year, has grown to include approximately 900 chemicals since it was first published in 1987.

What types of chemicals are on the Proposition 65 list?

The list contains a wide range of naturally occurring and synthetic chemicals that include additives or ingredients in pesticides, common household products, food, drugs, dyes, or solvents. Listed chemicals may also be used in manufacturing and construction, or they may be byproducts of chemical processes, such as motor vehicle exhaust.

What does a warning mean?

If a warning is placed on a product label or posted or distributed at a workplace, a business, or in rental housing, the business issuing the warning is aware or believes that it is exposing individuals to one or more listed chemicals.

By law, a warning must be given for listed chemicals unless the exposure is low enough to pose no significant risk of cancer or is significantly below levels observed to cause birth defects or other reproductive harm.
