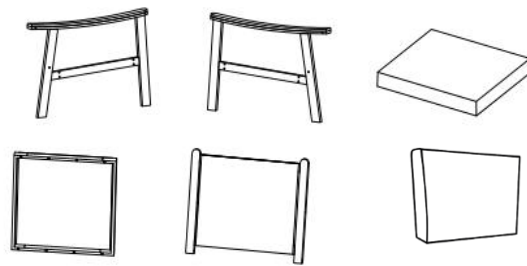
# Assembly Steps

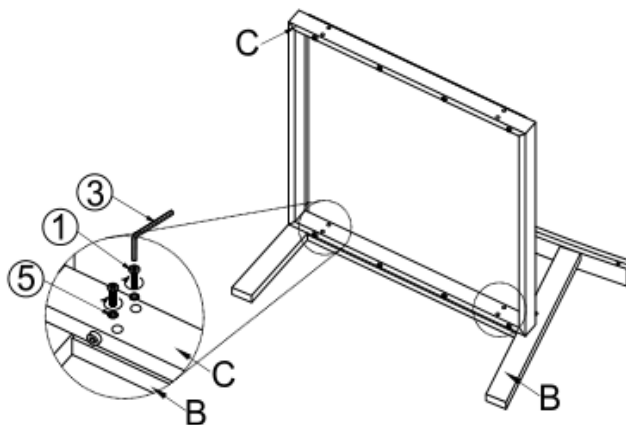

Please read through the instructions below to familiarise yourself with the parts and steps before assembly.

## Step 1



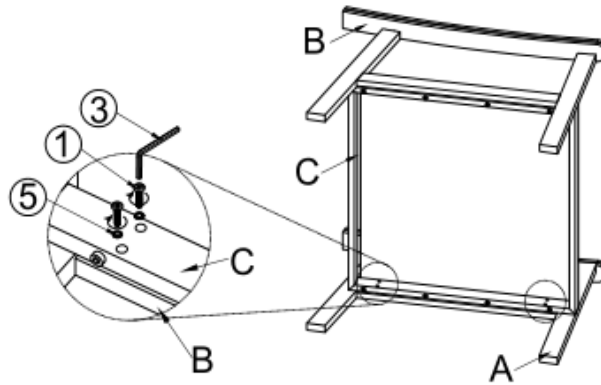
Unpack and place all parts on a clean, non-marring surface.

## Step 2



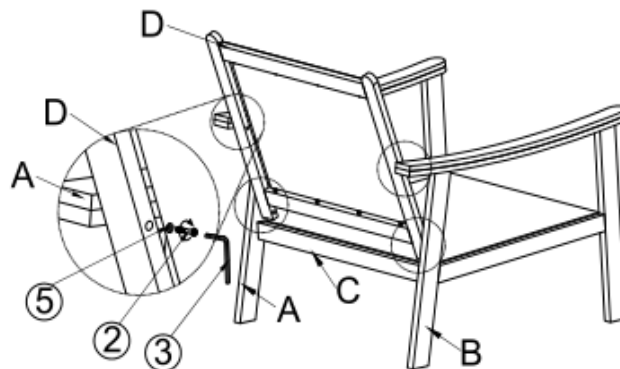
Attach Seat Panel (C) to Left Armrest (B) using Bolts (①) and Washers (⑤) with Allen Key (③).  
**Do not fully tighten the Bolts.**

### Step 3



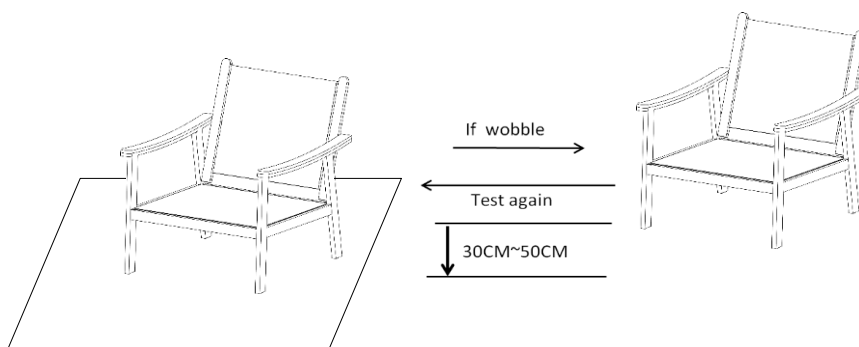
Attach Seat Panel(C) to Right Armrest(A) using Bolts(①) and Washers(⑤) with Allen Key(③).  
**Do not fully tighten the Bolts.**

### Step 4



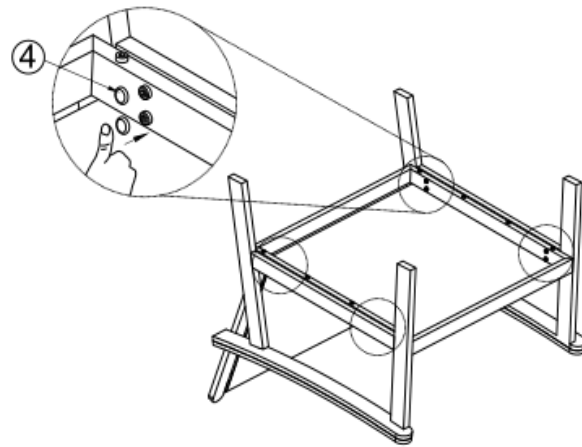
Attach Backrest(D) to Left Armrest(B) and Right Armrest(A) using Bolts(②) and Washers(⑤) with Allen Key(③).  
**Do not fully tighten the Bolts.**

### Step 5



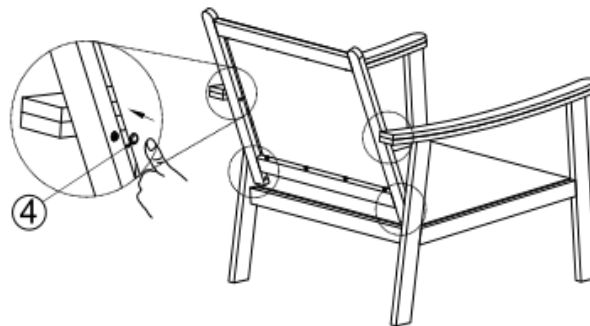
Place the Club Chair on a **LEVEL SURFACE** to see if it wobbles.  
If it wobbles, lift the Club Chair some 30cm to 50cm high from the ground.  
Keep your feet and toes well away from the drop zone.  
Drop the Club Chair freely and vertically with the four legs, hitting the ground, at the same time.  
This Drop Test will help to ensure that all the Bolts and gaps all reach full alignment status.  
Test again for evenness on a **LEVEL SURFACE**.  
If no wobbles are found, proceed to tighten all the Bolts.  
**When tightening the Bolts, tighten sequentially.**  
**DO NOT tighten any Bolt fully and then move on to the next one.**  
**This may cause the frame to warp.**  
**If there are still wobbles, loosen the Bolts and execute the same drop test.**

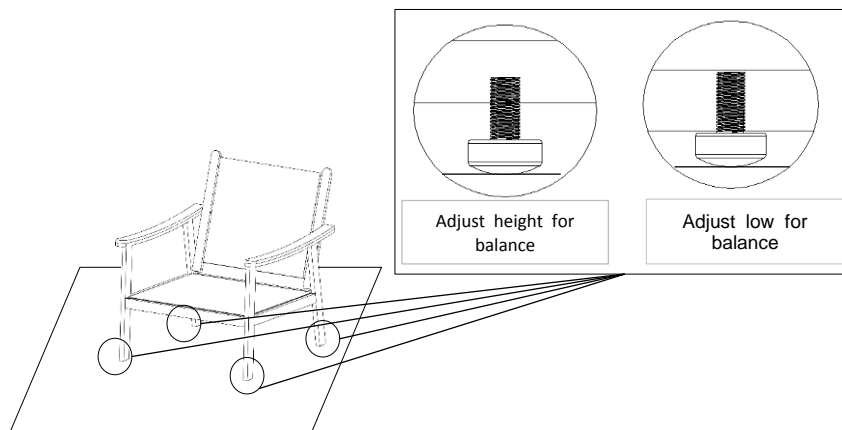
Cover the Bolts with Caps(4) after tightening.

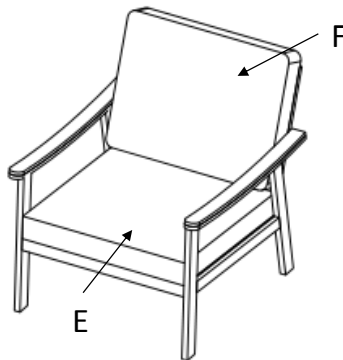


At this point, ensure all bolts and nuts are fully tightened and secured.

Then, with the assistance of your adult partner, proceed to turn and stand the Loveseat upright. Adjust the Legs Pre-installed Levellers until the Loveseat is level with the ground.

To adjust the Levellers, with the assistance of your adult partner, tilt the Loveseat to rest on the 2 feet. Adjust the levellers to the desired height to avoid wobbles.





















## Step 9



Place the Seat Cushion(E) and Back Cushion(F) on the Club Chair.

**This Club Chair can only be used on a flat, level surface.**

## Step 1



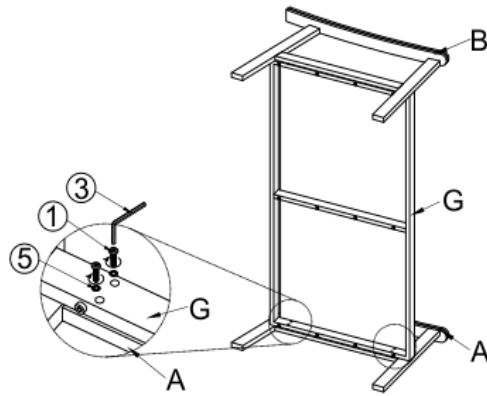
Unpack and place all parts on a clean, non-marring surface.

## Step 2



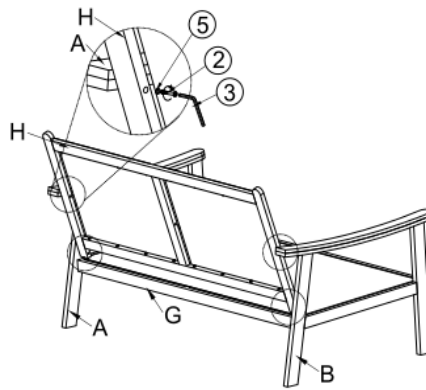
Attach Seat Panel(G) to Left Armrest(B) using Bolts(1) and Washers(5) with Allen Key(3).  
**Do not fully tighten the Bolts.**

### Step 3



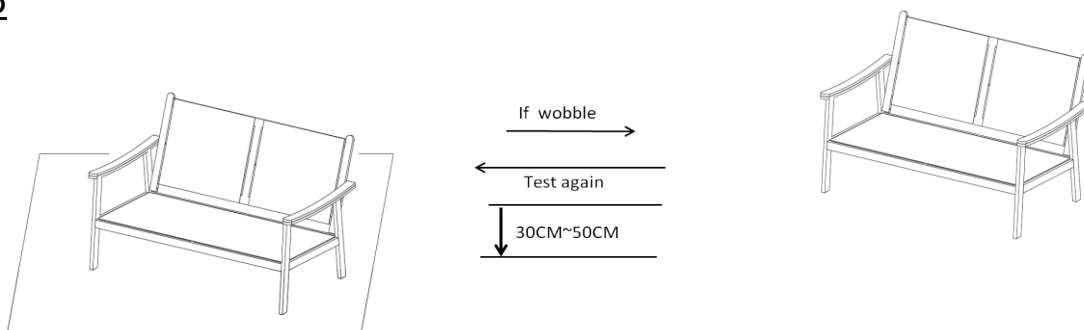
Attach Seat Panel(G) to Right Armrest(A) using Bolts(①) and Washers(⑤) with Allen Key(③).  
**Do not fully tighten the Bolts.**

### Step 4



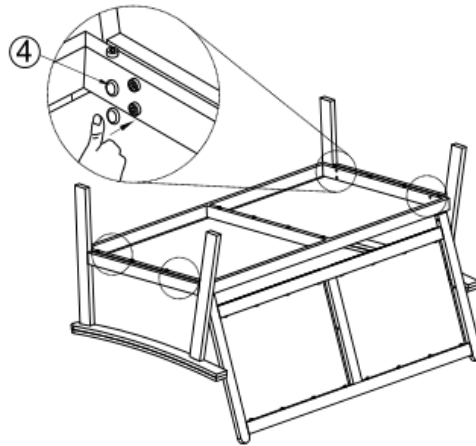
Attach Backrest(H) to Left Armrest(B) and Right Armrest(A) using Bolts(②) and Washers(⑤) with Allen Key(③).  
**Do not fully tighten the Bolts.**

### Step 5



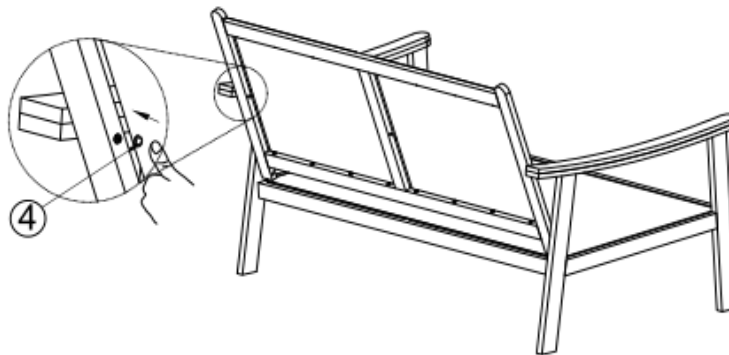
Place the Loveseat on a **LEVEL SURFACE** to see if it wobbles.  
If it wobbles, lift the Loveseat some 30cm to 50cm high from the ground.  
Keep your feet and toes well away from the drop zone.  
Drop the Loveseat freely and vertically with the four legs, hitting the ground, at the same time.  
This Drop Test will help to ensure that all the Bolts and gaps all reach full alignment status.  
Test again for evenness on a **LEVEL SURFACE**.  
If no wobbles are found, proceed to tighten all the Bolts.  
**When tightening the Bolts, tighten sequentially.**  
**DO NOT tighten any Bolt fully and then move on to the next one.**  
**This may cause the frame to warp.**  
**If there are still wobbles, loosen the Bolts and execute the same drop test.**

### Step 1



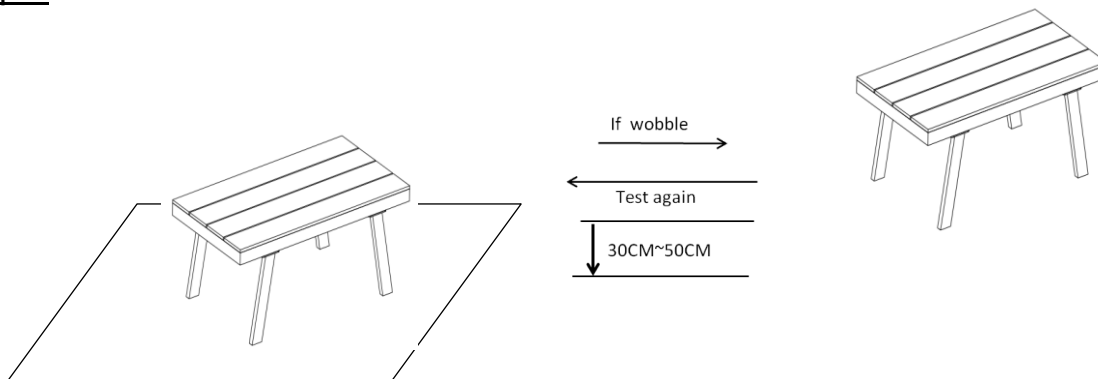
Unpack and place all parts on a clean, non-marring surface.

## Step 2



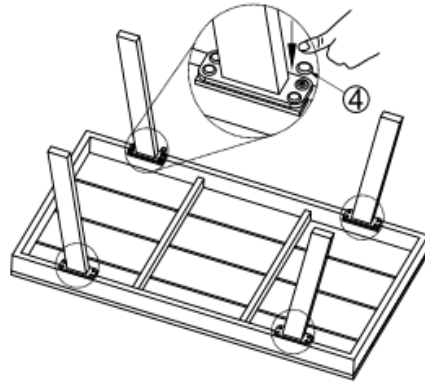
Place the Table Top(J) facedown upon the clean, non-marring surface.  
Attach one Leg(K) to Table Top(J) using Bolts(6) and Washers(5) with Allen Key(3).  
**Do not fully tighten the Bolts.**  
Repeat the same process with the remaining three Legs.

## Step 3



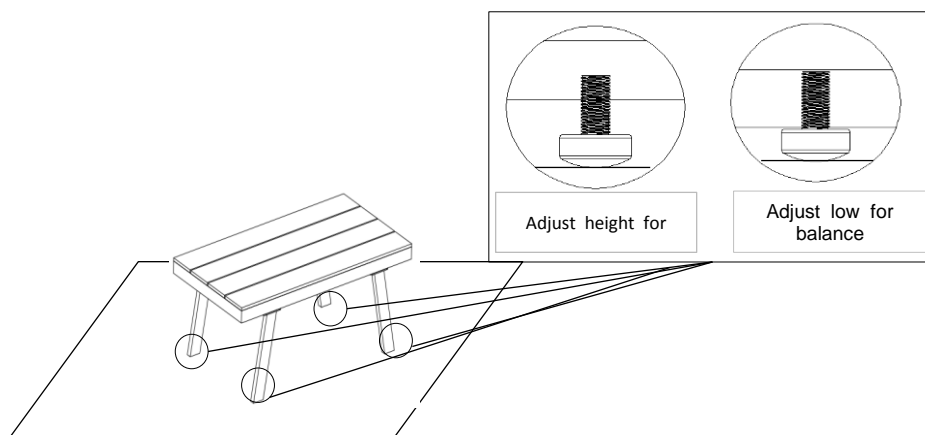
Place the Coffee Table on a LEVEL SURFACE to see if it wobbles.  
If it wobbles, lift the Coffee Table some 30cm to 50cm high from the ground.  
Keep your feet and toes well away from the drop zone.  
Drop the Coffee Table freely and vertically with the four legs, hitting the ground, at the same time.  
This Drop Test will help to ensure that all the Bolts and gaps all reach full alignment status.  
Test again for evenness on a LEVEL SURFACE.  
If no wobbles are found, proceed to tighten all the Bolts.  
**When tightening the Bolts, tighten sequentially.**  
**DO NOT tighten any Bolt fully and then move on to the next one.**  
**This may cause the frame to warp.**  
**If there are still wobbles, loosen the Bolts and execute the same drop test.**

Cover the Bolts with Caps(④) after tightening.

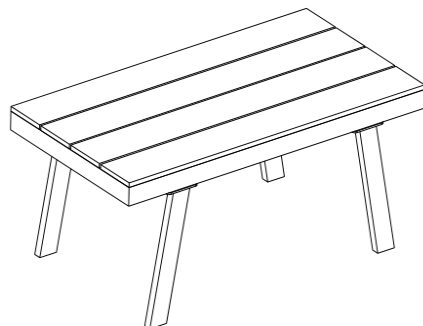
