



Do not assemble on flooring or carpet-




Assemble on a clean non-marring surface (packing foam)-




Save all packaging until finished-

Assembly Steps



This Table has multiple parts and may require up to 30 minutes to assemble. To giveyou an overview of the Table parts, the above picture is to help you put the variou sparts into perspective. Please read through the instructions below to familiariseyourself with the parts and steps before assembly.


Step 1



Open the carton and place all the parts onto a clean, non-marring surface. Attach the Top Panel(B) to Side Support Bar(A) using Bolts(1) with Allen Key(3) as shown above.

Do not fully tighten Bolts.


Step 2



Attach the Side Panel(C) to Side Support Bar(A) using Bolts(\bigcirc) with Allen Key(\bigcirc) as shown above.

Do not fully tighten Bolts.


Step 3



Attach the Horizontal Base Support Bar (D) to Side Support Bar(A) using Bolts(2) with Allen Key(3) as shown above.

Do not fully tighten Bolts.


Step 4



Attach the Side Support Bar(A) to Side Panel(C) and Top Panel(B) Horizontal Base Support Bar (D) using Bolts(1&2) with Allen Key(3) as shown above.

Do not fully tighten Bolts.

Step 5



Stand the Table up.Place the Table on a LEVEL SURFACE.

Inspect it and make sure all parts are adequately connected.

Gently and carefully, sit onto the Table.

This will help to align all parts at all the joints. Then get off the Table, and in a sequential manner, proceed to tighten all Bolts.

When tightening the Bolts, tighten sequentially.

DO NOT tighten any Bolt fully and then move on to the next one.

This may cause the frame to warp. If there are still wobbles, loosen the Bolts and execute the same process.

If the Table is not stable it could lead to damage to the product.

Your Table is ready for use.

This Table can only be used on a flat, level surface.

Care & Maintenance






Do not put hot items directly on furniture surface





Do not clean furniture with harsh cleansers or polish.

Do not write on furniture without a padded barrier to protect the surface.



To obtain the longest lifespan of your outdoor products, avoid extended and lengthy exposure to rain, snow, and direct sunshine. Whenever possible cover the product and /or place under patio or awnings.

What is Proposition 65?

Proposition 65 is a California law that requires warning labels on products that may contain one of more than 800-plus chemicals or ingredients that the California Office of Environmental Health Hazard Assessment (OEHHA) has deemed to cause cancer or other reproductive toxicity. Chemicals and elements on this list include wood dust, brass, and other everyday substances, which can be found in very common household items, such as: lamps, tableware, jewelry, crystal glasses, electric cords, beauty products, automobiles, and furniture.

Why Did I Find a Proposition 65 Warning on My Home Goods Product?

We include Proposition 65 warnings on all of our products because there is always a chance that one of the 800-plus common chemicals and ingredients listed under this law could potentially be on our furniture or packing materials. We risk large fines under this law, if we don't include this warning. Should I worry?

We realize you may be worried finding this warning on our products, but we want to reassure you that the hazardous exposure limits for any of these chemicals have never been found on furniture products that we've shipped to our customers. Additionally, this warning label is very common and can be found on almost every piece of furniture sold in the state of California.

Just How Common Are Proposition 65 Warnings?

Proposition 65 warnings have become so common in California that it is hard to take a trip to a local bank, grocery store, or restaurant without finding at least one warning. In fact, even the Disney Land Resort has a Proposition 65 warning:
