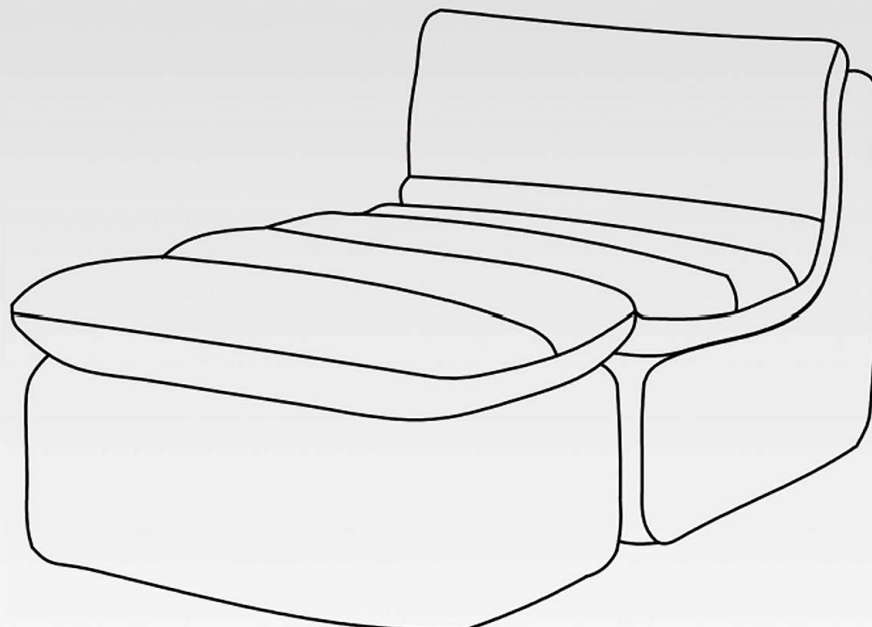

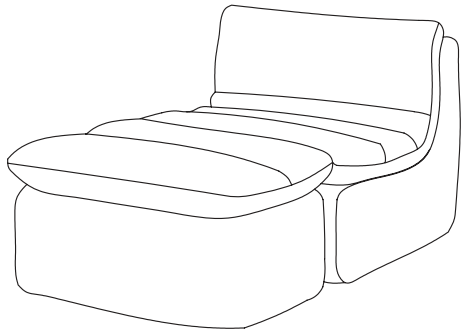

ASSEMBLY INSTRUCTIONS

This product does not necessitate manual installation. Upon unpacking, allow it to stand for 24 hours to ensure optimal functionality and readiness for use.



SAFETY INFORMATION

WEIGHT CAPACITY FOR PRODUCT: 300 LBS (≈136 KG)



Sit in the center of the chair with your back against the backrest



Do not sit at the front edge of the chair



Do not stand on the chair



Do not use the chair with more than one person

LIMITED WARRANTY

We promise to repair or replace any chair that is found to be defective in material or workmanship within one year from the date of original purchase, as long as you, the original purchaser, still own it. This is your sole and exclusive remedy under this warranty, subject to the provisions outlined below.

EXCLUSIONS

This warranty does not apply to, and no other warranty applies to:

- Normal wear and tear, which is to be expected over the course of ownership.
- Misuse, abuse, or excessive use of the product.
- Modifications or attachments to the product that are not approved.
- Products that were not installed, used, or maintained in accordance with the product instructions and warnings.
- Products used for rental purposes or unauthorized retail activities.

Seating Usage: Normal use for seating is defined as equivalent to a single shift, forty-hour (40) workweek. If the seating product is used in a manner exceeding this, the applicable warranty period will be proportionately reduced.

RETURN POLICY

We offer a 30-day return policy, meaning that all products purchased may be returned to us within that timeframe. You must contact us via email or customer service phone number within 30 days of receiving the product(s), and they must be returned to us without any undue delays.

CONDITIONS:

- Returned products must be in the same condition as received and returned in their original packaging.
- If the product is not faulty (i.e., if you change your mind or are unhappy with the product for another reason), you are responsible for the cost of return shipping. You must ensure the package arrives safely to us, so we recommend using a courier service that offers tracking.

- We reserve the right to offer partial refunds for returned products that are not in unused condition, are damaged, or have missing parts not due to our error.

HOW RETURNS WORK

We will provide the return address for the product as soon as possible. Once the returned product is received and inspected, we will provide a specific resolution.

If the return is approved, the refund amount will be automatically credited to your original payment method.
