HOW TO UNPACK YOUR MATTRESS

Step 1



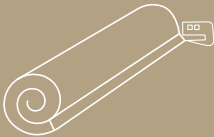
LAY DOWN THE PACKAGE IN YOUR BEDROOM AND OPEN IT WITH SCISSORS. PLEASE DO IT WITHIN 72 HOURS OF RECEIPT.

Step 2



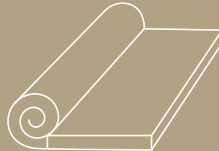
TAKE THE MATTRESS OUT OF THE BOX.

Step 3



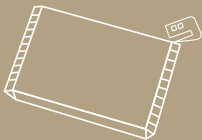
REMOVE THE MATTRESS FROM THE PLASTIC BAG. DO NOT USE KNIVES OR SCISSORS, SINCE THEY MIGHT DAMAGE YOUR BED.

Step 4



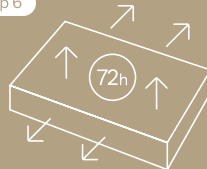
ROLL OUT THE COMPRESSED MATTRESS ONTO YOUR BED OR A CLEAN FLAT SURFACE.

Step 5



OPEN THE PLASTIC BAG ALONG THE EDGES CAREFULLY TO DECOMPRESS THE MATTRESS. REMOVE THE BAG.

Step 6



ALLOW UP TO 72 HOURS FOR THE BED TO FULLY RETURN TO ITS ORIGINAL SHAPE. ALSO LET IT AIR OUT IF THERE ARE ANY ODOORS.

It will run for 10 years from the date of purchase.

What's covered?

It covers any defects in materials or workmanship and applies only to the original purchaser.

- (1) Normal changes in softness or resilience
- (2) Normal impressions less than 1.5 inches in depth

- (4) Stains in use
- (5) Misuse or improper maintenance
- (6) Alteration or repair by unauthorized representatives
- (7) Damages resulting from transit or handling
