## DUST RECLAIMER SAFETY WARNINGS

1. Do not use with any openings blocked. Keep openings clear of anything that may limit air flow or hinder motor operation.
2. Do not use the Reclaimer without its filter in place. Before each use, make sure the filter is not clogged.
3. This product is designed only to pick up dry debris. Do not use the Dust Reclaimer to pick up water (or any other liquid) from the floor or containers such as sinks, tubs, barrels, etc.
4. Do not use for abrasives containing crystalline silica. Silica containing abrasives

have been linked to severe respiratory disease such as silicosis. Use proper abrasives such as aluminum oxide, glass bead, or walnut shell.

5. DO NOT OPERATE WITH ANY GUARD DISABLED, DAMAGED, OR REMOVED.

6. The use of accessories or attachments not recommended by the manufacturer may result in a risk of injury to persons.

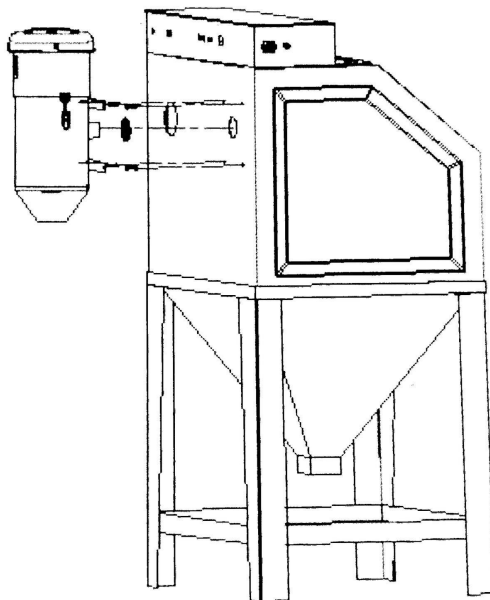
7. When servicing use only identical replacement parts.

8. Avoid unintentional starting. Prepare to begin work before turning on the tool.

## HOW TO INSTALL THE DUST RECLAIMER TO A BLAST CABINET

1. This dust reclaimer Kit is already assembled in the factory. But please check carefully about the situation of parts connection and screws.

2. Assemble the rubber sealing ring in the proper hole of sandblaster cabinet. Fix the dust reclaimer Kit well with matched screws.



## OPERATION INSTRUCTION

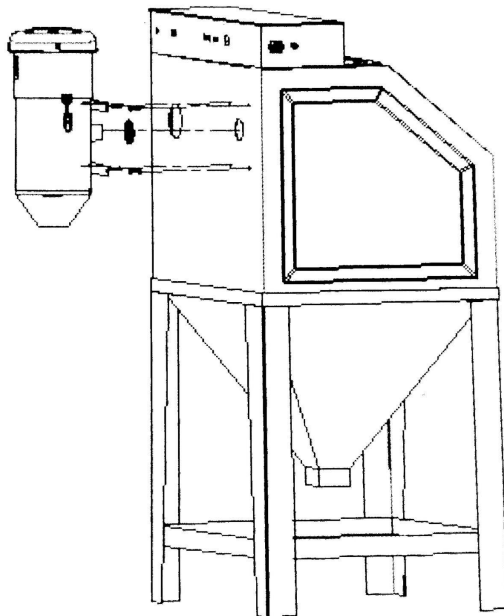
1. Connect with power. Press the switch the kit will start to work.

**Note:**The dust will be heaped up much in the fabric filter after some time usage that will cause the low efficiency of cleaning. Please pull the dust -off rod to flick dust from filter. If this operation does not work, the dust container? may be full, please empty it.

2. Open the lock in the bottom to empty the dust. If it is needed to clean fully, open the two locks in the middle to separate the dust container.

3. There is one metal spare plate for extra usage. This dust reclaimer Kit can be used in other sandblaster cabinets too. Making the holes with spare plate in the machine, assemble the rubber sealing ring and kit into the air outlet. Fix the kit and spare plate with screws. If combine with original cabinet, this spare plate is no necessary.

4. To prevent accidents, turn off the tool and disconnect its power supply after use.



## TROUBLESHOOTING

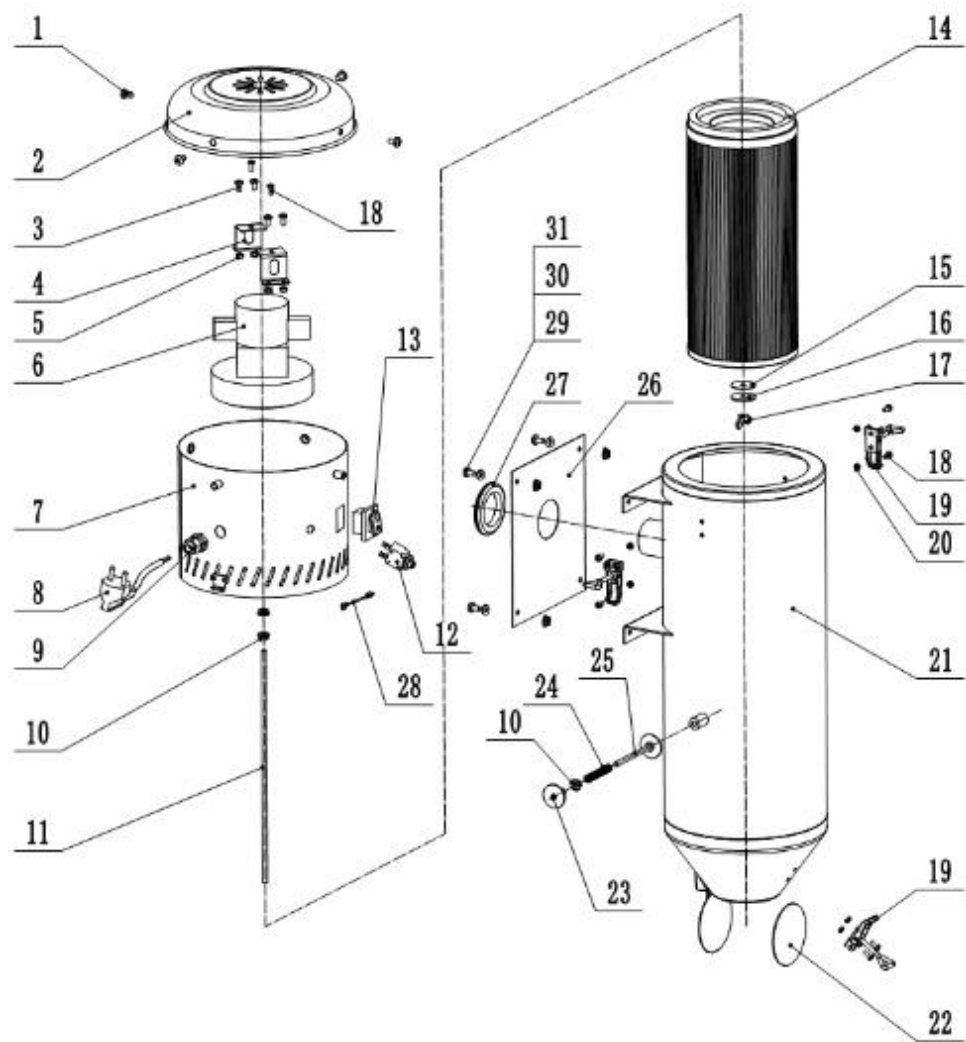
Problem	Possible Solutions
Dust reclaimer does not turn on.	<ol style="list-style-type: none"><li>1. Make sure the Power Switch on is in its "ON" position.</li><li>2. Make sure the Power Cord Plug of the dust reclaimer is properly connected to a working volt, grounded, electrical outlet.</li><li>3. Have a qualified service technician check out the Dust reclaimer and Blast Cabinet.</li></ol>
Poor visibility within the Blast Cabinet.	<ol style="list-style-type: none"><li>1. Check to make sure dust reclaimer is on.</li><li>2. Dust reclaimer is filled. Empty and clean out Dust reclaimer.</li><li>3. Filter in dust reclaimer needs to be cleaned or replaced.</li><li>4. Have a qualified service technician check out the dust reclaimer and Blast Cabinet.</li></ol>
