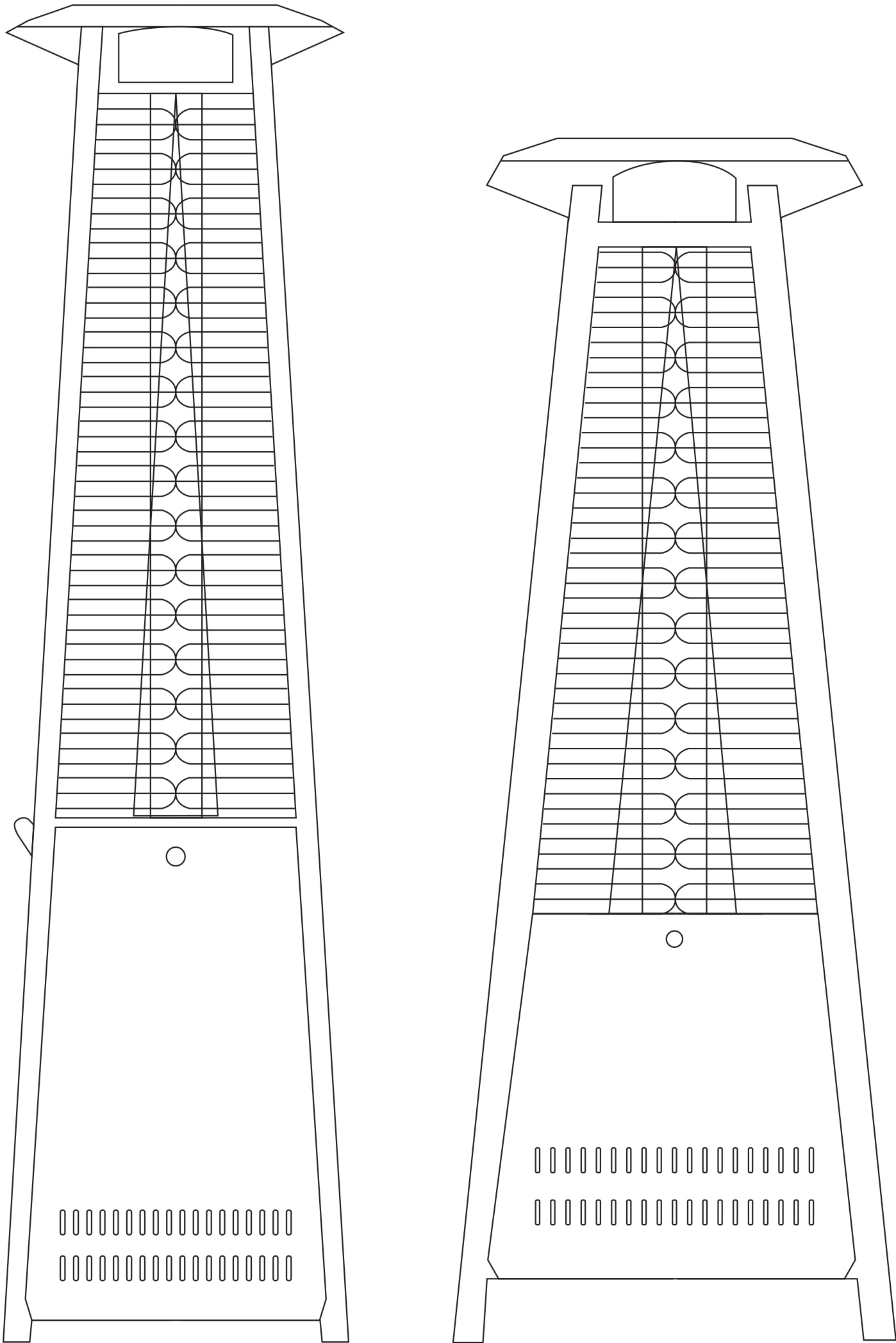

If your Lava Heat Italia® frame fails structurally during normal usage within five years, Lava Heat Italia® will repair or replace the outdoor heater frame at manufacturer's discretion (with same or similar product if discontinued) at no charge (shipping cost excluded). If the finish peels, cracks or blisters within five years, Lava Heat Italia® will repair, refinish or replace the frame at manufacturer's discretion (with same or similar product if discontinued) at no charge (shipping cost excluded). From time to time there may be minor variations in color and texture of finishes.

The warranty covers against discoloration for three years from the date of purchase.
