Assembly Steps




This Chair has multiple parts and may require up to 30 minutes to assemble. To give you an overview of the Chair parts, the above picture is to help you put the various parts into perspective. Please read through the instructions below to familiarise yourself with the parts and steps before assembly



- 1.1) Align the Seat(B) with Backrest(A) as shown above.
- **1.2)** Attach Seat(B) to Backrest(A) using Bolts(①), Spring Washers(④), and Washers(⑤) with Allen Key(⑥) as pictured above.
- **1.3)** Attach Seat(B) to Backrest(A) using Bolts(③), Spring Washers(④), and Washers(⑤) with Allen Key(⑥) as shown above.

^IDo not fully tighten the Bolts.


Step 2



Attach Front Legs(C) to Seat(B) using Bolts(2), Spring Washers(4), and Washers(5) with Allen Key(6) as pictured above.

Do not fully tighten the Bolts.

Step 3



Place the Chair on a LEVEL SURFACE to see if it wobbles.

If it wobbles, lift the Chair some 30cm to 50cm high from the ground.

Keep your feet and toes well away from the drop zone.

Drop the Chair freely and vertically with the four legs, hitting the ground, at the same time.

This Drop Test will help to ensure that all the Bolts and gaps reach full alignment status.

Test again for evenness on a LEVEL SURFACE.

If no wobbles are found, proceed to tighten all the Bolts.

When tightening the Bolts, tighten sequentially.

DO NOT tighten any Bolt fully and then move on to the next one.

This may cause the frame to warp.

If there are still wobbles, loosen the Bolts and execute the same drop test.

If the Chair is not stable it could lead to damage to the product.

Step 4

Inspect and make sure all parts are connected. Your Chair is ready for use.

This Chair can only be used on a flat, level surface.

Care & Maintenance

Do not put hot items directly on furniture surface

Do not clean furniture with harsh cleansers or polish.

Do not place furniture under direct sunlight.

Do not place furniture near heating or cooling vents.

Do not write on furniture without a padded barrier to protect the surface.

Stains may be removed with mild soap solution and damp cloth.

What is Proposition 65?

Proposition 65 is a California law that requires warning labels on products that may contain one of more than 800-plus chemicals or ingredients that the California Office of Environmental Health Hazard Assessment (OEHHA) has deemed to cause cancer or other reproductive toxicity. Chemicals and elements on this list include wood dust, brass, and other everyday substances, which can be found in very common household items, such as: lamps, tableware, jewelry, crystal glasses, electric cords, beauty products, automobiles, and furniture.

Why Did I Find a Proposition 65 Warning on My Home Goods Product?

We risk large fines under this law, if we don't include this warning. Should I worry?

Additionally, this warning label is very common and can be found on almost every piece of furniture sold in the state of California.
