MEASUREMENTS:

The customer is responsible for the accuracy of all measurements supplied to YUDEZIGN. YUDEZIGN accepts no responsibility or liability for measurement errors. The customer is responsible for the final design approval.

PRICES:

All prices presented to the customer are subject to change until an order is placed with the manufacturer or vendor.

DEPOSITS:

Because all projects are 100% make to order and customized, we require customer to pay in full of the original signed sales contract.

DELIVERY LEAD TIMES:

All delivery times are estimates; YUDEZIGN cannot guarantee specific deadlines and recommends that the customer not schedule installation until the customer receives product.

COMMON CARRIER DELIVERY:

YUDEZIGN contracts delivery services through common carriers. YUDEZIGN does not direct or control the operations of the Common Carriers. Each Carrier sets and executes its own policies and practices. Unless otherwise specified in writing on the Proposal, all deliveries of goods will be made to the customer's garage. In the event there is no garage, delivery shall be made to the most accessible area of the project site as determined at the sole discretion of YUDEZIGN.

INSPECTION:

Cabinets are delivered unassembled or assembled. Claims for shortages or damages must be made upon receipt. The customer is responsible for final inspection. Concealed damage claims (damage found after unpacking) must be made within 7 days of receipt of product. Do not install damaged or defective product. Assembly or modification of the products may void claims for damage. To file a claim please send an email to <u>orders@yudezign.com</u>.

INSTALLATION SERVICES:

CUSTOMER ACKNOWLEDGES THAT YUDEZIGN DOES NOT MANAGE OR PERFORM INSTALLATION SERVICES. YUDEZIGN makes no, and herby disclaims, all warranties and assumes no liability for work performed by an independent contractor performing installation services. Customer hereby acknowledges and agrees to hold YUDEZIGN harmless for all damages, losses, injuries, or any other defects or loss of use resulting from installation of goods.

RETURNS:

- All returns must be authorized by YuDezign prior to return shipment.
- For authorization, please send an email request to <u>orders@yudezign.com</u>.
- Returns must be received by YuDezign within 14 days of purchase.
- All items must be returned in original, unopened packaging, therefore NO RETURNS ON CUSTOMIZED CABINET AND ASSEMBLED CABINETS.
- No returns on trims, moldings, fillers, panels, or sales tools.
- Qualifying returns will incur a 25% RESTOCKING FEE.
- The customer is responsible for setting up all return shipments.
- Any returned product DEEMED UNSELLABLE WILL NOT RECEIVE CREDIT.

CANCELLATIONS:

Each order for custom is totally customized so it may not be cancelled or returned (unless the manufacturer approves the return) for any reason after YUDEZIGN has placed the order with the manufacturer. Special packing or handling requests by customer shall be at customer's expense.

PAYMENTS & REFUNDS:

- Once the order is in process, no changes can be made. Additional items can be processed as a new order.
- Cancellations after the order is packed will be subject to a 10% processing fee.

- Rush is unavailable for assembly orders and discontinued lines.

DELIVERY:

- Expedited shipping service is NOT available for replacements and/or parts.
- All replacement is default as pick-up only. Freight charge is additional cost.
- All damages must be documented and reported upon opening the boxes. Items that have been assembled or installed cannot be claimed as damage.
- YuDezign cannot be held responsible for any labor costs accrued during the installation of any of its products sold via any of its channels of distribution. This includes, but is not limited to, items that may be flawed or have become damaged in transit.

One Year Limited Warranty Statement

Yudezign extends the following limited warranty on all cabinets manufactured and sold by YUDEZIGN within the United States. This warranty does not cover cabinets sold or shipped outside of the United States. This Limited Warranty is only applicable to Products sold to the original purchasing consumer. YUDEZIGN warrants that all cabinets purchased from YUDEZIGN will be free from all unnatural defects in material and workmanship in accordance with YUDEZIGN quality standards sheet under normal residential use for 1 years from the date of the original purchase or if the original purchasing consumer owns the home in which such cabinets are installed, whichever is less. This warranty is non-transferable to subsequent owners of the home. Door hinges and all drawers glide system, including system hardware (lift system), however are warranted for only 1 year under normal residential use from the date of the original purchase.

This limited warranty is subject to all limitations, exclusions, disclaimers, and procedures set forth herein.

- The warranty does not cover defects caused by improper handling, storage, dirt, chemicals, abrasive or citrus cleaning products, installation, assembly or disassembly, transit or other intentional or negligent damage, product modifications, exposure to the extreme moisture, humidity or excessive heat or cold (temperature outside the range of 50-85°F and humidity outside the range of 30-55% are considered extreme), nor does it cover defects arising from normal wear and tear, misuse, neglect, accidents, alterations, improper use, exposure to improper loads, or failure to maintain properly. Any modification to the hardware structure or finish of the original consumer purchaser's cabinetry by anyone other than those specifically authorized by YUDEZIGN to do so shall void this limited liability warranty. The product must be used exclusively for its intended purpose to be covered by this limited liability warranty. This limited liability warranty shall become void if the cabinets or any components or parts thereof are in any way modified, improperly installed or damaged prior to or during installation, or installed or used in other than normal residential applications.
- Natural woods may vary in color, grain pattern, and characteristics and exhibit subtle changes as they age. Wood characteristics that naturally occur, such as variations in color, grain, mineral streaks, and knots, are not considered defects. YUDEZIGN will not be held responsible for these variations in your cabinetry. For example, painted doors, drawer fronts, and face frames may eventually have visible cracking around the joint area, and cabinet colors may darken or lighten over time. These conditions are considered a normal occurrence and are not included or covered by this limited liability warranty. A glazed finish by character is an uneven finish. Some edges and profiles will have heavier hanged up than others and glazing may vary cabinet to cabinet, door to drawer and item to item. This may result in overall color variations but is not considered a defect. UV light, Sunlight, smoke, household cleaners, and other environmental conditions may also affect the color and integrity of the Product's finish or appearance over time. These variations are the nature of the material in relation to their environmental exposure and are not considered defects in material or workmanship and are not covered under this Limited Warranty.
- Mitered door joints are likely to react to conditions of their environment. Gaps that may develop in door joints due to
 conditions of their environment are not included or covered by this limited liability warranty. This limited liability
 warranty does not cover or apply to hairline cracks of cabinetry; hairline cracks are unavoidable in wood cabinets given
 the nature of the material.

- Wood is wood and expansion and contraction still happen year after year as it compensates and adjusts to ever changing atmospheric humidity and temperature conditions. Observing shrink, expansion on center panels of doors is very common. It will return to its natural position within couple months once it has adjusted to seasonal changes. For the same reason, all door warpage greater than ½" will be warranted. Please remove all doors and check them on a flat surface for the above stated warpage before requesting replacement.
- Warranty Performance. YUDEZIGN periodically updates and makes changes to its product line and specifications. If a warranty claim is filed during the warranty period against obsolete or changed product and repair is not possible, YUDEZIGN will, at its sole option, repair or replace the part under warranty with a new part of the same style or with a similar style currently offered and does not include or cover any other costs, including but not limited to any costs of service, labor, shipment, transportation, removal or installation related to the repair or replacement. YUDEZIGN is not responsible for a replacement product that may not match the installed product exactly. If a manufacturing defect occurs within this limited liability warranty terms and conditions and YUDEZIGN determines to replace the defective cabinet or component or part thereof, YUDEZIGN will ship the replacement cabinet or component or part thereof to the original consumer purchaser via ground shipper or freight carrier, at YUDEZIGN's sole discretion.
