

DRAFTING CHAIR

OPERATING INSTRUCTIONS



FEATURE

• PNEUMATIC SEAT HEIGHT ADJUSTMENT

To raise seat remove pressure from seat and pull lever (1) up. To lower seat height sit on chair and pull lever (1) up.

NOTE: It is normal for chair to slightly lower under body weight.

• DUAL FUNCTION CONTROL

To adjust seat tilt, lift lever (2). Leave lever up for free float or push lever down to lock at any angle. To adjust Back angle lift lever (3). Leave lever up for free float or push lever down to lock.

• FOOTRING HEIGHT ADJUSTMENT

To adjust footring height, loosen knob (4) adjust footring to desired height, and tighten knob (4) completely to secure footring into position.

WARNING

1. Use this product only one person at a time.
2. Do not use this chair unless all bolts screws and knobs are securely tightened.
3. Check that all bolts screws and knobs are tight every three months or as needed.
4. Dispose of packing material properly. Do not use plastic cover as head covering. It may cause suffocation.
5. Do not use chair as a stepladder.
6. Use this chair for its intended purpose only.
7. Use mild detergent only for cleaning.

LIMITED WARRANTY

Chairs are warranted from the date of purchase against failure due to material and workmanship as follows:*

- Lifetime on component parts including pneumatic cylinder, control mechanism, base and casters.
- 3 Years on upholstery fabric and foam against wear and deterioration.
- Leather is not warranted against routine scratching and scuffing, as leather is subject to minor blemishes in use.

**All warranties are limited to the original purchaser for normal commercial usage defined as a standard forty hour work week by persons weighing 250 lbs. or less. This warranty will not cover labor, freight or damage from misuse, abuse, negligence, alteration, accident, vandalism, rusting, acts of nature or any other event beyond the control of us. The warranty does not cover cosmetic damage that may result from normal use. Liability for incidental or consequential damages is excluded. The user assumes all risk of injury resulting from use of this product. When usage is more than 40 hours per week, a five year warranty on all parts applies. Fabric is warranted for one year.*

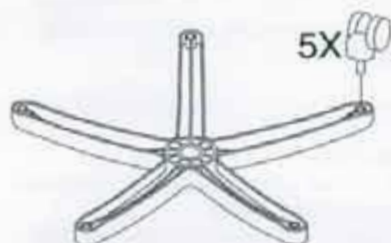
This warranty gives you specific legal rights, and you may also have other rights which vary from state to state.

It is the customer's responsibility to prepay freight on any components returned to the factory. Return freight on components covered by warranty will be paid by us.

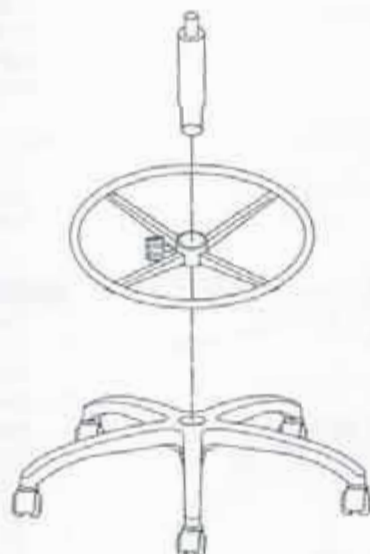
ASSEMBLY INSTRUCTIONS



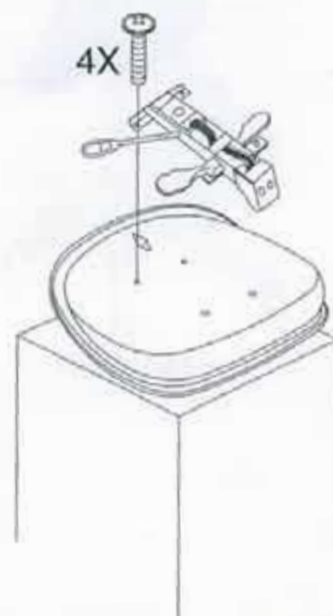
Insert Carpet Casters into Base. Be sure all Carpet Casters are inserted properly. Place Base upright so that all Carpet Casters rest evenly on a level surface.



Slide Pneumatic Cylinder through Footring and into Base.

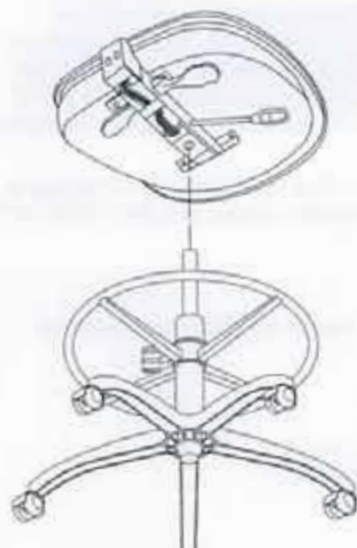


Attach Seat Plate to Seat Cushion using four Seat Plate Screws.

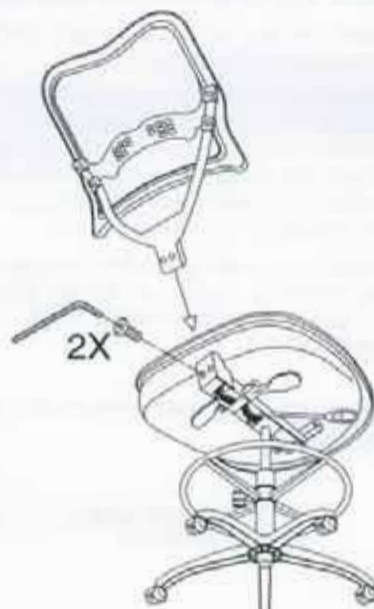


FULLY TIGHTEN ALL SCREWS.

Insert Cylinder into Base. Place Assembled Seat on top of Cylinder. Apply downward pressure to lock Seat in place.



Insert Back Support into Seat Plate and using Two Short Allen Screws.



ATTENTION: MAKE SURE ALL SCREWS ARE FULLY TIGHTENED BEFORE USING CHAIR. CHECK THAT ALL SCREWS ARE TIGHT EVERY THREE MONTHS OR AS
