

FIVE YEAR LIMITED WARRANTY
(Commercial Products Only)

If, within five (5) years from the date of purchase, any Commercial Product fails due to a defect in material or workmanship, Gama Sonic USA, Inc. will repair or replace it, at its discretion, free of charge. This Limited Warranty applies only to the original purchaser and is not transferable. Gama Sonic USA, Inc. has no obligation with respect to any warranty claims received by it after midnight on the date that is the five-year anniversary of the date of purchase, or after thirty (30) days from the date the warranty claim arises.

Any product that is not so identified as a commercial product shall be sold with Gama Sonic USA, Inc.'s standard Two Year Limited Warranty.

WILL NOT BE LIABLE FOR: (i) MORE THAN THE PRICE PAID FOR THE PRODUCT; OR (ii) INDIRECT, INCIDENTAL, SPECIAL, CONSEQUENTIAL, PUNITIVE, LOSS OF USE OR LOST PROFIT DAMAGES, EVEN IF GIVEN ADVANCE NOTICE OF THE POSSIBILITY OF SUCH DAMAGES. SOME STATES DO NOT ALLOW THE EXCLUSION OR LIMITATION OF DAMAGES, SO THE ABOVE LIMITATIONS OR EXCLUSION MAY NOT APPLY TO YOU.***

THIS WARRANTY IS IN LIEU OF ALL OTHER EXPRESS OR IMPLIED WARRANTIES. Notice of a warranty claim must be submitted within thirty (30) days of the date the claim arises.
