# **Limited Warranty**

The warranty obligations for this product are limited to the terms set forth below:

### What is Covered

- 1. All our products come with a one-year limited warranty.
- 2. Should the product contain manufacturer defects or if it does not work upon arrival, this warranty covers a max of two replacements within one year from the date you received your order.
- 3. We will only honor warranty claims of purchases made from authorized dealers. Only the original purchaser of this product is covered under this limited warranty. This limited warranty is not transferable to subsequent purchasers or owners of this product.
- 4. Proof of purchase is required.

### What is Not Covered

- 1. This limited warranty does not cover any shipping damage, lost in transit, or any misshipped items reported passed 30 days of delivery.
- 2. This limited warranty does not cover any damage, deterioration, or malfunction resulting from any alteration, modification, improper or unreasonable use or maintenance, misuse, abuse, accident, neglect, exposure to excess moisture, fire, improper packing, and shipping (such claims must be presented to the carrier), or other acts of nature.
