- Wipe area with a clean cloth dampened in water.
- Ensure that all of the soap residue has been removed.

- Limpie el área con un paño limpio humedecido en agua. Asegúrese de que los restos de jabón hayan sido eliminados.




INSTRUCTIONS DE NETTOYAGE

- Mouillez légèrement un tissu avec le mélange et essuyez doucement la zone sale. Évitez de frotter la zone à nettoyer de manière forte.
- Essuyez la zone avec un tissu propre imbibé d'eau. Assurez-vous d'enlever tous les résidus de savon.









STEP 1




Lay part(B) upside down. Attach part(G) to all the legs part (E) and Part (F). Attach the legs part (E) to the front of the chair. Attach the legs part (F) to the rear of the chair. Place chair upwards on its feet.

Coloque la pieza (B) boca abajo. Una la pieza (G) a todas las patas (E) y (F). Coloque las patas (E) en la pieza delantera de la silla. Coloque las patas (F) en la pieza trasera de la silla. Coloque la silla hacia arriba sobre sus patas.

Posez la pièce (B) sens dessus dessous. Raccordez la pièce (G) à tous les pieds pièce (E) et pièce (F). Raccordez les pieds pièce (E) à l'avant du fauteuil. Raccordez les pieds pièce (F) à l'arrière du fauteuil. Placez le fauteuil vers l'avant sur ses pieds.


STEP 2



Slide slots on Part (A) into the tabs on Part (B) as shown using them to firmly secure part (A) in place.



