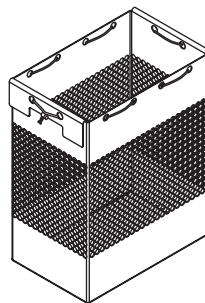

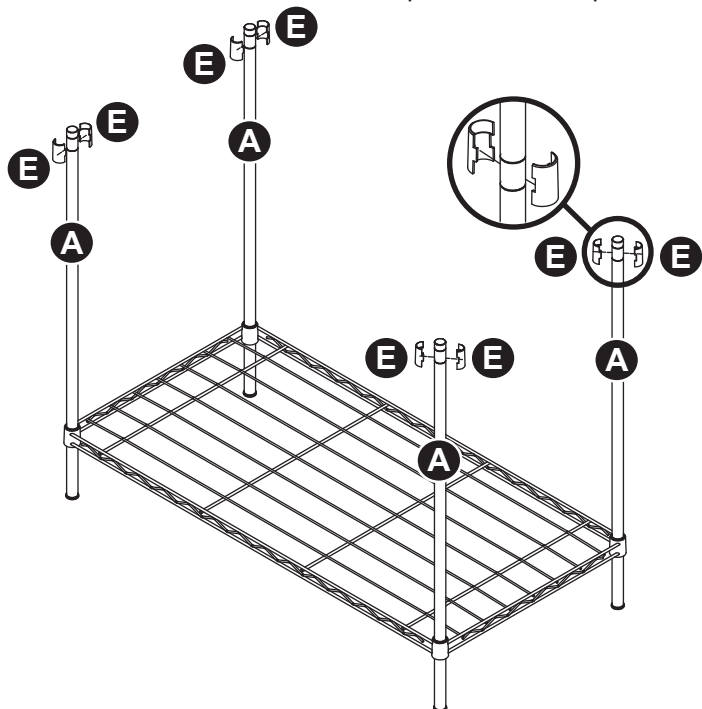
STEP 1. Snap two sleeves (E) at the bottom end of pole (A) at the location of the bottom shelf. Repeat for all four poles.



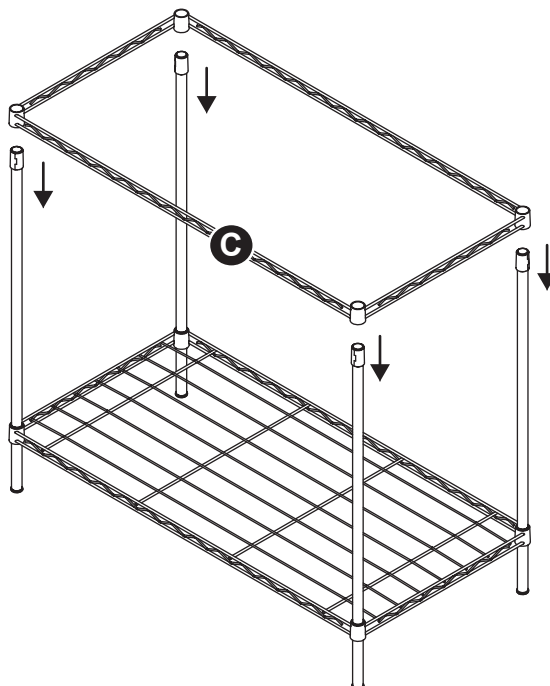
STEP 2. Slide the shelf (B) over the poles and down. Secure each corner onto the sleeves.



STEP 3. Snap two sleeves (E) at the top end of pole (A) at the location of the frame. Repeat for all four poles.

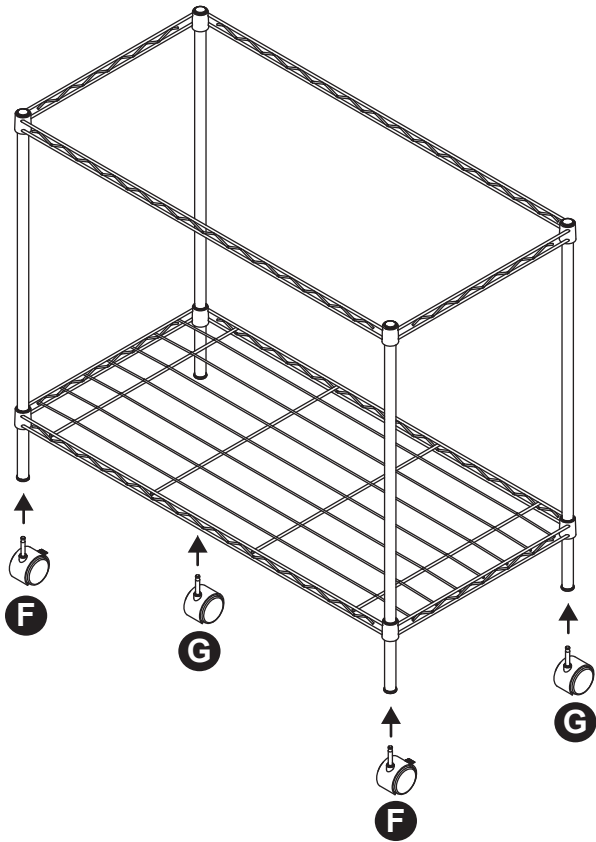


STEP 4. Slide the frame (C) over the sleeves on the end of the poles. Secure each corner onto the sleeves.

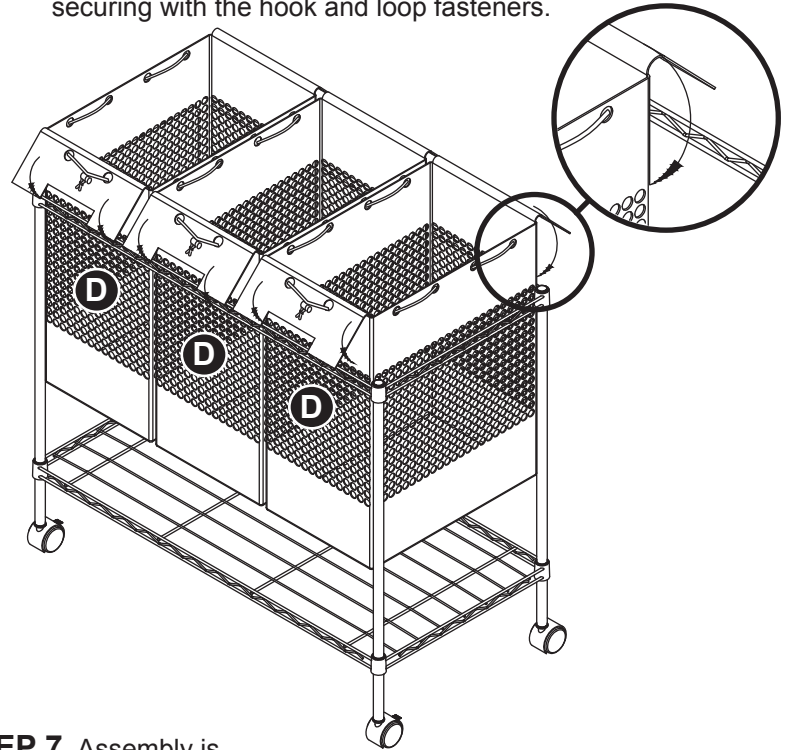

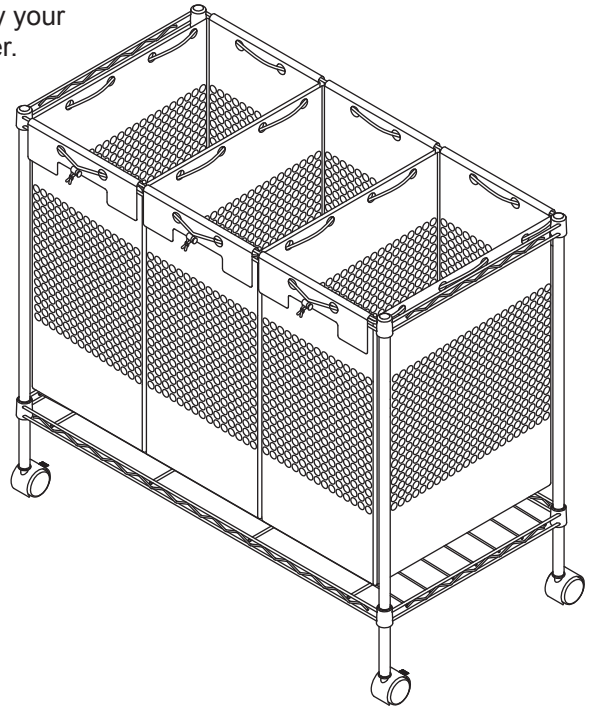
STEP 5. Install the wheels (E & F) into the bottom of the poles (A).



STEP 6. Install the laundry bags (D) over the frame by lifting the flaps on the laundry bags and securing with the hook and loop fasteners.
