Please pass the light strip through the holes in sequence as shown in the diagram and exit from the holes in the rear panel.

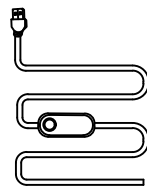
Please note that the adhesive surface should be attached to the inner winding surface for optimal use.
