
Assembly Instructions

CAUTION: This Sofa is NOT a TOY.


Keep your child / children at bay during the assembly process.

Whenever lifting/moving the Sofa and to prevent damage to the Sofa, two adults are needed to execute these actions.

Assembly Preparation

Before Beginning Assembly:





- Read instructions, cover to cover-
- Have 2 adults on hand for assembly-




Do not assemble on flooring or carpet-






Save all packaging until finished-


Assembly Steps



This Sofa has multiple parts and may require up to 30 minutes to assemble. To give you an overview of the Sofa parts, the above picture is to help you put the various parts into perspective. Please read through the instructions below to familiarise yourself with the parts and steps before assembly.



Unpack and place all parts on a clean, non-marring surface.




2.1) Place the Seat with Foldable Legs (A) facedown, on to a clean, non-marring surface. Lift Legs upwards and outwards until they lock into the Braces, as shown above.


2.2) Affix the Leg to the Brace using Bolt (2) and two Washers (3) with Allen Key (1), as described in the above picture.

Repeat the same process with the remained Legs.

Do not fully tighten the Bolts.




Insert the Back Cushions (B) and Arm Cushions (C) into the Seat Panel with Foldable Legs (A) into the correct positions as depicted above.



With assistance from your adult partner, turn the Sofa as pictured above and then, attach Back Cushions (B) and Arm Cushions (C) to Seat Panel with Foldable Legs (A) by using Washers (\Im) and Lock Nuts (\Im) with Spanner (\Im).

Do not fully tighten the Nuts.



Inspect the Sofa and make sure all parts are connected.

Gently and gracefully, sit into to the Sofa.

This would help to align all the parts at all the joint areas.

Then get off the Sofa, and in a sequential manner, proceed to tighten all Bolts and Nuts.

Then proceed to tighten all Bolts and Nuts in a sequential manner.

Whenever moving or lifting the table be sure to secure assistance from your adult partner(s). When tightening the Bolts and Nuts, tighten sequentially.

DO NOT tighten any Bolt or Nut fully and then move on towards the next one.

If there are still wobbles, loosen the Bolts and Nuts and execute this same process.

Your Sofa is ready for use.

This Sofa can only be used on a flat, level surface.

Care & Maintenance

- Do not put hot items directly on furniture surface.
- Do not clean furniture with harsh cleansers or polish.
- _ To obtain the longest lifespan of your outdoor prodcts, minimizing exposure to direct sunlight is recommended.
- Children should not climb or jump on the furniture.
- Do not write on furniture without a padded barrier to protect the surface.
- To obtain the longest lifespan of your outdoor products, avoid extended and lengthy exposure to rain, snow, and direct sunshine. Whenever possible cover the product and for place under patio or awnings.
- Not for commercial use. For residential use only.
- Stains may be removed with mild soap solution and damp cloth.
- Dust and pick-up spills using a clean, non-colored, lint-free cloth.

Questions & Answers about Proposition 65

What is Proposition 65?

Proposition 65 requires businesses to provide warnings to Californians about significant exposures to chemicals that cause cancer, birth defects or other reproductive harm. These chemicals can be in the products that Californians purchase, in their homes or workplaces, or that are released into the environment. By requiring that this information be provided, Proposition 65 enables Californians to make informed decisions about their exposures to these chemicals.

Proposition 65 also prohibits California businesses from knowingly discharging significant amounts of listed chemicals into sources of drinking water.

Proposition 65 requires California to publish a list of chemicals known to cause cancer, birth defects or other reproductive harm. This list, which must be updated at least once a year, has grown to include approximately 900 chemicals since it was first published in 1987.

What types of chemicals are on the Proposition 65 list?

The list contains a wide range of naturally occurring and synthetic chemicals that include additives or ingredients in pesticides, common household products, food, drugs, dves, or solvents. Listed chemicals may also be used in manufacturing and construction, or they may be byproducts of chemical processes, such as motor vehicle exhaust.

What does a warning mean?

If a warning is placed on a product label or posted or distributed at a workplace, a business, or in rental housing, the business issuing the warning is aware or believes that it is exposing individuals to one or more listed chemicals.

By law, a warning must be given for listed chemicals unless the exposure is low enough to pose no significant risk of cancer or is significantly below levels observed to cause birth defects or other reproductive harm.
