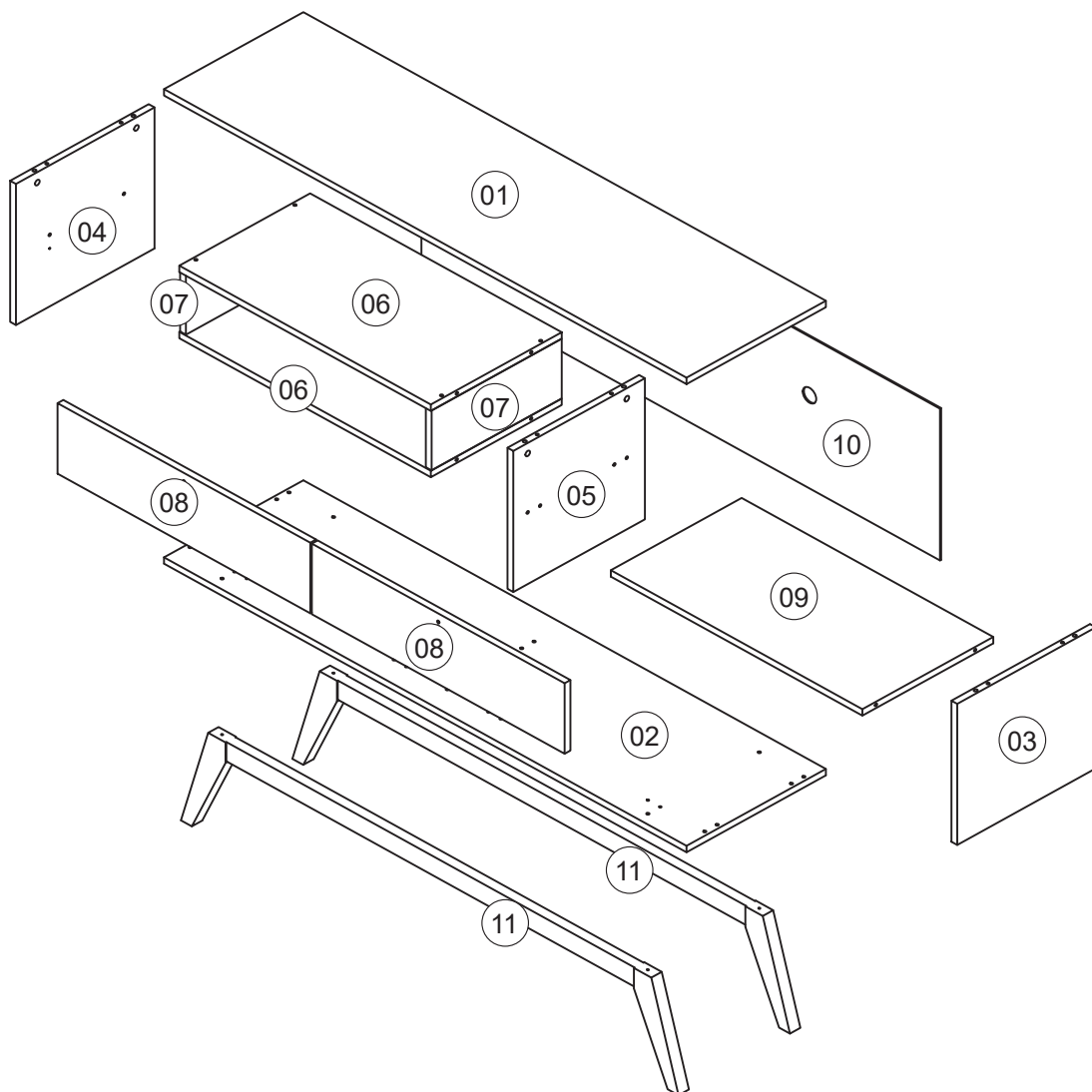
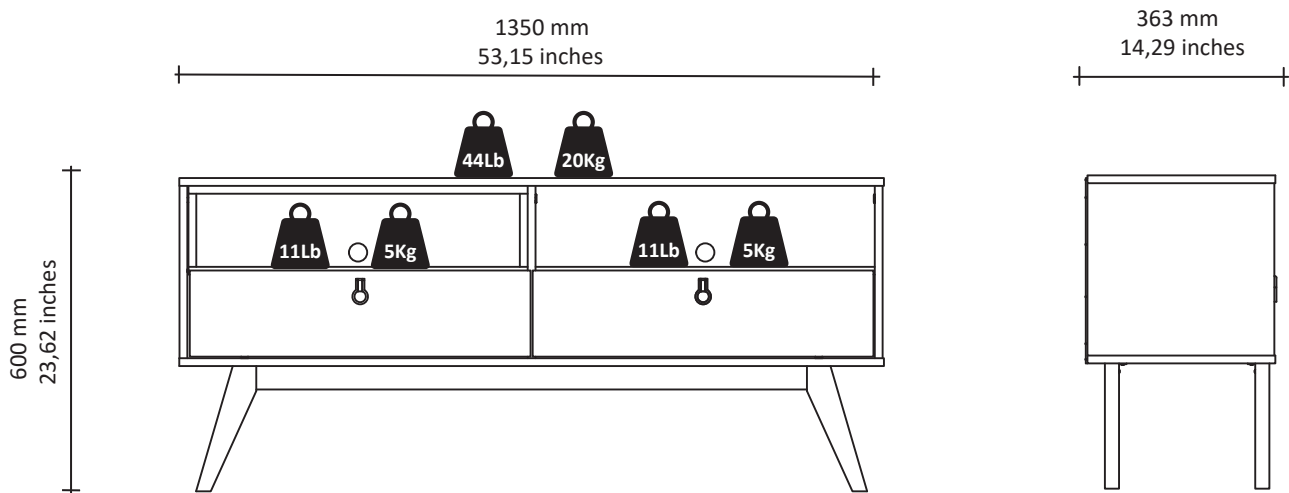
GENERAL SAFETY INFORMATION

1. Please read the Assembly Instructions prior to assembling this product.
2. Remove all the hardware from the box and sort by type.
3. Check to see that all the hardware and parts are present BEFORE assembling.
4. To avoid damage, assemble the product on a sturdy, level and protective surface.
5. Please wait until all steps are completed before fully tightening bolts.
6. Make Sure all bolts are tightly fastened before the unit is used.
7. To move the product, you must lift it. DO NOT drag it, if you drag it can cause overturning.
8. **This product is sold with a hardware kit to be fixed on the wall. You must install this kit to prevent any accidents or damages. When properly installed, this restrain can provide protection against the unexpected tipping of the unit due to small tremors, bumps or climbing. The restrain is only a deterrent and is not a substitute for proper adult supervision. Use of tip-over restraints may only reduce, but not eliminate, the risk of tip-over.**

INFORMACIÓN GENERAL DE SEGURIDAD

3. As the exclusive remedy under this Warranty, We will (at its sole option) repair, replace or refund the value of any defective furniture component. We may require independent confirmation of the claimed defect and proof of purchase. Replacement parts will be warranted for only the remaining period of the original Warranty.
