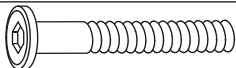
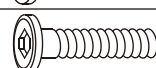
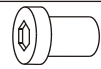
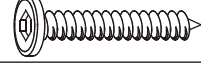
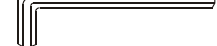
CAUTION : This Table is NOT a TOY. Keep your child / children at bay in the process of assembly.

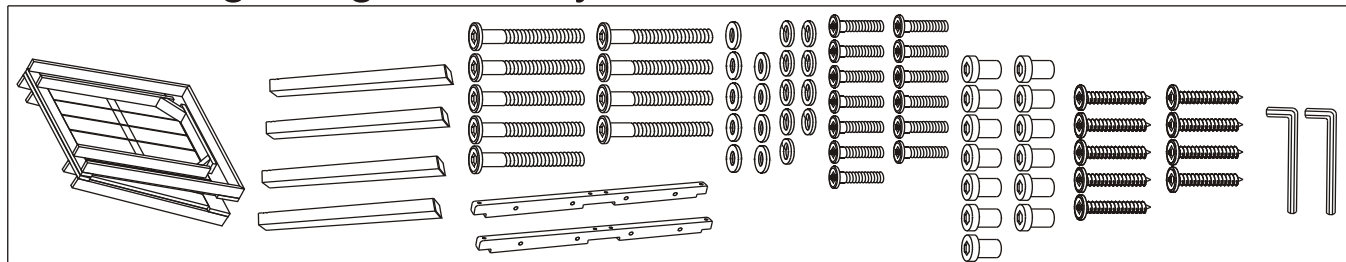

☒ Do not assemble on flooring or carpet.



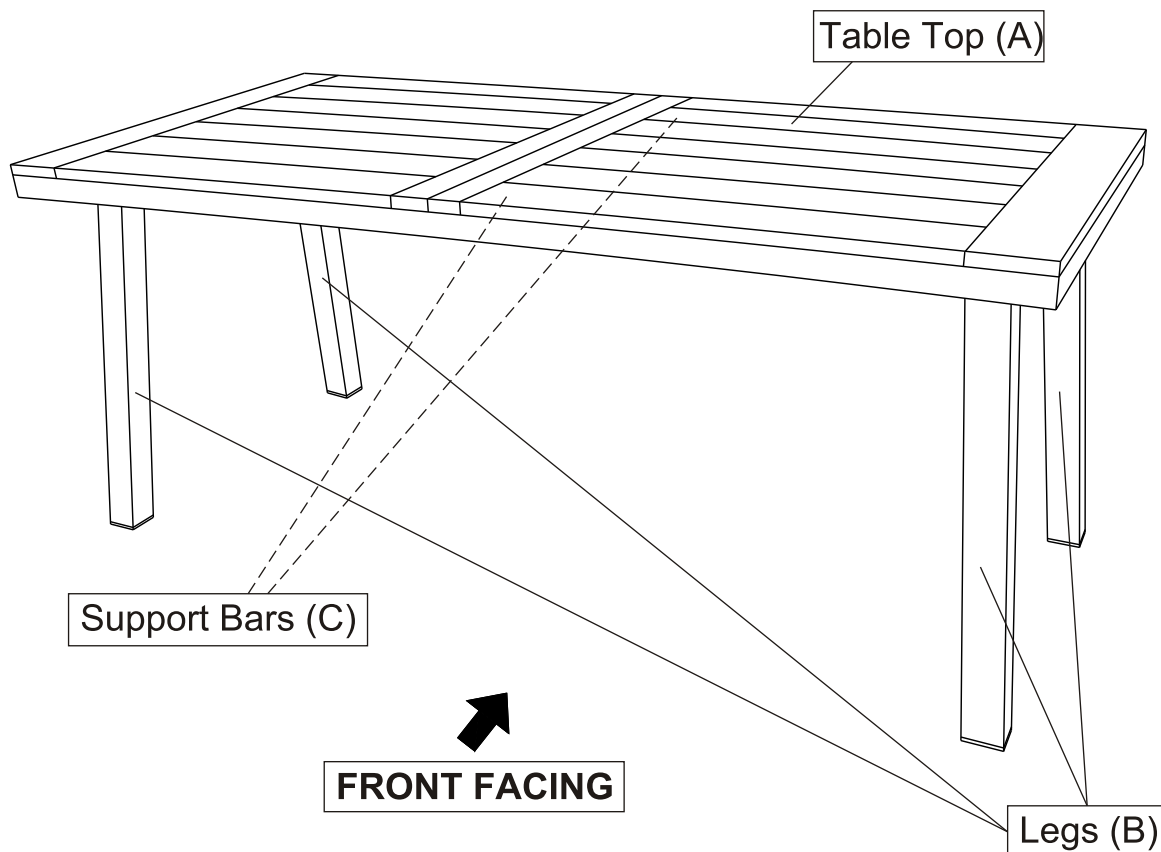
☒ Assemble on a clean non-marring surface (packing foam).



☒ Save all packaging until finished.

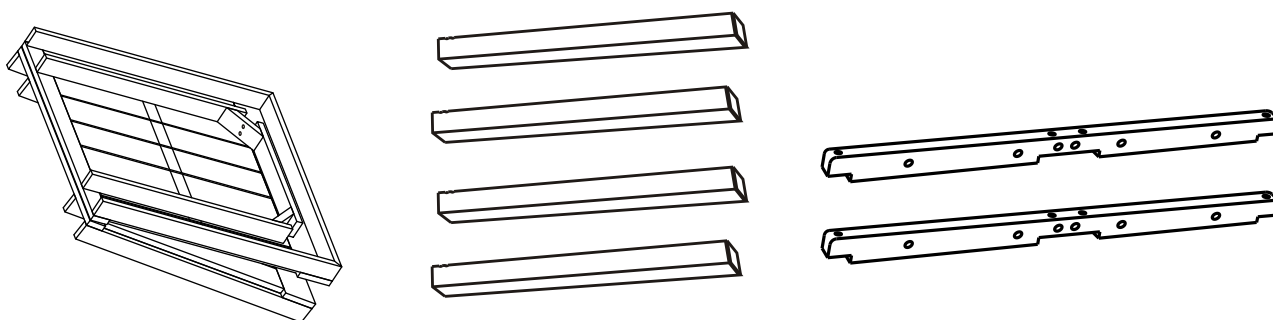
Assembly Steps

OVERVIEW



This Table has multiple parts and may require up to 30 minutes to assemble. To give you an overview of the Table parts, the above picture is to help you put the various parts into perspective. Please read through the instructions herebelow to familiarise the parts and steps before assembly.

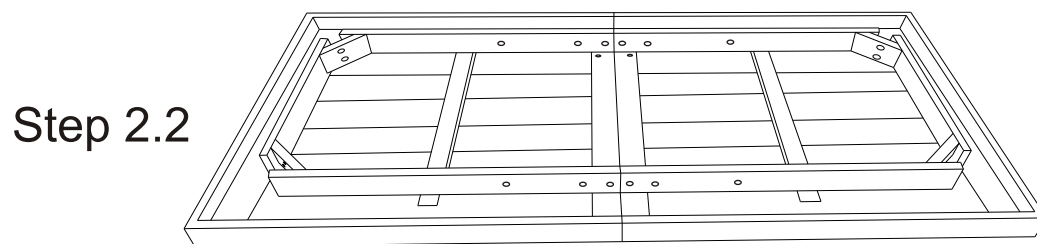
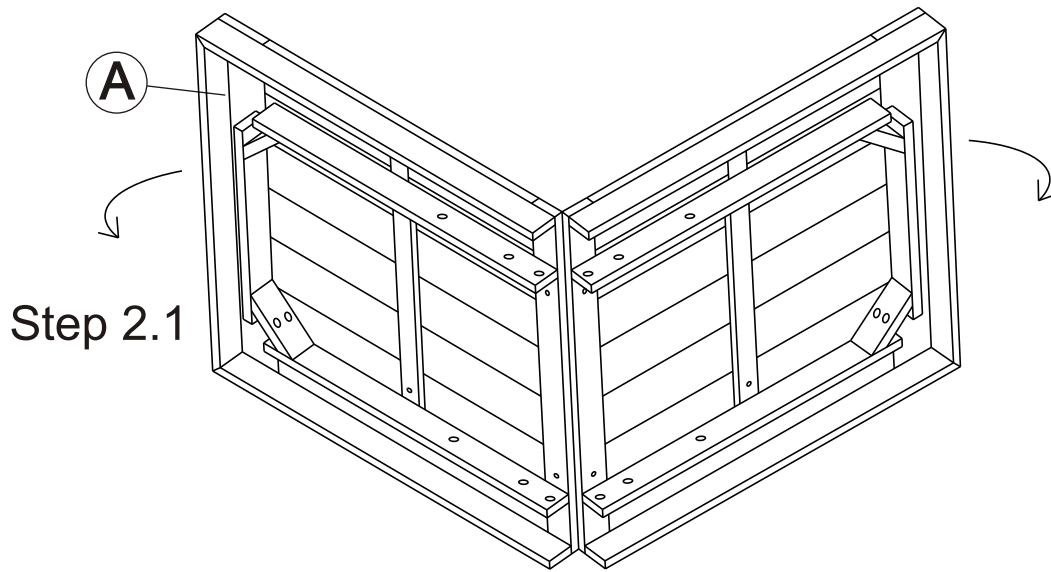
Step 1



Unpack and place all parts on a clean, non-marring surface.

Step 2

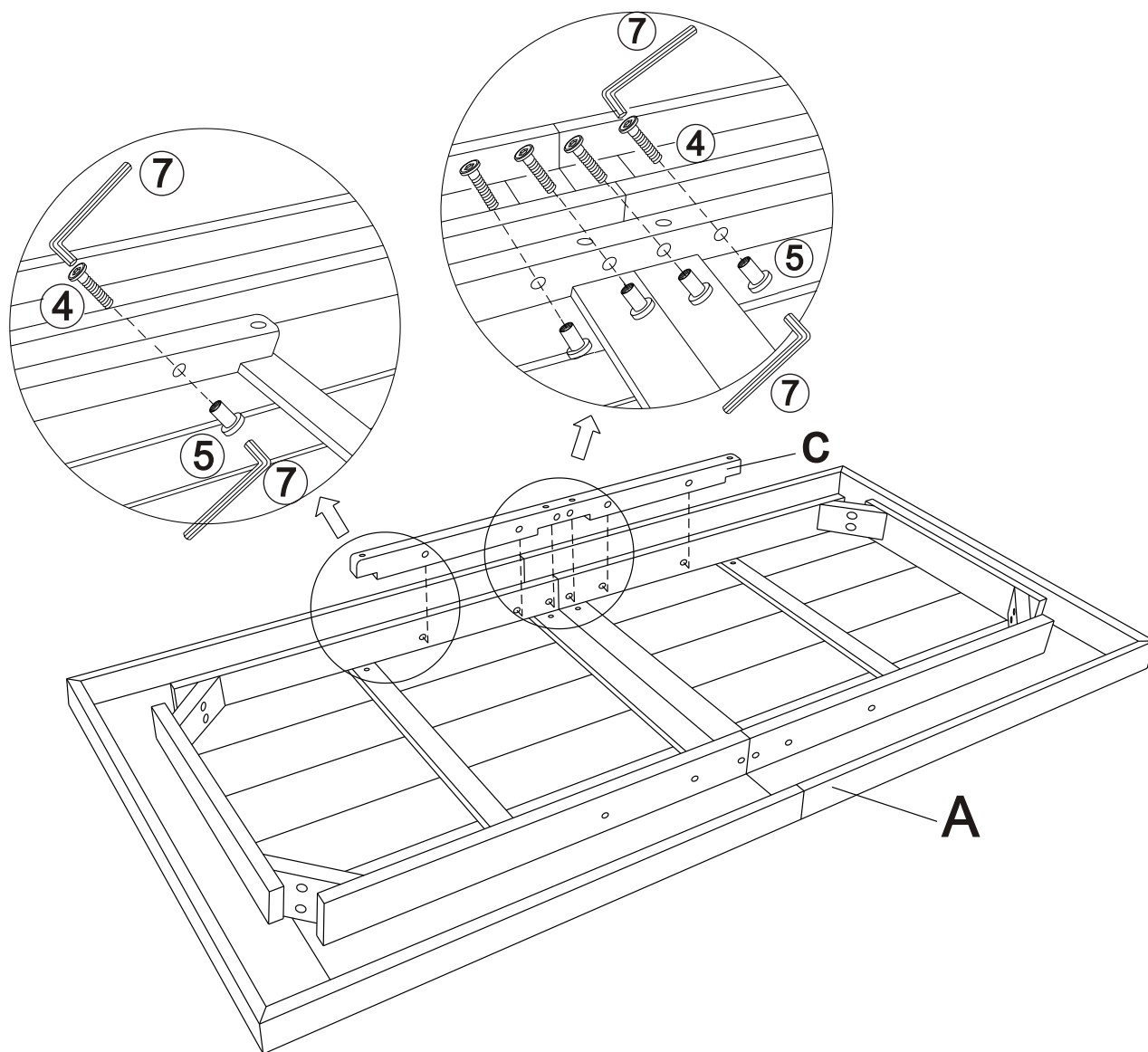


In step 2.1: Place the Table top (A) on one side as picture above. Slightly open the table top as the arrow.

In step 2.2: With the help from your partner, place the Table top (A) with its underside skywards, onto a clean,soft surface to avoid any scratches or damages to the product.

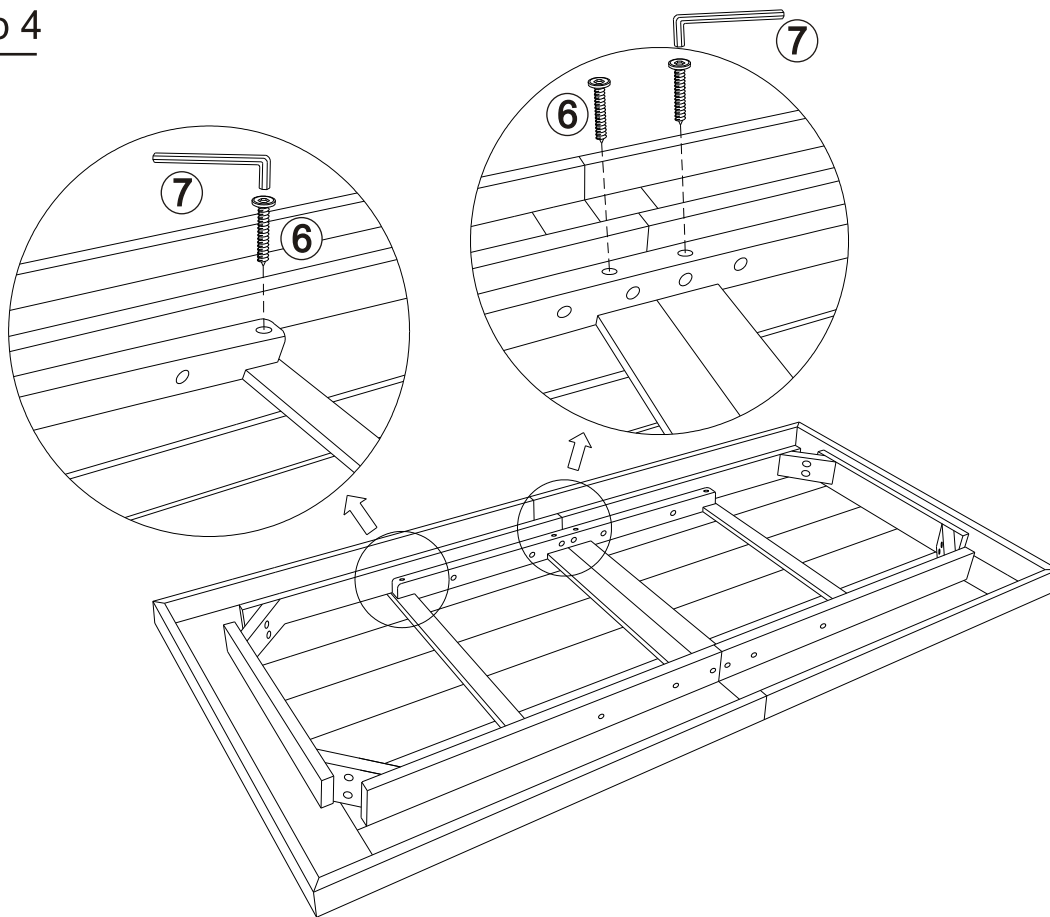
Step 3



Place Support Bar (C) to the housings of Table Top (A), secure by using the Short Bolts (④) with Sleeve Nuts (⑤), as shown in the picture.
Repeat the same process with the other Support Bar (C)
Only loosely tighten the Screws.

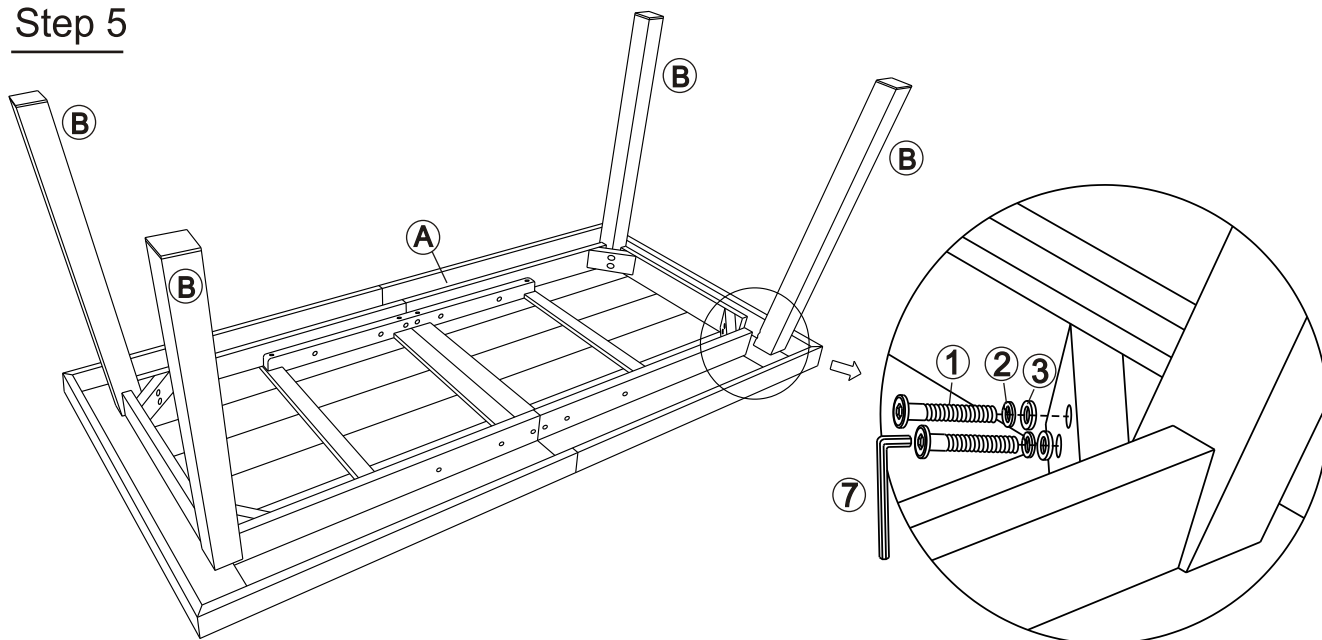
Assembly Steps

Step 4



Loosely affix by using the Screws (⑥) and Allen Key (⑦) as shown in the picture.
Repeat the same process with the other Support Bar (C).
Only loosely tighten the Screws.

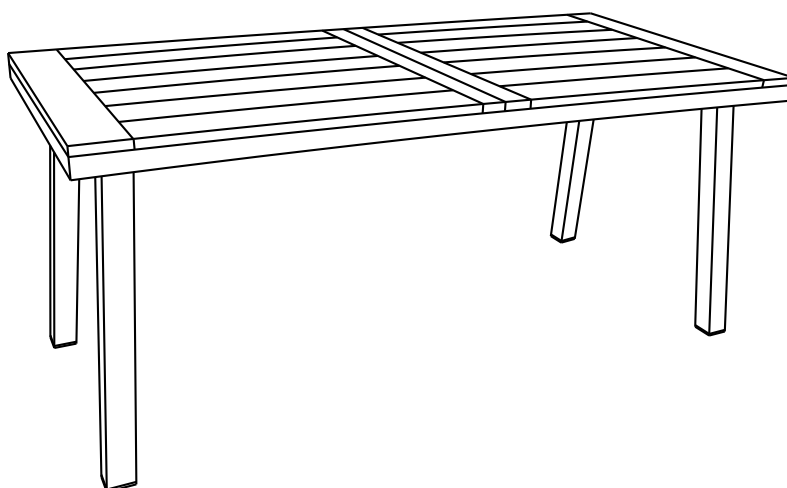
Step 5



Affix loosely the Legs (B) into the mounting position at the corners of the Table Top (A), using the Long Bolts (①) with Spring Washers (②), Flat Washers (③), as shown in the picture.
Repeat the same process with the other Legs (B).
Only loosely tighten the Screws.

Assembly Steps

Step 6



with assistance from your adult partners, Turn the Table right side up.

Inspect it and make sure all parts are adequately connected.

Check to ensure there is NO WOBBLINESS.

In a sequential manner, ensure all bolts and screws are fully locked into position and secured.

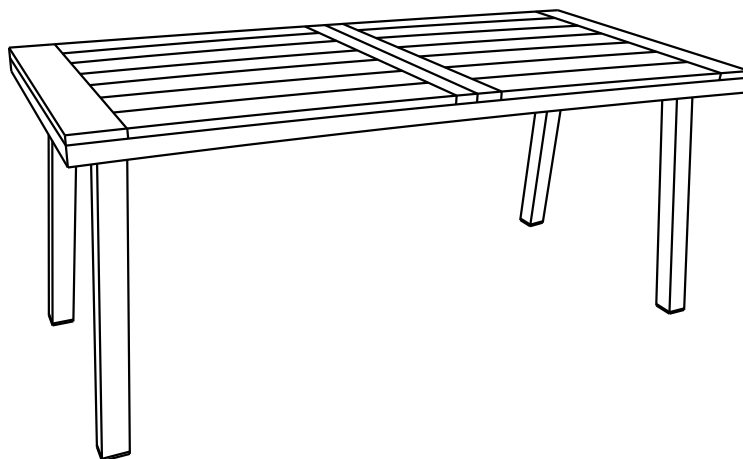
CAUTION: When tightening these screws, tighten sequentially.

DO NOT tighten any screw fully and then towards the next one. This would cause the frame to warp.

If there is still wobbles, loosen the screws and execute this same drop tests.

WARNING !! IF TABLE IS NOT STABLE, IT COULD LEAD TO DAMAGING THE PRODUCT.

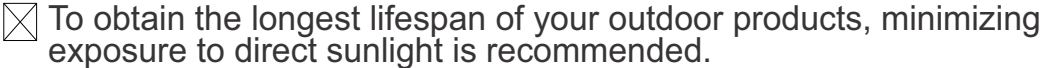
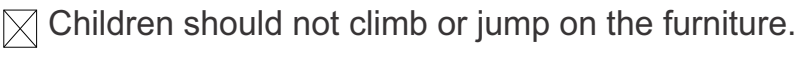
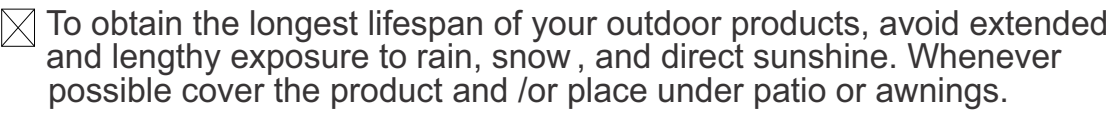
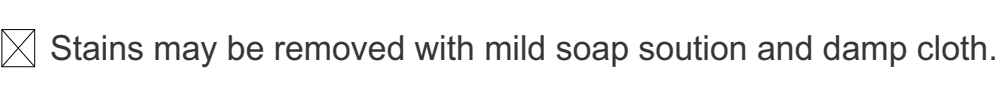
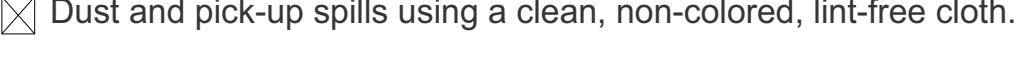


Ensure all screws are fully locked into position.

Questions & Answers about Proposition 65

- What is Proposition 65?

Proposition 65 requires businesses to provide warnings to Californians about significant exposures to chemicals that cause cancer, birth defects or other reproductive harm. These chemicals can be in the products that Californians purchase, in their homes or workplaces, or that are released into the environment. By requiring that this information be provided, Proposition 65 enables Californians to make informed decisions about their exposures to these chemicals.

Proposition 65 also prohibits California businesses from knowingly discharging significant amounts of listed chemicals into sources of drinking water.

Proposition 65 requires California to publish a list of chemicals known to cause cancer, birth defects or other reproductive harm. This list, which must be updated at least once a year, has grown to include approximately 900 chemicals since it was first published in 1987.

- What types of chemicals are on the Proposition 65 list?

The list contains a wide range of naturally occurring and synthetic chemicals that include additives or ingredients in pesticides, common household products, food, drugs, dyes, or solvents. Listed chemicals may also be used in manufacturing and construction, or they may be byproducts of chemical processes, such as motor vehicle exhaust.

- What does a warning mean?

If a warning is placed on a product label or posted or distributed at a workplace, a business, or in rental housing, the business issuing the warning is aware or believes that it is exposing individuals to one or more listed chemicals.

By law, a warning must be given for listed chemicals unless the exposure is low enough to pose no significant risk of cancer or is significantly below levels observed to cause birth defects or other reproductive harm.
