


1. Attach Seat Panel (1) to Back Panel (2) by using M6X40mm bolt (B) with Washer (C), and fasten with Allen Wrench (D).




- 2.** Attach Support Leg (3) to Assembled Parts (1) and (2) by using M6X20mm bolt (A) and M6X40mm bolt (B) with Washer (C), and fasten with Allen Wrench (D).




- 3.** 1. Attach Side Panel (4) to Assembled Parts (1) and (2) by using M6X40mm bolt (B) with Washer (C).
2. Attach Side Panel (4) to Back Panel (2) by using M6X40mm bolt (B) with Washer (C).
3. Fasten all bolts with Allen Wrench (D).




4. Ensure all bolt connections are fully tightened.




- 5.** Attach Seat Parts (5) to Side Panel (6) by using M6X40mm bolt (B) with bolt Washer (C), and fasten with Allen Wrench (D).




- 6.** Attach Support Leg (7) to Seat Panel (5) by using M6X20mm bolt (A) and M6X40mm bolt (B) with Washer (C), and fasten all bolts with Allen Wrench (D).




- 7.** 1. Attach Back Panel (8) to Seat Panel (5) and Side Panel (6) by using M6X40mm bolt (B) with Washer (C).
2. Attach Back Panel (8) to Side Panel (6) by using M6X40mm bolt (B) with Washer (C).
3. Fasten all bolts with Allen Wrench (D).




Ensure all bolt connections are fully tightened.




- 9.** Attach Back Panel (2) to Back Panel (8) by using M6X40mm bolt (B) with Washer (C), and fasten with Allen Wrench (D).




- 10.** Attach Seat Panel (5) to Seat Panel (1) by using M6X40mm bolt (B) with Washer (C), and fasten with Allen Wrench (D).



11. Open the vacuum packed Seat Cushion (9) by carefully cutting the bags with a pair of scissors. Insert the Seat Cushion (9) into the Seat Cover (10). Ensure the Cushion Cover completely covers the filler as image (2.) When closing the zipper ensure as image (3.) the cushion is compressed, this will allow the zipper to close with ease. Fluff all cushions and pillows to allow them to expand.

Ensure all bolt connections are fully tightened.

Limited Warranty

The manufacturers products are warranted against defects in material and workmanship while owned by the “Original Purchaser”. The term “Original Purchaser” is defined as that party or entity which purchases this manufacturers furniture from an authorized retailer as shown by the original sales receipt. This warranty does not apply to “as is” or previously owned products.

The manufacturer warrants its products to be free from defects in materials and workmanship (normal wear and tear, fading and stretching excepted), for one year from the date of purchase, except as provided below under the limited warranty. The exceptions or exclusions to this warranty are as follows:

1. Any warranty claim that is submitted after the limited warranty period, or without proper proof of purchase will not include the cost of parts, labor, or delivery.
2. This warranty shall not apply to the manufacturers products which have been subjected to misuse, neglect, alteration, modification, or attachments, either caused by the original purchaser, shipping, storage, accident, fire, flood, or acts of God.

In the event of a defect in material or workmanship covered by this warranty, the manufacturer will repair or replace, at their discretion, without charge the warranted parts within a reasonable amount of time. We reserve the right to require damaged parts to be returned to us upon request. Natural markings such as scars, brands, grain variations, wrinkles, color variations, etc. will be considered normal characteristics and not construed as defects.
