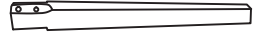

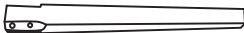

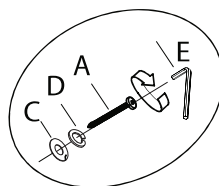
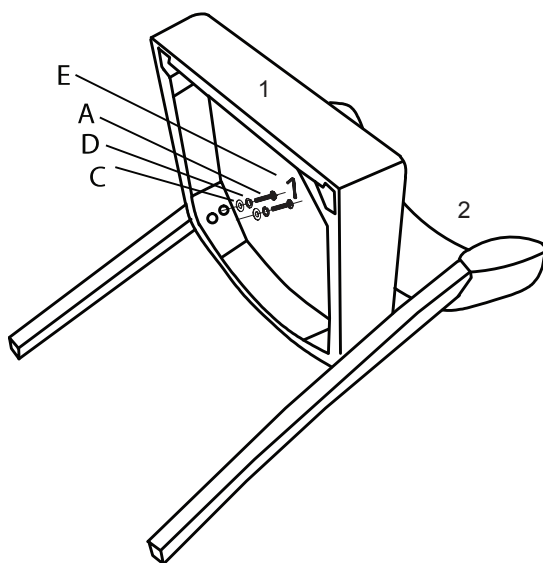


1. Ensure all parts have been removed from the carton and place on a protected surface or carpet.

Check all parts and hardware are the same as the “Parts List”.

2. Connect Seat Frame (1) to Back (2) using with Bolt (A), Spring Washer (D) and Flat Washer (C) on the corner position as below image then tighten with Allen Key (E).

3. Please do not fully tighten Bolts (A) until the chair is fully assembled.

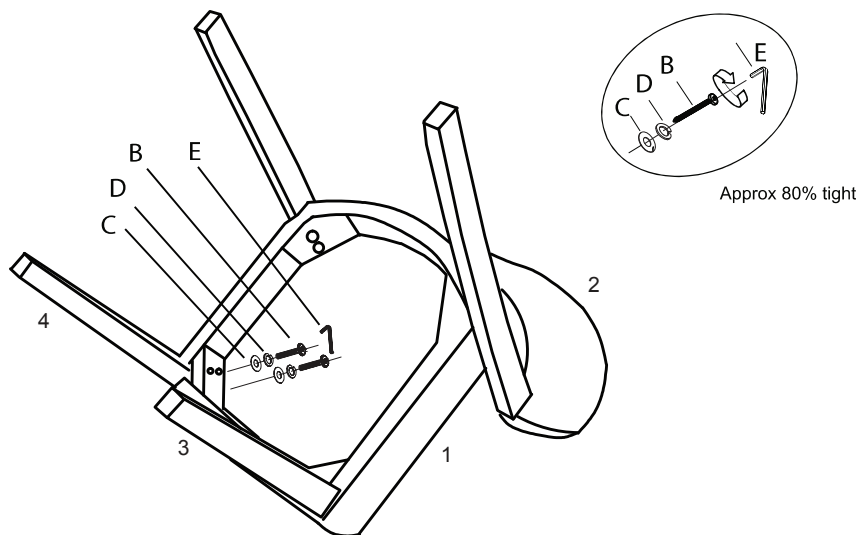


Approx 80% tight

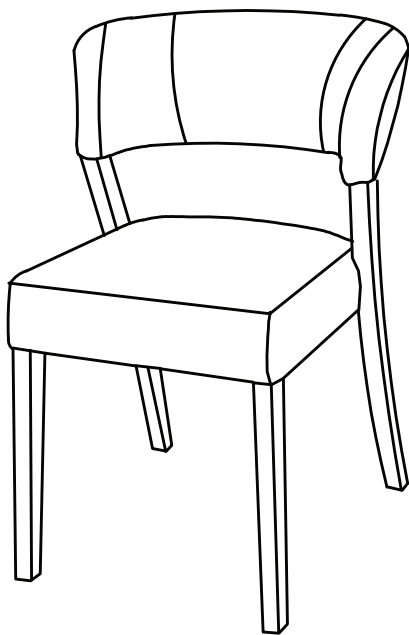


- 2.** 1. Attach Left Front Legs (3) & Right Front Legs (4) to Seat Frame (1) as below image with Bolts (B), Spring Washer (D) and Flat Washer (C) then tighten with Allen Key (E).

2. Please do not fully tighten Bolt (B) until the chair is fully assembled.



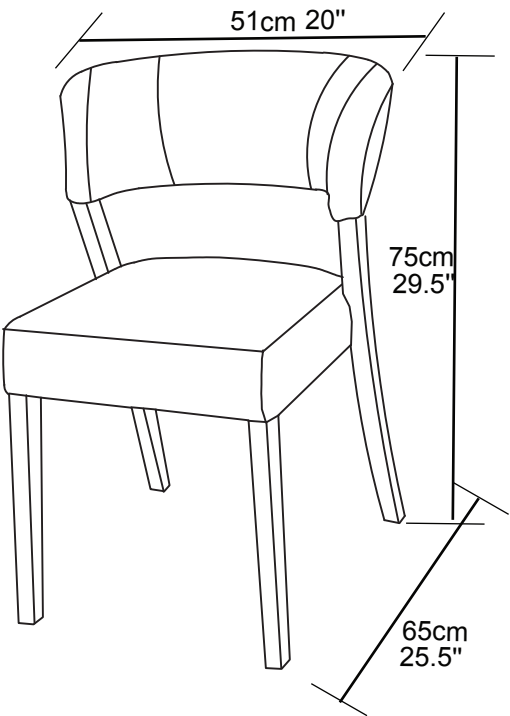
- 3.** 1. Place the chair onto a flat level surface and level the seat frame, once the chair is level, tighten the Bolts (A) & (B) with Allen Key (E) fully tighten.



Periodically (every 90 days) make sure that the screws are still fully tightened.
ATTENTION: Be certain that all screws are fully tightened before using chair

Limited Warranty

The manufacturer's products are warranted against defects in material and workmanship while owned by the "Original Purchaser". The term "Original Purchaser" is defined as the party or entity which purchases this manufacturer's furniture from an authorized retailer as shown by the original sales receipt. This warranty does not apply to "as is" or previously owned products.

The manufacturer warrants its products to be free from defects in materials and workmanship (normal wear and tear, fading and stretching excepted), for one year from the date of purchase, except as provided below under the limited warranty. The exceptions or exclusions to this warranty are as follows:

1. Any warranty claim that is submitted after the limited warranty period, or without proper proof of purchase will not include the cost of parts, labor, or delivery.
2. This warranty shall not apply to the manufacturer's products which have been subjected to misuse, neglect, alteration, modification, or attachments, either caused by the Original Purchaser, shipping, storage, accident, fire, flood, or acts of God.

In the event of a defect in material or workmanship covered by this warranty, the manufacturer will repair or replace, at their discretion, without charge the warranted parts within a reasonable amount of time. We reserve the right to require damaged parts to be returned to us upon request. Natural markings such as scars, brands, grain variations, wrinkles, color variations, etc. will be considered normal characteristics and not construed as defects.
