WARRANTY AND DISCLAIMER

nCamp warrants that the nCamp products accompanying this document will be free from defects in material and workmanship for one year from the date of purchase.

- 1. Returns: The customer must contact nCamp in the event he or she believes the product is defective and covered by this Warranty in order to open a warranty claim. Email nCamp at info@ncampgear.com. In some instances, it may be determined that parts can be easily installed by the customer and nCamp reserves the right to ship replacement parts directly to the customer for installation. Otherwise, the customer must pay for shipping the Product to nCamp at 4132 E Joppa Rd. STE 110 PB913 Baltimore, MD. 21236 (USA), for inspection. If the product is defective, as determined solely by nCamp after an inspection, the shipping costs will be refunded if proof of shipping is provided. No refunds of shipping costs will be made if the product is not defective.
- **2. Repair or Replacement:** nCamp's obligation under this Warranty is limited, at its sole and exclusive option, to either the repair or replacement of the product where a defect has been claimed and is determined by nCamp to be present. If the product, in the judgment of nCamp, shows evidence of having been altered, modified or repaired without the authorization of nCamp, the Warranty herein shall not apply.
